Respectfully submitting the Completed Staff Work (CSW) report on the alleged various irregularities of an employee at DENR Sub-Station, Magdiwang, Romblon forwarded by the Office of the President's 8888 Citizen's Complaint Hotline, from Ms. Mary Joy Mendoza of Brgy. Tampayan, Magdiwang, Romblon.

Results of the investigation revealed that harassment complaints against Job Order employee, Mr. Emeterio Quarre were settled at the Lupon ng Tagapamayapa of Barangay Tampayan, Magdiwang, Romblon. The Magdiwang Municipal Police Station has no blotter record of harassment. An endorsement to the Barangay level to address the complaint was issued by then Police Chief PCapt Elvis Fetalvero Galicia.

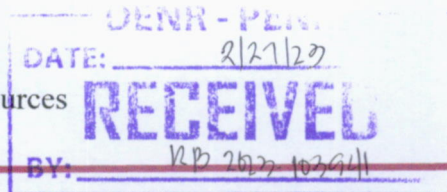
Meanwhile, the complainant's brother in law, Mr. Ronelio Franco, committed violations on P.D. 705 and DAO 97-32, which resulted to the confiscation of conveyances and twelve sacks of charcoal by Mr. Emeterio Quarre's team.

It is recommended that an administrative hearing must be conducted for the violation on Section 77 of P.D. 705 as amended by E.O. 277 and further amended by R.A. 7161, committed by Mr. Franco.

## MEMORANDUM

**SUBJECT :** SUBMISSION OF COMPLETED STAFF WORK ON THE ALLEGED VARIOUS IRREGULARITIES OF AN EMPLOYEE AT DENR SIBUYAN SUB-STATION, MAGDIWANG, ROMBLON [TICKET REFERENCE NUMBER P20230202-54-6-1]

### I. JUSTIFICATION

The 8888 Citizens' Complaint Hotline is a priority project of then President Rodrigo Roa Duterte, allowing the public to report complaints and grievances against government agencies, officials and employees. It is a mechanism where citizens may report their complaints and grievances on acts of red tape and/or corruption of any national government agency, Government owned or Controlled Corporation (GOCC), Government Financial Institution (GFI) and other instrumentalities of the Government.

The Core values of this Office center on discipline, excellence, nobility and responsibility. As employees, we must act accordingly and address complaints including those that will abridge in achieving these thrusts.

### II. LEGAL BASIS

*P.D. 705 Revised Forestry Code of the Philippines as amended by E.O. 277 and further amended by R.A. 7161*

*Section 77. Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License. – Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code: Provided, That in the case of partnerships, associations, or corporations, the officers who ordered the cutting,*





gathering, collection or possession shall be liable, and if such officers are aliens, they shall, in addition to the penalty, be deported without further proceedings on the part of the Commission on Immigration and Deportation.

***DENR Administrative Order No. 97-32***

***Section 2. Items subject to Apprehension, seizure, Confiscation and forfeiture***

A. Illegal Forest Products – Any forest product(s) defined in section 1 (a) above that are removed, cut, collected, processed and/or transported: without the requisite authorization or permit, with incomplete required supporting documents, with genuine authorization or permit and/or supporting documentation that have an expired validity, have been cancelled or that contain forged entries; or with spurious (fake) authorizations, permits and or supporting documentation. Note: Original documents shall be required at all times to actually accompany any forest products being moved or transported to any place and for any purpose.

B. Machinery, Equipment, Tools and Implements – used in the possession, gathering, collecting, processing and/or transporting of illegal forest products; and

C. Conveyance – any mode of type or class of vehicles or craft or any other means used in transportation either on land, water air, or any combination thereof.

**III. FACTUAL BACKGROUND**

**February 2, 2023** – This Office received a complaint lodged at the Citizen's Complaint Hotline with ticket reference number P20230202-54-6-1 regarding a complaint against Emeterio Mordido Quarre, a Job-Order employee of DENR Sibuyan-Romblon regarding alleged various irregularities

**February 3, 2023** – Special Order No.23-18 was released by the Office of the PENRO, directing a team to further investigate on the alleged irregularities of Mr. Emeterio Quarre. (*Annex A*)

**February 3, 2023** – A letter addressed to Ms. Mary Joy B. Mendoza was sent, informing her that an investigation team will conduct an investigation. Special Investigator Ann J. Adriguez called the complainant to gather initial details regarding her complaint (*Annex B*)

**February 6, 2023** – Travel Order of the Investigation team was approved.





#### IV. ACTIONS TAKEN

On February 7, 2023, Forester II James Mendoza, Forester II Sheilla Jane M. Forlales, Forester I Marielle V. Magallanes and Special Investigator Ann Adriguez of the Monitoring and Enforcement Section conducted site visit, interviewed concerned persons and further investigated on the said matter as per PENRO Special Order No. 23-18.

#### V. FINDINGS

Findings of the investigation include:

1. The complainant, Ms. Mary Joy Mendoza, and her family have personal disagreements with Mr. Emeterio Quarre. This is evident through a series of barangay hearings and Lupon ng Tagapamayapa mediation hearings between Mr. Gregorio Mendoza, 52, father of Ms. Mary Joy Mendoza, and Mr. Emeterio Quarre.

2. The alleged harassment was not settled at the level of the barangay council but later prospered into positive agreement thru the efforts of the Lupon ng Tagapamayapa

*Annex I – Certification dated February 3, 2023 and February 8, 2023, issued by Hon. Darwin Ruado, Punong Barangay of Tampayan, Magdiwang, Romblon re: settlement between Mr. Gregorio Mendoza and Mr. Emeterio Quarre*

3. The alleged harassment is not listed in the blotter book of Magdiwang Municipal Police Station. It was, however, reported therein and was endorsed to the Barangay council for proper disposition. This was ascertained in an interview with PCapt Mary Gaca, present Chief of Police, Magdiwang Munisipal Police Station.

4. The complainant points out that her brother-in-law transported “pinutol na punong mangga” The conveyance (Rusi 150 Tricycle with Plate No. 38579), along with the 12 sacks of charcoal (and not branches of mango trees) were apprehended on January 21, 2023 at Brgy. Ambulong, Magdiwang, Romblon. Apprehension made is in consonance with DAO 97-32 Section 2. The driver, Mr. Ronelio Franco, 31 years old and resident of Tampayan, Magdiwang, Romblon, has no Permit to Transport for the said forest product. (*Annex K – Blotter at Brgy. Ambulong by the Apprehending Team*)
5. Upon site visit, branches of the mango tree were certainly cut. There is no record of inspection of assigned Sibuyan-Substation personnel.
6. There is a report drafted by the team who apprehended the conveyance and the charcoal. There are no spot report and other related apprehension documents prepared by the apprehending team composed of Ryan Role, Ronald Dangoy, Emeterio Quarre, Jane Marin and April Montero – all Contractual Park Rangers.
7. Mr. Emeterio Quarre denied of having owned an unlicensed gun.

## VI. COMMENTS/ RECOMMENDATIONS

1. An administrative hearing must be conducted for the violation on Section 77 of P.D. 705 as amended by E.O. 277 and further amended by R.A. 7161.
2. Apprehending Team should be led by a permanent employee of this Office in order to have a liable personnel in case of further legal inquisitions.
3. Counselling should be done by the Human Resources to Mr. Emeterio Quarre regarding the harassment allegations.
4. Capacity building on DAO 97-32 should be conducted in order to capacitate all personnel especially the newly hired contractual Park Rangers on proper apprehension procedures and documentary requirements.








