CUTTING OF TREES WITHOUT PERMIT BY THE ALTAI PHILIPPINES MINING CORPORATION

BACKGROUND

1. A Joint Order was issued by the DENR MIMAROPA Regional Executive Director Lormelyn E. Claudio, Regional Director of Mines and Geosciences Bureau Engr. Glenn C. Noble, and Regional Director of Environmental Management Bureau Joe Amil M. Salino dated February 6, 2023.

- 2. Under directive number 5 of the Joint Order, this office was ordered to file appropriate legal action, if warranted, on the reported cutting of trees without a permit.
- 3. This office received a Memorandum from the DENR MIMAROPA Regional Executive Director dated February 13, 2023, with subject: Explanation Re: Illegal Tree Cutting of Altai Philippines Mining Corporation (APMC).

ACTIONS TAKEN

- 1. This office immediately issued a PENRO Special Order No. 23-19 dated February 7, 2023 creating a team to conduct re-inventory of trees within the twenty (20) hectares area, Parcels 1 and 2 Proposed Road, and Parcel 3 Road going to Proposed Port of APMC at Sitio Bato, Brgy. España, San Fernando, Romblon. (Copy of Special Order is attached mark as "Annex 1"). However, the team failed to enter the premises of APMC despite several attempts. Attempts were made on the following dates: February 8, 9 and 10, 2023. The team was not given consent to enter the said areas by the APMC main office.
- 2. On February 10, 2023, the team submitted an update report regarding the re-inventory of trees within the aforementioned areas. The same report was endorsed to the Regional Office through a memorandum dated February 16, 2023. (Copy of which is attached mark as "Annex 2").

- 3. This office explained through a memorandum dated February 21, 2023, as to why this office has not noticed the illegal cutting of trees undertaken at the APMC's 20-hectare site. The reasons were: the location where the removal and/or clearing of trees is undertaken is not visible from the road; and personnel of Sibuyan-Substation were on different travel purposes. (Copy of the memo is attached mark as "Annex 3").
- 4. This office sent a letter dated February 7, 2023, addressed to the President of the APMC, informing them that a re-inventory of trees within the 20-hectare area will be conducted to ascertain the allegation of cutting without a permit. (Copy of the letter is attached mark as "Annex 4").
- 5. Moreover, this office sent the APMC a reiteration letter dated February 16, 2023, to allow the team to conduct the said re-inventory. (Copy is attached mark as "Annex 5").
- 6. On March 2, 2023, this office received a response letter from the President of APMC dated February 28, 2023. They informed this office that APMC has voluntarily stopped exploration and related activities on February 6, 2023 prior to the issuance of Joint Order. The APMC further informed this office that they are "now in quandary how come ground validations and tree re-inventory are being sought per subject letters only after the issuance of those NOVs and while the same are pending resolution" by our office. Lastly, APMC also stipulated in their letter that they are ready and willing to have a dialogue with this office together with representatives from MGB and EMB Regional Offices on March 9, 2023, at the DENR-MIMAROPA Office, Ermita, Manila. (Copy of the response letter is hereto attached mark as "Annex 6").
- 7. On March 3, 2023, this office instantly replied to the response letter of APMC and inform them that an Inspection team will immediately conduct the re-inventory of trees within the 20-hectare area, including Parcels 1, 2, and 3, located at Sitio Bato, Brgy. España, San Fernando, Romblon. This office further asked a representative from the APMC to accompany the Inspection Team during the re-inventory. Also, this office invited them to a Technical Conference on March 8, 2023, to be held at the PENRO Romblon Conference Room, Brgy. Tabing-dagat, Odiongan, Romblon. (Copy is attached as "Annex 7").

In compliance to the PENRO Special Order No. 23-19, Series of 2023, the team headed by Forester I Rolly F. Morales, went to So. Bato, Brgy. Espana, San Fernando to conduct re-inventory of trees.

HIGHLIGHT OF ACTIVITIES:

The following activities had been observed:

- 1. We coordinated first with the Brgy. Official of Brgy. Espana, San Fernando, Romblon regarding the conduct of re-inventory in the area February 08, 2023.
- The team then proceeded to the office of Altai Philippines Mining Corporation to coordinate on the re-inventory. Upon arrival, Mr. Marvin Roy and Mr. Jaime C. Yap, representatives of APMC advised the team to make a request letter with corresponding Special Order to be forwarded to their main office for the re-inventory. Thus, the team relayed this message to PENR Office, and was able to provide a request letter with copy of PENRO Special Order for APMC's information. They, however, informed that they are not authorized to receive the documents and it should be directed to the main office and will wait for further instructions.



- That on the following day, February 09, 2023 the team went back to the area and coordinated with the representatives of APMC if the team is allowed to conduct tree reinventory. However, the representatives informed them that there is still no instruction from their main office and they are also waiting for a memorandum allowing the team to conduct tree re-inventory.
- 4. That on February 10, 2023, the team went back again in the area expressing the same intent of conducting tree re-inventory but was again denied as the representatives stated that they cannot allow the activity without the consent of the main office.

EXPLANATION RE ILLEGAL TREE CUTTING OF ALTAI

PHILIPPINES MINING CORPORATION (APMC) IN SIBUYAN

ISLAND, ROMBLON

This refers to your memorandum regarding the above subject dated February 13, 2023. In connection with the re-inventory of trees within the 20-hectare area of operation of the APMC, the Inspection Team failed to enter the APMC's area of operation located in Sitio Bato, Brgy. España, San Fernando, Romblon despite several attempts. Attached is the report on the re-inventory of trees within the 20-hectare including parcels 1, 2, and 3 as to why the Inspection Team was not able to enter the subject area.

Respectively, this office immediately issued a Special Order dated February 7, 2023, for a team to conduct rapid assessment/investigation on potentially damaged seagrass and other marine resources. On February 8, 2023, the team conducted the assessment/investigation. Results of the assessment/investigation revealed that rocks and pebbles, rocks with algae, and sand were existent in the surrounding area of the causeway. There were no sea grasses and corals found at the alleged damaged area particularly at the vicinity of the causeway. Attached is the assessment/investigation report of the team.

Furthermore, this office has recently forwarded a reiteration letter dated February 16, 2023, addressed to the president of APMC to allow the Inspection Team to conduct the said re-inventory. Please be informed that the team cannot easily pass through the area since they are not permitted to enter the premises. There are also APMC security guards positioned both at the entrance going the 20-ha site and entrance going to the causeway project.

Hereunder are the reasons why this office has not noticed the illegal cutting of trees undertaken at the APMC's 20-hectare site, to wit:

- The location where the removal and/or clearing of trees is undertaken is not visible from the road.
- 2) Personnel of Sibuyan Sub-station were on different travel purposes. Selected personnel were on travel to conduct patrolling operation of alleged illegal smallscale mining activities within the protected area of MGGNP at Sitio Hanggan and Sitio Banilad, Brgy. Mabini, San Fernando, Romblon covering January 2023. While other personnel are on travel to conduct BAMS in Brgy. Danao, Cajidiocan, Romblon.


