Respectfully forwarded is the memorandum of CENRO Puerto Princesa, Palawan dated March 3, 2023 relative to the above subject.

Per memorandum, it was manifested that at around 07:18 AM of January 9, 2023, Mr. Renante Gaurino and Mr. Ryan Balbuena arrived at the Sicsican Forest Product Monitoring Station (FPMS) informing that they were able to apprehend a multi-cab loaded with charcoal. Based on the inspection conducted by the personnel of Sicsican FPMS, they found out that the owner of the multi-cab loaded with forty-five (45) pieces of wood charcoal was Ms. Rose Batbat Balase, 54 years old and driven by Jaime Rodela Atacio, 64 years old.

The apprehended undocumented 45 sacks of wood charcoal with an estimated fair market value of Php4,500.00 while the one (1) unit White Suzuki FB Van/Multi-cab with Plate No. MAB 5773 has an estimated value of Php80,000.00. The apprehended items were brought to the compound of DENR CENRO Puerto Princesa, Palawan for safekeeping purposes.

Three (3) notices of hearing were sent and posted in three (3) different conspicuous places in relation to section 7 of DAO 1997-32. However, the claimant only appeared in the hearing that was scheduled on January 17, 2023 and the recommendation of the hearing officer is to forfeit only and confiscation of the charcoal and conveyance.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended vehicle and wood charcoal.

Respectfully submitted is the summary of the Administrative Adjudication of the Chief Monitoring and Enforcement Section, Forester Dennis Aldrin A. Velasco relative to the above subject.

Please be informed that this Office conducted an administrative hearing last January 17, 2023, pursuant to Department Administrative Order (DAO) 97-32. The hearing disclosed that one (1) unit white Multi-cab with Plate Number MAB 5773 was loaded with forty-five (45) sacks of charcoal without legal documents. Hence the Hearing Officer recommends the forfeiture and confiscation of the said charcoal and conveyance.

Upon review and evaluation of the report submitted including its attachments, the undersigned concurs with the recommendation of the Hearing Officer subject for review at the Regional Office.

DATE: **March 3, 2023**

Respectfully submitted is the summary of the Administrative Adjudication of one (1) Unit Multi-cab with Plate Number MAB 5773 owned by Rose Batbat Balase driven by his common law husband Jaime Rodela Atacio, loaded with 45 sacks of undocumented charcoal.

I. FACTS OF THE CASE

On January 9, 2023, at around 7:18 in the morning, Mr. Renante Gaurino and Mr. Ryan Balbuena arrived at Sicsican Forest Product Monitoring Station informing FT1 Rommel Adato that they were able to apprehend a multi-cab loaded with charcoal. FT1 Adato entertained their report and inspected the multi-cab which was brought to the check-point. It was found out that it was loaded with forty-five (45) sacks of undocumented charcoal.

According to Mr. Gaurino, on their way to Napsan, he spotted the white multi-cab loading charcoal at Sitio Pulang Lupa, Brgy. Montible, Puerto Princesa City. They apprehended the multi-cab knowing that the charcoal was undocumented and instructed the driver to follow them to Sicsican Forest Product Monitoring Station wherein the driver immediately obeyed. Mr. Gaurino made a turnover receipt and this Office issued an acknowledgment receipt as proof that the conveyance was already within the custody of this Office.

Upon inspection, it was found out that the driver was Mr. Jaime Rodela Atacio, 64 years old, the common law husband of Ms. Rose Batbat Balase, 54 years old, and the owner of the multi-cab and the charcoal. According to them, they were marketing dried fish and "bagoong" in the West Coast Area, particularly in Napsan. The charcoal was payment in exchange for the goods they brought to the area. She also explained that they work hard to find a living because aside from their daily sustenance, they are also working for the insulin maintenance of her husband who has diabetes.

During the administrative hearing Mr. Atacio and Mrs. Balase admitted that the said charcoal was owned by them and it was undocumented because it was paid to them in exchange for their goods. That they enter into the said type of livelihood to support the studies of her children and the medication of her husband Mr. Atacio.

The hearing officer also tried to get the testimony of the concerned citizen in the name of Mr. Renante Gaurino who caused the apprehension of the multi-cab, but despite notice, calls and text messages he did not appeared during the scheduled hearing. On the last notice of hearing, Mr. Gaurino personally received the communication from this office when he followed-up the status

of his apprehended Mitsubishi L-300 van and it was also explained to him why he needs to appear for a hearing in this case. Mr. Gaurino is the owner of the van apprehended last October 24, 2022 loaded with 53 sacks of charcoal. On December 12, 2022, he wrote a letter to this office expressing his desire to volunteer as DENRO and on January 9, 2023, he apprehended this multi-cab loaded with 45 sacks of charcoal from Sitio Pulang Lupa, Brgy. Montible, Puerto Princesa City as concerned citizen.

II. NOTICE OF HEARING

The hearing was conducted on January 17, 2023 with the driver and the owner of the conveyance. It was also considered to secure the testimony of the apprehending officer, hence hearings was scheduled on Feb. 1, 8 and March 1, 2023. However despite notice, text and call, he did not appear in this office for the said hearings, hence, it was inferred that the concerned citizen did not manifest intent to cooperate in this case. The hearing officer sees it right to submit the report of this administrative adjudication.

III. EVALUATION


The facts of this case revealed that the transported charcoal was indeed considered as illegal forest products as defined in DAO 97-32 Sec 2(a). Hence, the violation was clear under Sec 77 of PD 705 which stated that: *"Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code..."*

Furthermore, DAO 97-32 Sec. 9, on the temporary release of conveyance under 1(b) the DENR Confirmation, provides *"that the applicant was not among those who were apprehended by virtue hereof and is not a respondent in the case by virtue of which the conveyance is detained pendent lite..."* In this case, the owner was among the respondents to the case and present during the apprehension. Hence, the conveyance is not qualified for temporary release.

It is worth noting that the multi-cab was just turned over to Sicsican Forest Product Monitoring Station (SFPMS) and upon verification it was evidently loaded with undocumented charcoal, it was apprehended and subjected to administrative adjudication. During the hearing, ownership of the charcoal was admitted by the multi-cab owner and his common law husband who is the driver of the conveyance, hence it was concluded that there is a valid apprehension.

IV. RECOMMENDATION

It is hereby recommended that the forty-five (45) sacks of charcoal and the white multi-cab be confiscated in favor of the government.

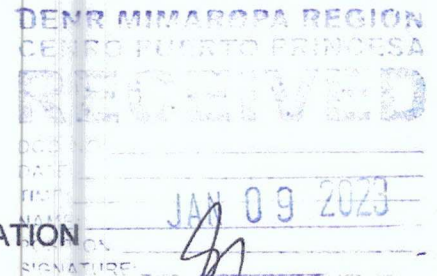

The undersigned accommodated them at the check-point and inspected the multi-cab. The owner of the multi-cab was Ms. Rose Batbat Balase, 54 years old and the Driver Jaime Rodela Atacio, 64 years old. According to them, they were marketing dried fish and "bagoong" at the West Coast Area particularly in Napsan. They said that the charcoal were payments for their goods which they accommodated to earn a living especially that her husband has insulin maintenance. The undersigned asked Mr. Renante G. Guarino, how they were able to apprehend the multi-cab. According to him, on his way to Bgy. Napsan, he spotted the white multi-cab loading a charcoal at Sitio Pulang Lupa, Brgy. Montible, Puerto Princesa City. They immediately apprehend the said multi-cab and instructed to convoy them to Sicsican Monitoring Station. Immediately the undersigned informed the Chief MES regarding the incident and as instructed the multi-cab was brought to the CENRO PPC Office for proper documentation. Turn-over receipt was prepared by Mr. Renante Gaurino and an acknowledgement Receipt was issued by this office as proof of the turn-over.

7. Recommendations: It is recommended that the said individuals be invited for further investigation/clarification and filing of appropriate charges if warranted.
