Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated February 13, 2023 relative to the above subject.

Per memorandum, the apprehension was made on December 28, 2022 at around 02:00 P.M. due to the inspection conducted by the Park Ranger from the PAMO of ENTMRPA and the enforcement personnel of CENRO Taytay. The team discovered pile of lumbers during their patrolling at the seawall construction which leads for the apprehension of the 191.26 board feet lumber of Apitong species.

The apprehended undocumented lumber of Apitong species has an estimated fair market value of Php11,475.60. The apprehended item was brought to the compound of Diver's House Station, El Nido, Palawan for safekeeping purposes.

Three (3) notices to the public dated January 4, 2023, January 11, 2023 and January 18, 2023 were posted in different public places for the scheduled February 3, 2023 administrative hearing in relation to Section 8, Item No. 3 of DAO 1997-32. However, no claimant appeared in the CENR Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their rights to the item apprehended in favor of the government.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended lumbers.

This report is respectfully submitted pursuant to Department (DENR) Administrative Order 97-32 dated October 10, 1997.

WHAT

This is the final report on the administrative adjudication of the forty-nine (49) pieces of lumber of Apitong species equivalent to one hundred ninety-one point twenty-six (191.26) board feet.

WHEN

The interception/recovery took place last December 28, 2022 and the corresponding report was submitted and received in the Office on January 3, 2023 (Annex A to A₁) plus the geo-tagged pictures (Annex B), Tally Sheet (Annex C), and Apprehension Receipt (Annex D to D₂).

WHERE

The forest products were recovered in Sitio Cabigsing, Barangay Buena Suerte, El Nido Palawan and brought to Dive Hous, Barangay Corong-Corong, El Nido, Palawan.

WHO

The so-called Apprehension Receipts bear no name of probable culprits. The operating enforcers were personnel from the Protected Area Management Office (PAMO) of El Nido-Taytay Managed Resource Protected Area (ENTMRPA) led by Forest Ranger Jonathan A. Arzaga

WHY

The subject items of forest products were taken and seized for failure by anybody to claim with valid documents despite invitation in public notice posted in three consecutive weeks.

HOW

The lumber was discovered by Park Ranger Hero Jeff Isidro and Brethart Sanogal during their inspection at the seawall construction.

Adjudication procedure

Seizure Receipt (Annex E) and Seizure Order (Annex F to F₂) were facilitated on January 4, 2023 in order to acquire jurisdiction over the intercepted items. The seized items have an estimated value of eleven thousand four hundred seventy-five point sixty (11,475.60) pesos. Public notices (Pabatid sa Publiko) were posted consecutively every week on January 4, 11 and 18, 2023 (Annexes G to G₂). The Certification of the Records Officer dated January 26, 2023 was then issued upon completion of the posting of Pabatid to the Public (Annex H).

In the absence of claimant, the undersigned opted to adjudicate the issue on the basis of the report submitted. This Office sent invitation to Forest Ranger Jonathan A. Arzaga et. al, and Punong Barangay Ricky Ballena of Barangay Buena Suerte, El Nido, Palawan to a hearing on 3rd day of February, 2023 at 3:30 in the afternoon (Annex I to I₁).

The examination pushed through as evidenced by the Attendance Sheet (Annex J). Preliminaries such as attendance check and the IEC presentation was set aside since all of the attendees were personnel from this Office.

On the examination, *Hearing Officer* directly asked on the present location of the lumber. *FR Arzaga* answered to be in the Dive House for the safekeeping. *HO* then followed up the inquiry if follow-up operation was conducted by the enforcement team after the incident. *FR Arzaga* answered that it was during the apprehension; the team also conducted investigation in the vicinity of the area but residents were silent on the possible owner of the lumber. *HO* then declared the items to be abandoned.

Conclusion and recommendation


The items listed down in the Seizure Order and Seizure Receipt are deemed abandoned thus hereby recommended for the issuance of Order of Forfeiture.
