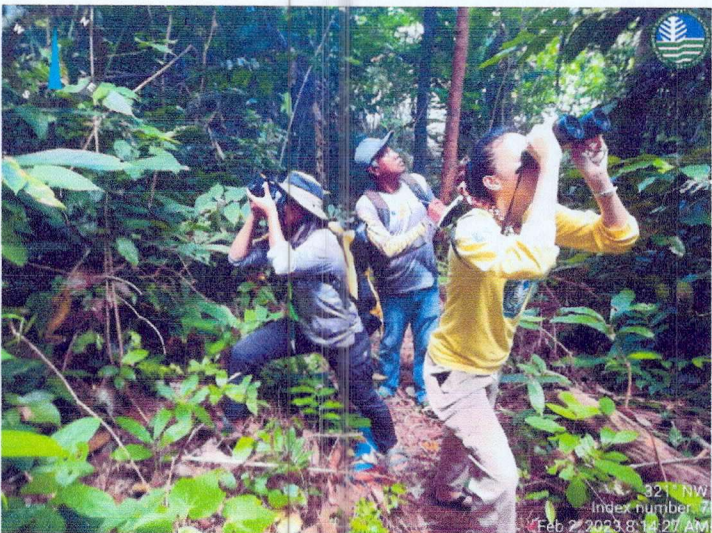
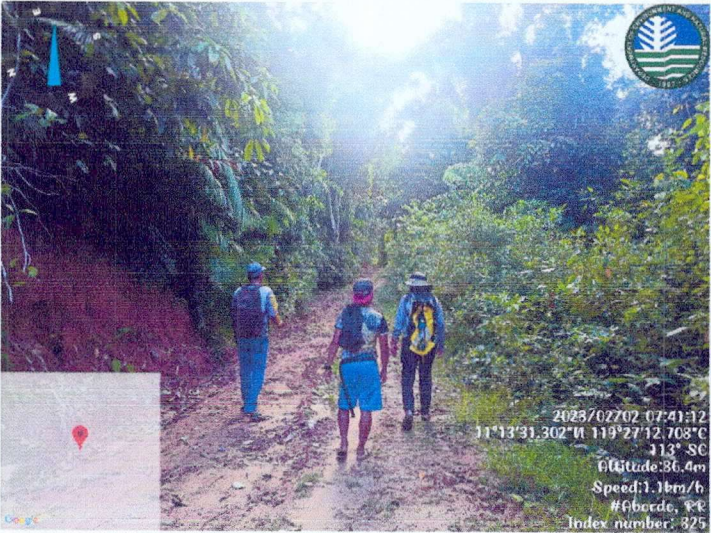

Transect walk at Cadlao Trail, Cadlao Island, Bgy. Corong-corong, El Nido, Palawan on January 31, 2023




Transect walk at Sitio Manlalic, Bgy. Manlag, El Nido, Palawan on February 1, 2023
