Submitting is the Progress Report on the Technical Assistance to LGU on mainstreaming the Integrated Coastal Management (ICM) approach into the Comprehensive Land Use Plan (CLUP).

Please be informed that upon completion of the inception phase of mainstreaming the ICM into CLUP as per BMB Technical Bulletin No. 2022-02 in the Province of Palawan, and based on the road mapping activity conducted last CY 2022 and following the prioritization criteria, the Municipality of Aborlan was chosen to be a target LGU for mainstreaming the ICM approach into the CLUP this year.

The Municipality of Aborlan declared their whole municipal waters as Marine Protected Area (MPA) by virtue of Municipal Ordinance and this year, they are planning to update their CLUP.

As one of the activities under the mainstreaming phase of ICM mainstreaming to CLUP, the undersigned together with Supervising ECOMS Rhodora B. Ubani and CMEMP Extension Officer Krizia Meryl Ecube coordinated with the Local Government Unit (LGU) of Aborlan regarding the new direction of this office on ICM technical assistance support. The team spoke with the Municipal Planning and Development Coordinator (MPDC) and OIC Municipal Agriculture Officer (MAO) in the absence of the Mayor.

Further, be informed that as per the MPDC of the municipality, the coordination is timely since they are preparing the list of the members of the Technical Working Group (TWG) for the updating of their CLUP and they will inform this office once the TWG list has been finalized as well as the schedule of the activities in relation to the latter.

Relative to the mandates of the Department of Environment and Natural Resources (DENR) to conserve, manage, develop and properly use the country's environment and natural resources, this office is extending Technical Assistance to the LGUs within the Province of Palawan in any concerns related to the environment. As such, one of the priority programs of the DENR is the Coastal and Marine Ecosystems Management Program (CMEMP) which aims to address the drivers and threats of degradation of the coastal and marine ecosystems.

This program uses the Integrated Coastal Management (ICM) approach to holistically manage the ecosystems by looking at the interconnectivity of the activities from the ridges down to the coastal areas.

In the previous years, the DENR provided Technical development of localized LGU ICM plans as part of the Technical Assistance (TA) in the CMEMP under the DAO 2016-26.
