Forwarded is the memorandum from CENRO Puerto Princesa City dated February 20, 2023 reiterating the request for correction of plan Gss-04-0000224 at Barangay Simpocan, Puerto Princesa City.

As a brief background, enumerated below are the flow of action status in relation to the above-subject survey plan:

- a. Survey Order No. 2017-07-005 dated July 6, 2007 was issued to Engr. Donna Belle Luengo to conduct verification survey showing the relative position & approved PLS 529 and Gss-04-0000224 as surveyed by Engr. Jonathan F. Gellez (Attachment I).
- b. Engr. Luengo submitted her findings dated January 22, 2018 informing the results of verification survey. Per her report in item #2 "existing barangay road is not reflected on the map of PLS 529 and only portion of the road is reflected in Gss-04-0000224". In conclusion since actual road is not reflected on the map, the road now traverses into the lots of the Gss plan as against to its actual position wherein the road is in between PLS 529 and the Gss lots. It was also mentioned in the report that the extent of error is undetermined since some claimants failed to point its lot boundary (Attachment II).
- c. A memorandum from CENRO Puerto Princesa City dated July 25, 2018 submitting the inventory and status of all lots covering the said Gss plan as one of the basis for the amendment of the survey plan.
- d. A Memorandum from the RED dated April 8, 2019 advising Engr. Luengo to continue and complete the conduct of verification survey to ascertain the extent of erroneous tielines (Attachment III).

- e. Engr. Luengo continued the survey on lots under PLS 529 and submitted her report dated July 30, 2019 (Attachment IV).
- f. A memorandum from the RED dated October 4, 2022 stated that the said subject plan is no longer amenable since some lots covering the said survey plan have been issued patents per submitted status of lots. Instead it was advised to do a consolidation-subdivision survey.

In this regard, this Office reiterates the recommendation as mentioned in the report of Engr. Luengo dated January 22, 2018 that there is a need of verification survey of all the Gss lots in order to determine the particular lots having defective tielines before a subdivision or consolidation-subdivision survey or any possible solution be applied. Thus, fund allocation is also requested to cover the travelling expenses, per diems and other incidental expenses in the execution of the survey. This office is also requesting for a representative of that office joining the survey team.



Pursuant to Survey Order No. 2017-07-005 dated July 06, 2017, the undersigned together with the PENRO survey team conducted the verification survey covering the lots inside PLS 529 and GSS-04-000224 located at Simpocan, Puerto Princesa City, Palawan.

The team is tasked to ascertain the position and descriptions of the existing monuments, fences, walls and other permanent structures which are used to provide evidence of original boundaries. After data gathering through research, the following are observed:

- PLS 529 in barangay Simpocan consist of 26 lots particularly Lot Nos. 237-262 equivalent to Lot 7040-7065 of Cad.800-D Puerto Princesa Cadastre respectively and 1 lot is timberland specifically Lot 7032 Cad.800-D (see attached annex A).
- Per approved technical description of GSS-04-000224 and PLS 529 it was observed that portion of GSS-04-000224 adjoins to PLS 529 particularly lot 237, portion of lot 238,241 & 242 and lots 246-248 while remaining of GSS-04-000224 has a gap between PLS 529 from lot 238-241 and 243-245, PLS 529 (see attached annex A).

The survey started by running series of control traverse stations with the aid of Electronic Total Station traversing the existing barangay road. Side shots and readings are made randomly on the existing fence of the properties, improvements and GSS monuments along the road. I was not able to shot corner monuments on the middle/center portion of the GSS since the lot claimants failed to point their actual boundary corners. To ensure reliability of the survey, I ran series of traverse stations and shot the existing old PLS monuments particularly corners of Lot 245-254 (see attached map, Annex B), to serve as additional reference for checking purposes.

Per results of the verification survey the following were determined:


- The existing monuments and structures of PLS 529 follows what is being described in the approved technical description except for:
 - Lot 248, PLS 529 equivalent to Lot 7051, Cad.800-D which was subdivided under survey number Psd-04-203959 in which the position of fence by the occupants shows that the boundary markers were incorrectly placed (see attached annex ©).
 - ▶ Lot 249, PLS 529 equivalent to Lot 7052, Cad.800-D the position of the fence overlaps to the adjoining lot 7051, Cad.800-D, specifically Lot 248-A, Psd-04-203959 by 31.49 meters covering an area of 3,780 square meters (see attached annex 心).
 - One boundary monument of Lot 245, PLS 529 equivalent to Lot 7048, Cad.800-D were placed 30 meters towards the GSS lot (see attached annex D).
- The existing barangay road is not reflected on the map of PLS 529 and only portion of the road is reflected in GSS-04-000224 (see attached annexA).
- 3. The tie lines of some lots of GSS-04-000224 are observed erroneous and if correction or the tie lines are applied, it will create a gap between PLS and GSS (see attached annex v). These gap or space has occupants on the ground with existing structures and fences.

The team is on conclusion that the technical description of PLS 529 follows the actual positions and descriptions of the existing monuments & fences on the ground while the tie line of some lots within GSS-04-000224 are erroneous. The extent of error is undetermined to date because some lot claimants failed to pin point their boundary corners. There is a need to relocate the GSS lots in order to determine the particular lots having defective tie lines.

The parties affected in the determination of boundaries were informed of the results of observation.

In view of the foregoing, I hereby recommend that this report be forwarded to regional office for information and appropriate action.

Pursuant to Memorandum from the Regional Executive Director dated April 08, 2019, This Office Memorandum dated July 24, 2019 and a letter request from Yangco Law Office requesting assistance on the relocation survey of Lot 248-250, PLS-529, the undersigned together with the PENRO survey team conducted the relocation survey located at Simpocan, Puerto Princesa City, Palawan.

During the conduct of verification survey per Survey Order No. 2017-07-005 dated July 06, 2017 the team had ascertain the position and descriptions of the existing monuments, fences, walls and other permanent structures which presented a result of observation and submitted to the Regional Office.

The team is tasked this time to continue the relocation survey on PLS-529 particularly Lot 248-250 and place a concrete monuments based on the findings during the verification survey.

Per results of the relocation survey the following were accomplished:

- 1. The existing monuments and structures of PLS 529 follows what is being described in the approved technical description. Monuments labeled as government survey (GS) were placed on the boundary corners having without visible concrete monuments on the ground on the requested lot.
- 2. The existing barangay road is not reflected on the map of PLS 529 and only portion of the road is reflected in GSS-04-000224. Thus, portion of Lot 248 and 249 were traversed by the actual position of the road.

- 3. The lot subject to be monumented were Lot 248, 249, and 250, PLS-529 which was subdivided into PSD-04-203959, PSD-04-093233, and PSD-045316-071411 respectively covering a total of 17 corners monumented on the ground.
- 4. Markers were placed on the boundary corners which falls to the existing road.

In view of the foregoing, I hereby recommend that this report be forwarded to regional office for information.

This has reference to the request of this Office on the status of correction and/or amendment of Plan Gss-04-0000224 situated in Barangay Simpocan, Puerto Princesa City.

Be informed that this Office put on hold the acceptance and processing of all public land applications covered by the aforementioned plan considering that it has been reported that the said plan is erroneous. A Memorandum from the Regional Office dated April 23, 2018 was issued advising Engr. Donna Belle E. Luengo to complete the verification and relocation of the remaining lots under Gss-04-000224. Copies of several documents relative to the said request are hereto attached.

However, in paragraph 3 of your Memorandum dated October 4, 2022 which was forwarded to this Office per PENRO Memorandum dated December 7, 2022 which is quoted as:

"Further, the said plan is no longer amenable per submitted tabulated status of lots under the said survey plan have been issued with corresponding patents. Based on the letter or Ms. Teodula Pampilo the conflicts of Lots 35, 36 & 37 can be resolved by consolidation-subdivision taking into account the actual occupation of his children. This may also be applicable to other claimant in question of their occupied lots."

Be informed further that the said conflict mentioned is covered by PENRO Order of Investigation docketed as Land Case No. 0499 entitled Maximiano Dagot rep. by: Rosita Bula Dagot, Protestant versus Teodola Pampilo, et al involving Lot Nos. 35, 36 and 37, Gss-04-000224 all in Barangay Simpocan, Puerto Princesa City. The said conflict is not a simple boundary conflict but the issue is the ownership of the land.

Relative thereto, this Office is reiterating and requesting that a correction survey be made by that Office and not for the expense of the claimants/applicants who are most of them has no capacity to hire the services of a private Geodetic Engineer.


