This refers to Memorandum dated November 29, 2022 from the OIC, Assistant Regional Director for Technical Services regarding the request for issuance of Special Patent over a parcel of land in the name of Philippine Red Cross (PRC), Marinduque Chapter, situated in Brgy. Isok I, Poblacion, Boac, Marinduque and to reproduced records filed by PRC in this office.

Please be informed that the carpeta folder of the abovementioned application is not available in this Office as it was forwarded already to the Regional Office. Further be informed that as provided for under R.A. 10072, also known as Philippine Red Cross Act of 2009, PRC is defined as voluntary, independent and autonomous non-governmental society auxiliary to the Republic of the Philippines. Moreover, Section 4 of R.A. 10023 states that only public land actually occupied and used for public schools, municipal halls, public plazas or parks and other government institutions for public use may be issued special patents under the name of the national agency or LGU concerned. The acceptance of the said application by this Office was due to the belief that PRC is considered a national government agency.

Relative thereto, the request for issuance of special patent of the PRC-Marinduque Chapter cannot be facilitated as it is a non-government agency. It is advised that they may file for land registration case in the court of competent jurisdiction.

Please be informed that per Office Memorandum dated 05 July 2022 (photocopy enclosed) of the Chief, Records and Knowledge Management Division, this Office, it was mentioned that the status of the above mentioned subject request and/or the existence of the folder/s containing its records, if there are any, cannot be ascertain due to the fire incident that occurred on 28 May 2018, that razed the LMB Building, then located in Binondo, Manila, including most of our records. Further, the said request is not included in the records taken from the files of DENR-Records Management Division, which the LMB acted for CY 2014-2018.

Hence, may we request that the records of the above stated application be reproduced and submitted to this Office, for further appropriate action consistent with the existing laws, rules and regulations.
