We would like to inform you that what the guard-on-duty told you on January 16, 2023 is true that all staff of CENRO Sablayan Coordinating Office is in Sablayan and no one there can accept your document. All personnel of the Coordinating Office are enjoined to attend the Flag Raising Ceremony and meeting every Monday.

For the security of records and prevent loss of documents, the acting records officer of the Coordinating Office is the only one authorized to received documents. This documents will be forwarded to CENRO Main Office at Sablayan and the CENR Officer will refer to the concerned personnel for appropriate action.

With regards to the processing of the application for land title under the name of the second wife of Mr. Pedrito Villar, it is also true that the application was given due course. At that time, this office has not received any protest or claim that pertains to the subject lot, that is why they are advised to comply with the requirements just like what we do with the other clients of the DENR. However, when the office received the protest against the said application on November 29, 2022, it was referred to the office of the Barangay Captain of Barangay 3 to undergo the Barangay Conciliation Proceedings. This is compliance to the Local Government Code of 1992, Sec. 412, R.A. 7160, LOI 1314, Series of 1983, Implementing P.D. 1508. Also, our personnel in-charge in processing was advised that the processing of the said application be held in abeyance pending the resolution of the problem.
