Submitted is the accomplishment report of CENRO Roxas on the conduct of Coastal Clean-up on February 24, 2023 in Barangay Bagumbayan, Roxas, Oriental Mindoro. The activity is in response to the call of volunteers of Oriental Mindoro Provincial Environment Management Unit on the implementation of Republic Act No. 9003.

A total of 42 participants joined the said activity coming the CENRO Roxas, Dangay Port Maritime Police, Barangay Officials and volunteers. A 250-meter shoreline clean-up collected a total of 47 sacks of non-biodegradable wastes approximately 131 kilograms. It was turned-over to the Barangay Officials for proper disposal.

This is in response to the request of the Provincial Environmental Management Unit-Oriental Mindoro for volunteers pertaining to the implementation of the Republic Act No. 9003. Among the objectives of this act is to ensure the cleanliness of the surroundings. including the coastal areas.

The barangay chosen is one of the coastal barangays in the Municipality of Roxas, Oriental Mindoro, where issue on waste management associated with the people is pragmatic. This area is also a local tourist attraction for its beautiful sea side view and restaurants in the area. Due to increasing population in the area, extensive trashes and litters have been observed to be one of the environmental problems the barangay has been facing.

Please be informed that the activity was participated by employees of DENR-CENRO Roxas, Maritime Police of Danggay Roxas and Barangay constituents headed by Brgy. Captain Melecio Solangon. It was composed of 36 female and 42 male participants. The activity started with early in the morning in the initiative of DENR-CENRO Roxas, Oriental Mindoro.

The cleanup has lasted for an hour in an approximately 280-meters shoreline stretch. A total of 47 sacks with an estimated weight of 131 kilograms of wastes/garbage such as plastics, food wrappers, old clothes, fishnets and other non-biodegradable wastes were collected. Moreover, woody debris/litter was also observed in the whole stretch of area due to Northeast Moonsoon / Amihan Season. The collected wastes are turned-over to the barangay Officers for proper disposal.

In conclusion, it was observed that the site has no proper waste disposal and barangay does not strictly impose the ordinances on such environmental law. Hence, continuous information campaign will be conducted and coordination with the barangay LGU for strict implementation of ordinances and imposition of penalties on violation to proper solid waste management shall be done. Further, signage's regarding the laws need to be placed within the area as well, to remind the residents on the obedience to the law.

The selected site shall be the focus area for the conduct of same activities and other appropriate activities, in order to observe the progress and development, in terms of waste management and other environmental laws.








