

The Annual National Observance of 18-Day Campaign to End Violence Against Women (VAW) aims to be UNITED by 2030 and sustaining the traction gained from the 2016 to 2021 theme, "VAW-free Community Starts with Me," the 2022 campaign focused on the new recurring banner "UNITED for a VAW-free Philippines". This theme aims to highlight the powerful impact of combining individual efforts towards a collaborative and united thrust towards a VAW-free Philippines.

In observance of the 18-Day Campaign to End Violence Against Women, all DENR PENRO-Palawan Officials and Personnel and CENR Offices were encouraged to actively participate in all activities related to the said event, these include the following to wit;

k. awarding ceremony during the culminating activity to formally close the 18-Day Campaign to End VAW

On November 25, officials and personnel enjoyed the DENR Palawan VAW Kick-off Activity it was held at DENR PENRO Lobby. One of the highlights of the kick-off was the lecture on "Anti-Violence Against Women and Their Children Act of 2004" or Republic Act 9262 having Atty. Herlene A. Hemor Legal Researcher of DENR PENRO Palawan as the resource speaker. Atty. Hemor discussed the full details of RA 9262 including four (4) types of violence, penalties, who may file Petition for Protection Orders and other important details. Participated by 25 female and 12 male for a total of 37 participants.

DENR PENRO Palawan received a memorandum dated November 22, 2022 from Regional GADFPS to join the virtual forum on LGBTQIA+ Community Issues in the Workplace conducted on December 1, 2022 and participated by the officials and personnel of DENR Palawan via zoom.

On Monday forum (December 5, 2022) DENR PENRO Women staff cast the Lupang Hinirang, Panunumpa and Short discussion about the annual campaign ask some trivia question and gave Tayo Ang Kalikasan (TAK) collaterals 5pcs. TAK shirt, 5pcs. TAK ballpen and 20pcs. TAK stickers to be specific followed by the announcement and updates of different Sections/Units and lastly our PENR Officer.

As part of the annual observance of the 18-Day Campaign to End VAW, the GADFPS of DENR Palawan organized a simultaneous lecture/forum on "Anti-Trafficking in Persons Act of 2003" or RA 9208 having Atty. Jazmin D. Altea, Attorney III of PENRO Palawan as the resource speaker. Held on December 6, 2022, face-to-face and via Zoom which was participated by the officials and personnel of PENRO and CENR Offices. Atty. Altea discussed the full scope of "Anti-Trafficking in Persons Act of 2003" or RA 9208 including the "Expanded Anti-Trafficking in Persons Act of 2012" or RA 10364 that amended the RA 9208 and established the "Inter-Agency Council Against Trafficking (IACAT) and has the three (3) important elements which was the Acts, Means and Purpose. Participated by 9 female and 3 male for a total of 12 participants.

In relation to campaign Information, Education and Communication (IEC) materials and videos of RA 9262 and RA 9208 are played on PENRO Lobby to disseminate important details regarding the mentioned laws. The materials and videos are from the Philippines Commission on Women website.

The DENR Palawan GADFPS had a 4-day extension of the Annual Observance of 18-Day Campaign to End VAW. On December 16, PENRO GAD Focal Person organized a Simultaneous Quiz Bee via Zoom at 9:00 am, the Mentimeter Application was used during the said activity to accommodate the participants from different CENR Offices. Ms. Maria Vianca Garraez earned 9442 points and placed 3rd in the final round while Ms. Helen Grace A. Rodriguez earned 10850 points and placed 2nd in the final round and for the 1st place earned 11427 points was Ms. Justine Medina. In the afternoon at 4:30pm the awarding of certificates and collaterals for resource speakers and winners, culminating activity was held to formally close the Annual Observance of 18-Day Campaign to End VAW PENRO officials and personnel participated the said activity. Participated by female and male for a total of participants.

In commemoration of the Annual Observance of the 18-day Campaign to End Violence Against Women (VAW) with a theme "UNITED for a VAW-free Philippimnes" from November 25 to December 12, 2022, the GAD Focal Point System of PENRO Palawan will be organizing simultaneous activities for the DENR personnel and staff to support the said observance. This year, the campaign generally aims to promote awareness about the Anti-Violence Against Women and their Children Act of 2004 (R.A. 9262) and Anti-Trafficking in Persons Act (R.A. 9208), both for the general public and the institutions that are mandated to implement the law.
