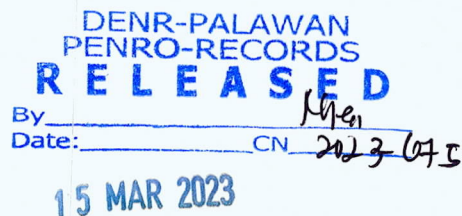
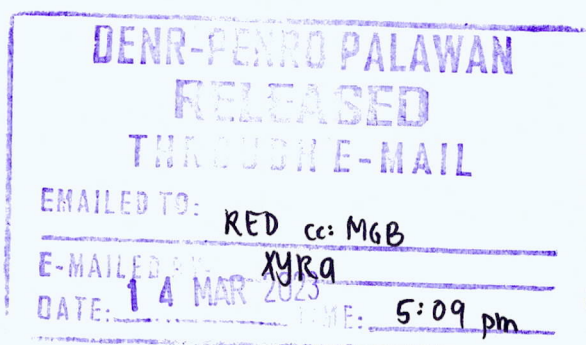

This pertains to the on-going public assembly/rally of the residents from the different barangays in the Municipality of Brooke's Point, Palawan composed of different community sectors (e.g Youth, Women and others) with their spokesperson Pastor Job Z. Lagrada along the National Highway of Purok 5, Barangay Maasin, Brooke's Point, Palawan, in front of the Office of Ipilan Nickel Corporation (INC) and along the Satellite Hauling Road of the company.

Relative thereto, per monitoring conducted by this Office from March 7, 2023 to date, it is informed that the following events/activities transpired:

1. March 7, 2023 – a mass was held by Bishop Socrates Mesiona in the area attended by the participants of the public assembly/rally. The mass was also attended by Vice Mayor Atty. Mary Jean D. Feliciano and ten (10) parish priests from other parish churches.

March 10, 2023 – RTC Branch 165 Presiding Judge Ramon Chito Mendoza signed and issued a 20-day Temporary Restraining Order (TRO) based from Civil Case No. BPT-0040 for Damages and Injunction, with Prayer for Ex-parte 72-hour TRO (with extension) and/or Writ of Preliminary Mandatory and Prohibitory Injunction, filed by Ipilan Nickel Corporation (INC) against Pastor Job Z. Lagrada, Dominador Magdaluyo, Marcelo Palmones and/or all other persons claiming rights under them and occupying the property of INC



Attached herewith are copies of Temporary Restraining Order and the Notice/Communication addressed to PMAJ Esperida for ready reference.

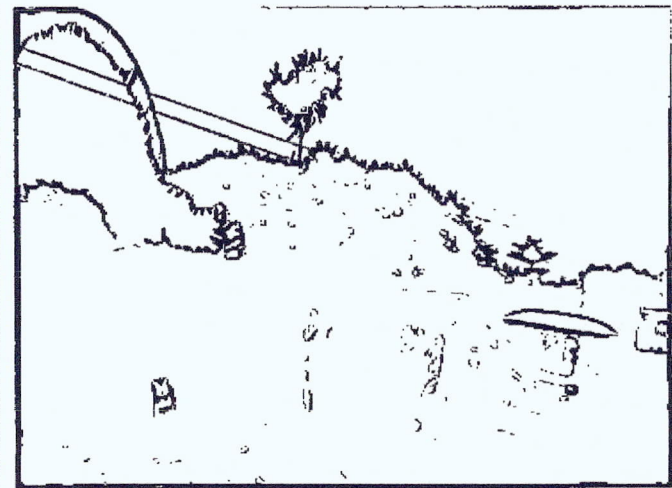
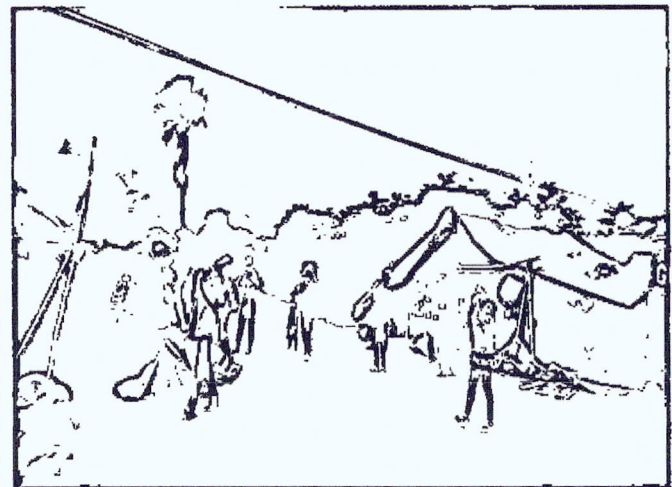
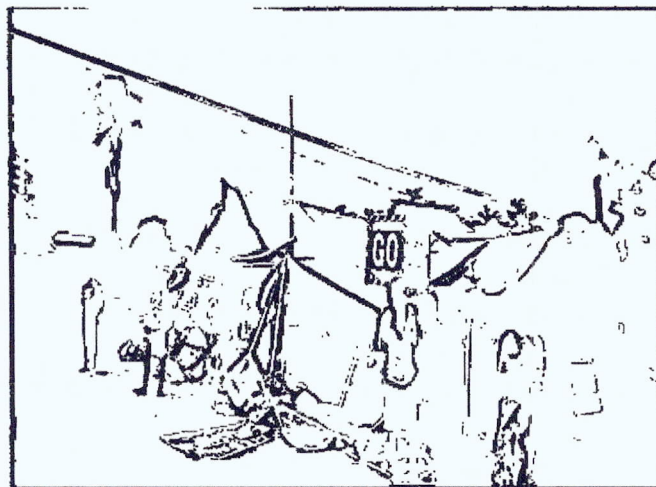
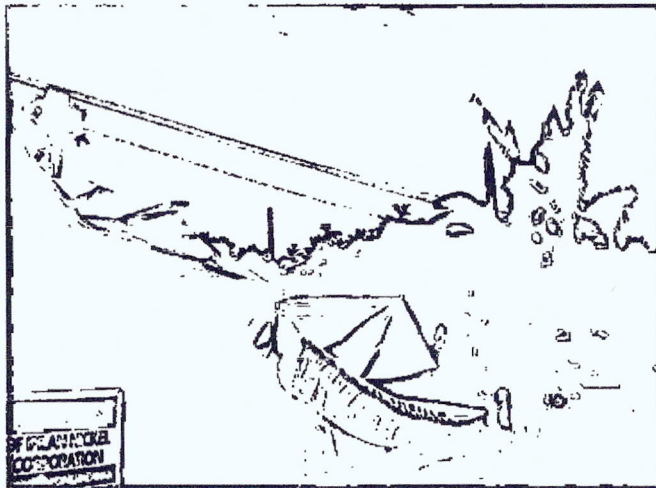

ORDER

When this case was called for hearing on March 10, 2023 at around 2:00pm for the purpose of the propriety of the issuance of Temporary Restraining Order (TRO), Atty.'s Christopher Capul, Mary Louise Inguillo and Reeno Febrero appeared as counsel for the petitioner Ipilan Nickel Mining Corporation (INC). Defendants Dominador Magdaluyo and Marcelo Polmones likewise appeared without any counsel.

During the hearing for issuance of TRO, Atty. Christopher Capul presented to the witness stand first witness Engr. Richard L. Natad a Geodetic Engineer by profession, who testified by way of Judicial Affidavit and who finished and concluded his direct testimony and in the process identified the following documentary evidence, to wit: the Transfer Certificate of Title (TCT) No T-7007 of the property owned by Ipilan Nickel Mining Corporation (INC) as Exhibit "A" the Location of the Map of the Barricade Established by the Defendants as Exhibit "J"; the PRC ID of the witness as

Exhibit "I"; and the Deed of Absolute Sale as Exhibit "B". Witness testified *in part* that when he did the plot and overlay he found out that the rallyists are occupying a portion of INC's property and have set up barricades at both sides of its Main Haul Road abutting the National Highway.¹

Next to be presented as witness for the plaintiff is Engr. Segundo Villanueva who also testified by way of Judicial Affidavit and who was able to conclude and finish his direct testimony and identified the following documents marked as Exhibit "A" the TCT No. T-7007; the Deed of Absolute Sale marked as Exhibit "B"; the PRC ID of the witness marked as Exhibit "I"; the Location of the Map of the Barricades Established by the Rallyists as Exhibit "J"; and the Photos marked as Exhibit "O" to O-4. Engr. Segundo Villanueva also testified that as a result of the constructed barricades and shelters upon INC's Main Haul Road which blocked the ingress and egress of the INC's premises the mining company experienced tremendous opportunity losses. He further testified that INC's relation with its contractor has been negatively affected. Due to the misinformation being spread by the defendants, witness testified that INC's goodwill has been and continues to be damaged.²

The defendants Dominador Magdaluyo and Marcelo Polmones actively participated during the entire proceedings by making statements and asking questions from the petitioner's witnesses.

Thereafter, Atty. Christopher Capul made an oral formal offer evidence and taking into account the oral comments/objections of the defendants, the Court RULES to admit all of the documentary evidence for whatever nature and purpose/purposes for which they have been offered.

After weighing the arguments and issues raised by both parties including the verified petition filed by the plaintiff and the Judicial Affidavits attached thereto, this Court finds and so holds that the matter is of extreme urgency and the applicant Ipilan Nickel Mining Corporation (INC) will suffer grave injustice and irreparable injury if this Court will not issue a Temporary Restraining Order (TRO) in its favor.

Accordingly, this Court hereby resolves to issue a Temporary Restraining Order (TRO) for a period of twenty days

(20) unless sooner lifted prohibiting and enjoining the defendants Dominador Magdaluyo and Marcelo Polmones and/or all other persons claiming rights under them and presently occupying the property of Ipilan Nickel Mining Corporation (INC) from stopping, apprehending, searching, obstructing or even approaching in and all the vehicles of individuals making use of access roads including the main whole roads, the barangay roads parallel to main whole road and access road in Sitio Panay going to INC or mine camp and to make their way to the mine pit and *vice versa* upon posting a bond to answer for the damages which the defendants may suffer by reason of the Temporary Restraining Order (TRO) if the Court should finally decide that plaintiff Ipilan Nickel Mining Corporation (INC) is not entitled thereto in the amount of **Five Hundred Thousand Pesos (Php500,000.00)**, payable to this Court within three (3) days from notice hereof.

Failure to post the same within the aforesaid period will result to the withdrawal or lifting of the Temporary Restraining Order (TRO). Meanwhile, let the hearing on propriety on the Issuance of *Writ of Preliminary Injunction* proceed on March 17, 2023 at 2:00 o'clock in the afternoon.

Notwithstanding that the parties have been notified in open court, the Court Sheriff IV Clodualdo V. Levita is hereby **DIRECTED** to personally serve copies of this Order to the petitioner Ipilan Nickel Mining Corporation (INC), the defendants Dominador Magdaluyo and Marcelo Polmones as well as all other persons claiming rights under them and occupying the property of Ipilan Nickel Corporation (INC) for information and guidance.

IT IS SO ORDERED.




