Under Travel Order No. 2023-001, the undersigned conducted a site investigation last 13 February 2023 in response to the report received from a CENRO-Coron personnel regarding the alleged seabed quarrying operations in Barangay VI, Coron, Palawan.

Background Information

Last 07 February 2023, six (6) individuals were seen conducting seabed quarrying along Coron Bay, just close to the mouth of the Dipulao River. They were diving to extract aggregates in the seabed using a shovel and putting them into sacks. These sacks will be placed in a raft or balsa for transportation back to the land (see Photo Documentation).

Upon initial interview with a certain Mr. Rogelio "Boy" Balat, the collected aggregates will be for personal use for their houses. Mr. Balat was hesitant to provide other details upon inquiry and did not fully disclose when they started extracting aggregates from

Purpose and Scope

The undersigned conducted the fieldwork to investigate the seabed quarrying operations further and verify its purpose. The investigation includes an ocular inspection of the site, photo documentation, a verbal interview with the said individuals or owner of the private property, and apprehension if necessary.

Findings and Observations

1. The subject area is along Coron Bay, Brgy. VI, Coron. It is geographically situated at 12° 0'36"N. 120°10'35"E. It is approximately 2.48 kilometers from CENRO, which is reachable by a 10-minute motorcycle ride followed by a 30-minute non-motorized boat ride (Figure 1).

Figure 1. Location map of the investigated seabed quarry site in Brgy. VI, Coron, Palawan. The red line is the route taken by the undersigned going to the subject area which is approximately 1.66 km from the entry point.

- 2. Before the investigation, the undersigned went to the Barangay Hall of Barangay VI to seek assistance from Hon. Maria V. Cinco. However, no barangay personnel was available to accompany the undersigned in the subject area. After further discussion with Kap. Cinco on the matter, she informed the undersigned that the extracted aggregates are not for the use of Fernvale Resort, but the individuals involved are "Delos Angeles" and "Ventorillo". Further, she stated that a yellow truck transfers the extracted aggregates. Kap. Cinco provided no further information as to the destination and recipient of the materials.
- 3. At the subject area, no person was *In Flagrante Delicto* or caught in the act of extracting aggregates from the seabed. However, the conveyances used for the extraction, such as two (2) rafts and some empty sacks, were seen (see Photo Documentation).
- 4. Also observed in the area are a concrete mixer, steel bars, and concrete forms (see Photo Documentation).
- 5. Upon docking, some individuals have avoided and hid from the undersigned. Despite countless communication requests, the individuals hid in a white concrete house and did not approach the undersigned. Thus, the undersigned could not gather any information or interview the purpose of the extraction of aggregates (see Photo Documentation and Figure 2).
- 6. After further investigation, the undersigned observed three (3) docking areas, two of which had a "No Trespassing. Community Property" sign (Figure 2).

Comments and Recommendations

 Based on the results of the investigation, the subject area is considered closed to mining applications under Section 15 of the DAO 2010-21,

In case of seabed/marine aggregate quarrying, offshore areas less than 1,500 meters from the mean low tide level of land or island(s) and where the seabed depth is less than 30 meters measured at mean sea level.

This statement also falls under Section 8 of DAO 2000-25 or the Implementing Rules and Regulations of Executive Order No. 153 - "Authorizing the Utilization of Offshore Areas not Covered by Approved Mining Permits and Contracts as Sources of Dredgefill Materials for Government Reclamation Projects and for Other Purposes".

- Since there was no interrogation with the individuals present in the subject area or any
 communication with the person ordering the extraction, no apprehension took place.
 Therefore, no seabed quarrying permit or other pertinent documents were presented to
 the undersigned.
- Provided that no permit was granted to the owner, such activity violates Section 103 of the Republic Act 7942, otherwise known as the Philippine Mining Act of 1995.

Theft of Minerals. - Any person extracting minerals and disposing the same without a mining agreement, lease, permit, license, or steals minerals or ores or the products thereof from mines or mills or processing plants shall, upon conviction, be imprisoned from six (6) months to six (6) years or pay a fine from Ten thousand pesos (P10,000.00) to Twenty thousand pesos

(P20,000.00), or both, at the discretion of the appropriate court. In addition, he shall be liable to pay damages and compensation for the minerals removed, extracted, and disposed of.

Furthermore, the extracted materials are considered illegally sourced mineral/mineral products. Based on Section 116 Chapter XII of DAO 2010-21.

Illegally-sourced minerals/mineral products are those which are mined, extracted, removed and/or disposed of without authority or permit under existing mining laws, rules and regulations.

- 4. Since there is no information regarding the purpose of the seabed quarrying, whether it is part of any Government Reclamation Projects or for personal use, the undersigned will continuously monitor the subject area in cooperation with Barangay VI.
- For CENRO-Coron to endorse this to PMRB-Palawan to obtain more information on the seabed quarrying operation, proper evaluation of the violations, and impose appropriate sanctions,


