

Greetings!

The undersigned is writing on behalf of my client, Lusviminda Acosta. This pertains to the implementation of the decision in DENR Case No. 5904 (DIGNA MATALANG COCHING, SPS FELIPE ACOSTA AND LUZVIMINDA ACOSTA, APPELLANTS, VERSUS EMELIE L. BESAGA, APPELLEE) as per the Memorandum from DENR-MIMAROPA dated January 20, 2022 (copy of the memorandum dated January 20, 2022 is attached herein as Annex "A").

The said memorandum states:

Based on the foregoing, the CENRO Roxas, Palawan is instructed to implement the Order dated December 27, 2017 in compliance with the Memorandum dated January 26, 2016 of the Office of the Assistant Secretary for Legal Affairs as well as the subject Memorandum, secure the assistance of the local government unit concerned and personnel of the Philippine National Police, and immediately submit a report of compliance hereof.

From the said Memorandum, it is clear that the CENR Officer of CENRO Roxas, Palawan is the responsible official tasked to implement the aforesaid decision, particularly the implementation of the Notice to Vacate dated August 20, 2020 from the Regional Executive Director ordering Emelie Besaga to vacate the subject area in the decision (copy of the Notice to Vacate is attached as **Annex** "B" hereof).

The said Notice to Vacate was not implemented because Emelie Besaga filed a Motion to Quash to challenge the said Notice to Vacate and the Order dated December 27, 2017. However, as per the Notice from the Regional Director of DENR MIMAROPA dated August 25, 2021, the said Motion to Quash has been denied because the Regional Director stated that the judgment has become final and can no longer be modified nor disturbed (copy of the said notice dated August 25, 2021 is attached herein as Annex "C").

Please take note that as of March 21, 2022, there has been a relocation survey of the subject area of the decision and the existing structures of Ms Besaga inside Lot 4512 and 4514 were already identified. See copy of the Memorandum from PENRO Palawan dated March 21, 2022 and attachments as **Annex "D"**.

In lieu of the above, it is most respectfully prayed that the Order dated December 27, 2017 should be immediately implemented by this Honorable Office, including the aspect of enforcing the Notice to Vacate against Besaga. As per the Memorandum dated January 20, 2022, the CENRO Roxas was specifically mandated to fully implement the aforesaid order. The CENRO Roxas, Palawan is mandated to secure the assistance of the LGU and PNP Personnel. Hence, the CENR Officer of Roxas, Palawan no longer has any option but to implement the said decision. He cannot pass the implementation to the LGU. The continued non implementation of the said order is Prejudicial to the interest of my client who has been deprived of the enjoyment and position of the subject property for many years when the Supreme Court has already rendered a final and executory decision over the subject matter since September 21, 2015.

Wherefore, it is prayed that your Honorable Office should take immediate action and implement the said decision. Otherwise, my client will be constrained to file the necessary action to protect her interest, including but not limited to filing administrative cases before the Office of the Ombudsman for Grave Misconduct and/or Gross Neglect of Duty as well as other pertinent administrative disciplinary cases.



Code of 1991, specifically Book Three, Chapter 3, Article I, Section 444 (b)(3)(vi) thereof and similar provisions.

At your option, you can also file a case before the court to expedite the implementation.

This refers to your letter dated November 13, 2018 addressed to the Undersecretary for Field Operations seeking assistance regarding your Forest Land Use Agreement for Tourism Purposes (FLAgT) dated November 18, 2005.

Records show that you are the petitioner in G.R. No. 194061 entitled "Emelie L. Besaga versus Spouses Felipe Acosta and Luzviminda Acosta and Digna Matalang Coching". The petition was denied and the case was declared final and executory per Entry of Judgment dated September 21, 2015 issued by Supreme Court – Deputy Clerk of Court and Chief, Judicial Records Officer Basilia T. Ringol.

Consequently, the case was remanded to the DENR wherein per Memorandum dated January 26, 2016 of then Acting Assistant Secretary for Legal Affairs, the latter stated that the full implementation of the August 6, 2006 Decision necessitates the:

"Pursuant to the subject Decision of the Office of the President as affirmed by the Court of Appeals and the Supreme Court in their Decisions docketed as CA-G.R. SP No. 100616 and G.R. No. 194061 dated October 30, 2009 and August 5, 2015, respectively, and in compliance with the instruction dated January 26, 2016 of the then DENR Acting Assistant Secretary for Legal Affairs to implement the August 6, 2006 Decision rendered in DENR Case No. 5904, the Forest Land Use Agreement for Tourism Purposes issued to Emelie Besaga (FLAgT No. DENR IV-MIMAROPA-11302030-0002) is ordered, as hereby it is, AMENDED to cover only Lot No. 4513 of Cad. 860-D, San Vicente Cadastre and to exclude therefrom Lot Nos. 4512 and 4514 of the said cadaster which pertain to and are covered by the FLAgT application of Luzviminda Acosta.

Records further show that you filed thru counsel a Motion for Reconsideration and/or Protest/Opposition to the Order dated December 27, 2017. This was denied per Resolution dated September 13, 2018 issued by then Regional Executive Director Henry A. Adornado wherein it was stated that:

"This Office holds that the instant Motion need not anymore be commented upon by the Spouses Acosta as the decision in the original case from which the implementation is based is the same final and executory decision upon which this Motion is based."

xxx-xxx

The instant Motion can no longer be entertained by this Office since this case has already attained finality and is in its final stage of implementation. The other peripheral issues cited by the Movant cannot be properly resolved along with the implementation being assailed as the allegations have been the subject of a previous separate investigation by this Office."

Moreover, it bears stressing that a decision that has acquired finality, as in this case, becomes immutable and unalterable. A final judgment may no longer be modified in any respect, even if the modification is meant to correct erroneous conclusions of fact or law. In short, once a judgment becomes final and executory, it can no longer be disturbed no matter how erroneous it may be and nothing further can be done therewith except to execute it.

In view of the foregoing, we regret that we cannot extend assistance regarding your FLAgT because we are only implementing a Decision issued by the Supreme Court which has become final and executory.

We hope we have enlightened you regarding this matter.

SUBJECT OF THE ORDER AMENDING THE FOREST LAND USE AGREEMENT FOR TOURISM (FLAGT) PURPOSES

ISSUED TO EMILIE L. BESAGA

In compliance to the memo-instruction from the Regional Executive Director dated January 20, 2022 relative DENR Case No. 5904 duly resolved with Order of Finality, the survey team created under PENRO Special Order No. 2022-018 dated February 22, 2018 together the Regional team and representative of the parties conducted the relocation/verification survey of Lot 4512, 4513 and 4514, Cad.860-D, located at Barangay Port Barton, San Vicente, Palawan.

The team is tasked to ascertain the position and descriptions of the existing monuments, fences, walls and other permanent structures inside the subject lots. After data gathering through research, the following were observed:

- There is a an approved FLAgT plan (No. DENR IV-MIMAROPA-11302030-0002) certified by Jose M. Difuntorum, Chief Forest Resources Conservation Division, recommended by Armando P. Rutaquio, Regional Technical Director for Forestry, and approved by Vicente S. Paragas, CESO III, Regional Executive Director Region IV-B. It consists of one (1) lot covering an area of 1.4 hectares with nine (9) corners. (Annex 1)
- The FLAgT was awarded to Ms. Emilie Besaga on November 18, 2005 for a period of twenty five (25) years to expire on November 30, 1930. (Annex II)

The survey started by reading side shots made randomly on the existing monuments particularly BLLM No. 19 and 25, fence corner of Lot 4509, 4510, 4511 and PS monuments of Lot 4505, to serve as additional reference for checking purposes.

Per results of the survey the following were determined (see Annex III):

- 1. The corners of subject lots were all marked with stake to delineate its boundaries.
- 2. Lot 4513, Cad.860-D falls entirely within the salvage zone of 25.00 meters wide designated by the LGU.
- 3. All Existing structures of Ms. Besaga were identified and observed. It falls inside Lot 4512 and 4514.

Attached are pictures of documentation for the entire survey activities. In view of the foregoing, it is hereby recommended that this report be forwarded to the Regional Office for information and appropriate action.

I am writing on behalf of MRS. LUZVIMINDA ACOSTA pertaining to G.R. No. 194061 entitled EMELIE L. BESAGA vs. SPOUSES FELIPE ACOSTA AND LUZVIMINDA ACOSTA AND DIGNA MATALANG COCHING. In that case, the Decision rendered by the Supreme Court (Second Division) has already become final and executory as of April 20, 2015. A copy of the Decision and the Entry of Judgment are attached for your reference.

In the said Decision, the Supreme Court upheld the findings made by the Secretary of the DENR, the Office of the President and the Court of Appeals. The Decision recognized my rights as the legitimate applicant for an SLUP over Lot Nos. 4512 and 4514. My client has repeatedly made follow-ups in your office and in the office of the DENR-CENRO of Roxas-San Vicente for the full implementation of the said Decision to no avail. In your Memorandum dated June 13, 2017 you make it appear that your Office is still in the process of "clarification" as to the status and action taken by other offices regarding my rights over the said properties.

Considering that the survey of Lot Nos. 4512 and 4514 were undertaken by your Office and the fact that it was your Office that initially included these parcels of land in the SLUP-FLAgT of EMELY. BESAGA, we believe that all the matters or information that you require are within your Office. Also, even the Office of the Secretary, the Regional Director and your Legal Office has already directed your Office for the full implementation of the said Decision.

In this connection, we are respectfully requesting your Office to immediately implement the said Decision.
