On record is our memorandum of March 9, 2023 to CENRO Puerto Princesa instructing to submit compliance to the instruction of the OIC ARD for Technical Services considering that Mr. Salazar requested to hold in abeyance the conduct of investigation involving Lots 8074, 8754 and 8764, Cad 199 situated at Tagauayan, Cuyo, Palawan because it is in the level of court and is waiting for the resolution.

Per attached letter of Mr. Salazar, he corrected the misinformation relative the case he filed. Accordingly, it is before the Provincial Prosecutor Office and not of Regional Trial Court. In the paragraph 3 of the same letter he humbly asked for the apology he made before that Office.



Cocoro, Magsaysay, Palawan over certain parcels of land located on the said barangay (hereto attached with attachments).

Please be informed that per our letter dated April 18, 2022 (copy hereto attached), the Protestants, Mr. Emilio Agnas, et. al., were directed to file their verified protest against the Agricultural Sales Application No. 045316-013 of Stimson Salazar covering Parcel No. 5 of Tagauayan Island Big and Parcel No. 6 of Tagauayan Island Small containing an area of 387.6 hectares located in So. Tagauayan, Bgy. Cocoro, Magsaysay, Palawan. However, as of this moment, this Office has not received any verified protest from the complainants.

In this regard, this Office would like to reiterate our previous memorandum dated July 20, 2022 (copy hereto attached), requiring the complaints to file their verified protest and requesting the Regional Office for fund allocation with regards to the conduct of ocular inspection/investigation over the said land dispute considering that the subject area is an island municipality.

This pertains to the letter dated April 4, 2022 (copy hereto attached) of Mr. Stimson L. Salazar which was received by this Office on July 4, 2022 requesting for an ocular inspection/investigation and meeting with the Sangguniang Bayan of Magsaysay, Palawan together with the complainants regarding his land dispute against Mr. Emilio Agnas, et. al. over Tagauayan Islands (Big and Small) located in So. Tagauayan, Bgy. Cocoro, Magsaysay, Palawan.

Please be informed that per our letter dated April 18, 2022 (copy hereto attached), the Protestant, Mr. Emilio Agnas, et. al., were directed to file their verified protest against the Agricultural Sales Application No. 045316-013 of Stimson Salazar covering Parcel No. 5 of Tagauayan Island Big and Parcel No. 6 of Tagauayan Island Small containing an area of 387.6 hectares located in So. Tagauayan, Bgy. Cocoro, Magsaysay, Palawan anent to the instruction from then Regional Executive Director Maria Lourdes G. Ferrer, *CESO III* per letter dated November 25, 2021 (copy hereto attached) pursuant to DENR Administrative Order (DAO) No. 2016-31.

Considering that some lots within the Municipality of Magsaysay, Palawan are covered by Decree, the Protestant was likewise requested to secure first a Certification from the Cuyo-Agutaya-Magsaysay Municipal Circuit Trial Court certifying that the involved lots of the Protest are within Public Land and are not covered by any Decree or Cadastral Court Proceedings for Registration. Attached herewith are the list of involved lots within Tagauayan Islands (Big and Small).

Be informed further that the said lots are the subject of complaint of the residents of Tagauayan Islands per letter dated May 25, 2021 (copy hereto attached).

In this regard, considering that there is no allocated fund/budget with regards to the conduct of ocular inspection/investigation subject of the protest and/or conflicting claim, this Office would like to respectfully request for a funding for the travelling expenses over the disputed land since the subject area is an island municipality.

In addition, we would like to request for a copy of the investigation report rendered by the Fact-Finding Team from the Central Office wherein per Memorandum dated April 29, 2015 (copy hereto attached) from Acting Assistant Secretary for Legal Services Atty. Dear DENR-CENRO Velasco:

With reference to your letter dated November 4, 2022, asking this representation to furnish Your Office a copy of the Criminal Case filed before the Regional Trial Court of Palawan. May I correct the information regarding the case which I have filed before the Provincial Prosecutors Office (PPO), is not with the RTC of Palawan. It is about the criminal case for Attempted Murder resulting from an incident that transpired on April 25, 2021, perpetrated by Emilio Agnas and members of his family and some residents thereat attempting to harm us. A Resolution issued by the Provincial Prosecutors Office, for some legal technical reason, was downgraded to Grave Threats, instead, of my original complaint for Attempted Murder. Photo copy is hereto attached and marked as **Annex "A"**.

My Lawyer, having not satisfied with the PPO Resolution, filed a Motion for Reconsideration praying to reconsider our original complaint for Attempted Murder, but, it was not granted. That case for Grave Threats was subsequently elevated to lower Court which is now being heard at the Municipal Trial Court of Cuyo, Palawan. Photo copy of the Motion for Reconsideration is hereto attached and marked as **Annex "B"**.

With all due respect, I, stand corrected for the misinformation I made in my letter to the OIC, ASSISTANT REGIONAL DIRECTOR FOR TECHICAL SERVICES on September 11, 2021. Further, humbly asking that Office of my sincerest apology of my honest mistake.

Please allow me to clarify the issues. That, it is not about the lots covering Lot Nos. 8074, 8075, 8754 and 8764, Cad-229, which was previously investigated and ocular-inspected by the DENR Central Office Fact Finding Team, headed by ATTY. GERALDINE DELA CERNA RAMOS, acting on the SB RESOLUTION NR. 02-2015. Photo Copy of that Letter dated February 10, 2015, hereto attached and marked as **Annex "C"**. A Resolution for that matter was issued, by then Acting Assistant Secretary for Legal Services, DENR, ATTY. ANSELMO C. ABUNGAN on April 29, 2015, Photo copy of which is hereto attached and marked as **Annex "D"**.

In fact, the conflicting issues now being complained by Sps. Emilio Agnas and Delia Abrina Agnas, by among the Heirs, are the properties left behind by late SIMEON ABRINA and BARBARA NACASI, their grandfather. Sps Emilio and Delia Abrina Agnas are not in favour of selling parts of their inherited shares to this representation. Photo Copy of the letter addressed to OIC CENRO PEDRO A. VELASCO dated February 2, 2023 by the other heirs is hereto attached and marked as **Annex "E"**.



The DENR-RED MIMAROPA Region sent a letter on November 25, 2021 to EMILIO AGNAS in order for him to submit a verified Protest against me. As of this date, no such Protest has been filed by him. A copy of the letter is attached and marked as **Annex "F"**.

Some of the residents of Taguayan Island filed a complaint against me at the Sangguniang Panlalawigan ng Palawan alleging that I hired goons and harassed them. This is not true. The complaint was scheduled for hearing before the Committee on Barangay Affairs of the Sangguniang Palawan on February 14, 2022. The Complainants did not appear. The Committee called my attention to the signatories in the Complaint who appears to be signed by only one person. Copy of the complaint is marked as **Annex "G"**.

Similar complaints were filed before the Offices of DENR-MINAROPA, DENR-PENRO and DENR-CENRO, in Puerto Princesa City. These complaints were likewise brought to the attention of media where me and members of my family were dragged and embarrassed us before the public.

In view of the foregoing reasons, may I therefore respectfully request Your Office to conduct ocular inspection and investigation in order to clarify, ventilate and to end up the issues on the alleged illegal and speculative acquisition and sale of public lands at So. Taguayan, Barangay Cocoro, Magsaysay, Palawan.

RESOLUTION

This resolves the above-captioned complaint for Attempted Murder that charges all herein respondents after they allegedly conspired, confederated, and mutually helped each other, while armed with bolo, steel pipe, and wooden club, in trying to kill complainant and his companions on April 25, 2021, at around 9:00 o'clock in the morning in Tagawayan shoreline, of Barangay Cocoro, Magsaysay, Palawan, but respondents' attempt was thwarted as complainant and company were able to leave the place unscathed.

The Criminal Complaint has the following attachments, to wit:  
(1) *Malaya at Kusang Loob na Salaysay* of Stimson Salazar y Lanuza; (2) *Malaya at Kusang Loob na Salaysay* of Pamela Salazar y Pacaldo; (3) *Malaya at Kusang Loob na Salaysay* of Reynante Palao y Bantog; (4) *Malaya at Kusang Loob na Salaysay* of Alex Parangue Y Agnas; (5) Report on Violation of Art. 51 (Attempted Murder); and (6) Cellular phone video of the incident in a compact disc (CD).



IN VIEW OF THE FOREGOING, it is respectfully recommended that **INFORMATION** for the crime of **GRAVE THREATS** under Article 282 (1) of the Revised Penal Code, as amended by Section 70 of Republic Act No. 10951, be **FILED** against respondents **EMELIO AGNAS** and **RENE ABRINA** before the proper court.



**MOTION FOR RECONSIDERATION  
/RE-INVESTIGATION**

The Private Complainant STIMSON L. SALAZAR, by himself and under oath, unto this Honorable Court most respectfully states the following:

1. On September 6, 2021, this Honorable Office issued a Resolution in this case. At that time, the Respondents had not yet filed their Counter-Affidavit. A copy was received on September 24, 2021.

2. The dispositive portion of the Resolution states the following:

**"IN VIEW OF THE FOREGOING, it is respectfully recommended that INFORMATION for the crime of GRAVE THREATS UNDER Article 282 (1) of the Revised Penal Code, as amended by Section 70 of Republic Act No. 10951, be FILED against respondents EMELIO AGNAS and RENE ABRINA before the proper court.**

The complaint against the rest of the respondents, namely:  
**LUISITO ABRINA, DELIA AGNAS, ANGELIE DERIAL, IRENE DELA CRUZ, REGINA ABRINA, JOSELITO ABRINA, JONIEMEL MANLAPAZ, JOHN LOWIE ABRINA, LINDA VILLAVERDE, ADELA DACILLO, RODRIGO BAGONA, a.k.a BABY MANLAPAZ, ALFREDO AGNAS, ERMA AGNAS, HELEN AGNAS, and ROLLY AGNAS, is hereby DISMISSED for lack of probable cause.**



nued to threaten him and his companions. They were forced to immediately re-start the engine of the banca and travelled back to Magsaysay, Palawan.

10. When the Complainant and his companions arrived in Bantayanan Wharf in Bgy. Lucbuan, Magsaysay, Palawan, they saw four (4) PNP personnel there including the Chief of Police. It appears that the Respondents had reported the incident to the PNP even before they arrived in the wharf. However, the PNP did not conduct a search on their person to verify if the Complainant had a firearm with him. They then left the wharf and proceeded to the PNP Magsaysay to report the incident. The Complainant presented his toy-gun to the PNP Investigator. This is the same plastic toy gun that the Complainant had used in bluffing the Respondents.

11. The Complainant reported the incident to the PNP Magsaysay, Palawan and also filed a complaint in the barangay. In the barangay, the parties agreed to amicably settle the case. Copy of Kasunduan in the barangay is **Annex "B"**. However, the Respondents filed a Complaint against him for GRAVE THREATS and a complaint was actually filed at the MCTC Cuyo, Palawan. The case was dismissed by the court. A copy of the Order of dismissal is attached as **Annex "C"**.

12. When the Respondents filed the complaint against the Complainant, he was compelled to file this Complaint for ATTEMPTED MURDER in order to protect himself from the baseless criminal charge against him. The affidavit complaint of the complainant and his witnesses are all in the records of this case submitted by the PNP Investigator. The video footage by the Respondents and the video footage of the Complainant had been submitted to this Honorable Office.

13. The audio of the video footage clearly captured the voice of one of the Respondents to punch a hole in the banca so that the banca will not be able to leave the place and the Respondents can kill the Complainant and his companions. These words were uttered even as the banca was already leaving the place.

### **Arguments & Discussion**

14. *"The essential elements of an attempted felony are as follows:*

*The offender commences the commission of the felony directly by overt acts;*

*He does not perform all the acts of execution which should produce the felony;*

*The offender's act be not stopped by his own spontaneous desistance;*

*The non-performance of all acts of execution was due to cause or accident other than his spontaneous desistance.*

*The first requisite of an attempted felony consists of two (2) elements, namely:*

*(1) That there be external acts;*

*(2) Such external acts have direct connection with the crime intended to be committed." (Fantastico vs. Malicse, G.R. No. 190912, January 12, 2015)*



*Police Staff Sargent Samuel A. Bacuel, the Police Investigator in this case, is hereby directed to **submit with dispatch** or within ten (10) days from receipt hereof the Barangay **Certification** to file action after conciliation between the parties failed*

3. On September 29, 2022, the private Complainant filed a Motion for Reconsideration. The Respondents were furnished with a copy of the motion by way of registered mail. It appears that this motion was not acted upon by this Honorable Office. It also appears that a Criminal Information for Grave Threats for EMELIO AGNAS and RENE ABRINA was filed before the MCTC of Cuyo, Palawan. The records of the lower court does not contain a Resolution of the Motion for Reconsideration filed by the Private Complainant.

4. The arraignment of these accused was scheduled for hearing on March 24, 2022 before the MCTC of Cuyo, Palawan. During the hearing, the private complainant asked the Honorable Court for the reconsideration of the fact that only two (2) of Respondents in the criminal complaint before this Honorable Office had been charged.

### **Facts of the Case**

5. The Private Complainant adopts and re-pleads the allegations in his Motion for Reconsideration for the purpose of this MOTION FOR RECONSIDERATION/REINVESTIGATION, as follows:

6. On April 25, 2021, the Complainant travelled to Tagawayan (main island) in order to inspect the Barangay Multi-Purpose Building as the Punong Barangay of Bgy. Cocoro, Magsaysay, Palawan asked for his help for the repair of the said building. Punong Barangay RENANTE PALAO together with his two (2) Barangay Tanods were with the Complainant. Also travelling with the Complainant was his daughter. They also brought along with them snacks for the residents of the Sitio Tagawayan as PB PALAO had requested for an assembly of the residents upon his arrival.

7. The Complainant is a claimant of several parcels of land in Tagawayan (main island) by virtue of Waiver of Rights executed by other claimants in his favor. He has tax declarations over these parcels of land. He has an approved Survey Order over the island as well as the small island nearby. A copy of the Survey Order is attached as **Annex "A"**.

8. When the motorized banca was approaching the island, the Complainant noticed several persons who were armed with bolos, steel pipes and wooden sticks were approaching the motorized banca. They threatened to kill us. They even insulted PB PALAO.

9. As these persons were getting near the motorized banca, the Complainant who had a foreboding of what could possibly happen in the island had brought along with him a plastic toy gun. He told these persons to desist from getting near the banca or he would shoot them. Even as he was bluffing these persons with his toy gun even while two (2) of them slashed and hacked the bow and the outrigger of the banca. At the same time, these persons conti-



nued to threaten him and his companions. They were forced to immediately re-start the engine of the banca and travelled back to Magsaysay, Palawan.

10. When the Complainant and his companions arrived in Bantayanan Wharf in Bgy. Lucbuan, Magsaysay, Palawan, they saw four (4) PNP personnel there including the Chief of Police. It appears that the Respondents had reported the incident to the PNP even before they arrived in the wharf. However, the PNP did not conduct a search on their person to verify if the Complainant had a firearm with him. They then left the wharf and proceeded to the PNP Magsaysay to report the incident. The Complainant presented his toy-gun to the PNP Investigator. This is the same plastic toy gun that the Complainant had used in bluffing the Respondents.

11. The Complainant reported the incident to the PNP Magsaysay, Palawan and also filed a complaint in the barangay. In the barangay, the parties agreed to amicably settle the case. Copy of Kasunduan in the barangay is **Annex "B"**. However, the Respondents filed a Complaint against him for GRAVE THREATS and a complaint was actually filed at the MCTC Cuyo, Palawan. The case was dismissed by the court. A copy of the Order of dismissal is attached as **Annex "C"**.

12. When the Respondents filed the complaint against the Complainant, he was compelled to file this Complaint for ATTEMPTED MURDER in order to protect himself from the baseless criminal charge against him. The affidavit complaint of the complainant and his witnesses are all in the records of this case submitted by the PNP Investigator. The video footage by the Respondents and the video footage of the Complainant had been submitted to this Honorable Office.

13. The audio of the video footage clearly captured the voice of one of the Respondents to punch a hole in the banca so that the banca will not be able to leave the place and the Respondents can kill the Complainant and his companions. These words were uttered even as the banca was already leaving the place.

### **Arguments & Discussion**

14. *"The essential elements of an attempted felony are as follows:*

*The offender commences the commission of the felony directly by overt acts;*

*He does not perform all the acts of execution which should produce the felony;*

*The offender's act be not stopped by his own spontaneous desistance;*

*The non-performance of all acts of execution was due to cause or accident other than his spontaneous desistance.*

*The first requisite of an attempted felony consists of two (2) elements, namely:*

*(1) That there be external acts;*

*(2) Such external acts have direct connection with the crime intended to be committed." (Fantastico vs. Malicse, G.R. No. 190912, January 12, 2015)*



15. In this case, the Respondents commenced the execution of the crime of attempted murder by their overt acts of "welcoming" the Complainant and his companions with bolos, steel pipes and wooden sticks, all intended to kill the Complainant and his companions as the acts were simultaneous with their shouts to kill the Complainant and his companions. They, however, failed to produce the felony not because of their spontaneous desistance as they persisted in committing the acts until the Complainant's banca was immediately re-started and they hurriedly left the place. In other words, they failed to commit the crime of murder because the Complainant and his companions left the place. Two (2) of the Respondents had actually committed overt acts by hacking and slashing the bow and outrigger of the banca in order to disable the banca and thus consummate their intent to kill.

16. Intent to kill can clearly be inferred from the acts of the Respondents when they met the banca of the Complainant all fully armed to kill. This incident is so unusual as even women were likewise armed to kill with bolos. Thus clearly showing their deliberate and conspiracy to kill the Complainant and his companions. This is very clear even in the video-footage that the Respondents submitted to the MCTC Cuyo when they filed a complaint for GRAVE THREATS against herein Complainant.

17. There was no spontaneity in the commission of the acts by the Respondents against the Complainant who was visiting the island together with the Punong Barangay in order to lend assistance in the repair of a barangay multi-purpose building. They were thus shocked to see the Respondent wading in the sea to meet the banca of the Complainant and his companions who were then unarmed. Thus, there is evident premeditation and treachery.

18. It could also be said that since the Complainant and his companions were just five (5) while the identified Respondents are eighteen (18), there is an abuse of superior strength committed by them against the Complainant and his witnesses. There were actually 23 armed people who met the Complainant and his banca as they were approaching the beach.

19. The Complainant also came to know that the mastermind of the ATTEMPTED MURDER (assassination) against him is a certain LORENA ANDAO CHERRY as shown in the Facebook posts by her to the Respondents. Copies of the screen shots of her Facebook posts are attached as **Annex "D"** and **Annex "D-1"**. These Facebook posts are even more shocking because they are public posts. Portions of the public Facebook posts is the following:

"x x x **TARABANGI INDO TAD-TADEN DAN SI SALAZAR  
MAKITA INDO SA DALAN PIANGA INDO REYNANTE PALAO  
PATIGAYON DAN BAGO MAGKARAGULO DYAN**" (LET US HELP EACH  
OTHER CHOP INTO PIECES SALAZAR IF YOU SEE HIM IN THE ROAD.  
BREAK HIS BONES REYNANTE PALAO PLEASE BEFORE TROUBLE  
HAPPENS THERE)

20. The Respondents were emboldened to commit the acts against the Complainant because LORENA ANDAO CHERRY promised them that if they will file a complaint against the Complainant, she will pay the services of a lawyer.



The evident premeditation by the Respondents and by LORENA ANDAO CHERRY to kill the Private Complainant is evident and clear.

21. The Complainant believes that a Certificate to File Action is not required in this case as the complaint is for ATTEMPTED MURDER and not a complaint for GRAVE THREATS. The penalty for ATTEMPTED MURDER is more than one (1) year. Hence, referral to the barangay is not required.

22. The Complainant in this case is a resident of Bgy. Tenga-Tenga, Cuyo, Palawan while the Respondents are residents of Tagawayan Island, Bgy. Cocoro, Magsaysay, Palawan. Pursuant to the Local Government Code, if the parties are residents of different municipalities, referral to the barangay is not required.

23. The Complainant also believes that he need not be hacked by the Respondents in order for a complaint of ATTEMPTED MURDER can be filed against them. The Respondents did not merely threaten to kill the Complainant, they truly intended to kill him at that time as shown in the video evidence. The complaint is not GRAVE THREATS because the Respondents did not merely threaten to kill the Complainant and his companions. They intended to kill the Complainant and his companions and failed but not because of their desistance but because the Complainant and his companions were able to escape on time.

24. The annexes attached in the Motion for Reconsideration are also adopted and re-pleaded in this Motion for Reconsideration/Reinvestigation. The Private Respondent can readily identify the Respondents as shown in the video footages that they themselves submitted before this Honorable Office and the their video-footage that was submitted before this Honorable Office.

**WHEREFORE**, premises considered, it is most respectfully prayed unto this Honorable Office that the Resolution be reconsidered and a criminal complaint for ATTEMPTED MURDER be filed against the Respondents as enumerated in the caption of this motion.

Other measures of relief which are just and equitable under the premises are also prayed for.



Attached for your perusal is a copy of the Fact-finding Investigation Report, together with annexes contained in One (1) folder, of a Team created by this Office to inquire into facts and issues in relation to the above-mentioned subject matter.

The Report raises as the primary matter of concern in subject Sanggunian Resolution, and the accompanying Petition, the non-contested lots in Sitio Tagauayan, Barangay Cocoro. It has been found by the Team that such lots have been declared as public land and property of the State as far back as 1965 by the (then) Court of First Instance in Cuyo, Palawan. As the Petitioners now allegedly possess, occupy, improve and cultivate these lots, they are entitled by such declaration to purchase the same through Agricultural Sales under the provisions of the Public Land Act.

Furthermore, the Team also contends that the Order dated 30 January 2014 of OIC, Regional Executive Director Oscar C. Dominguez approving S.A. No. 2014-01-001 for lots being applied for by Mr. Stimson Salazar should be accorded presumption of regularity.

This Office conforms to the findings and recommendations of the Team in the Report subject to your further appropriate action.


