Buenavista, Marinduque for the benefits of its residents**


Dear Honorable Lormelyn E Claudio:



SUBJECT: LAND OWNERSHIP DISPUTE BETWEEN ATTORNEY ARACELI ADAN-RUBIN AND SOME RESIDENTS AT SITIO SAPINIT, BARANGAY BAGTINGON, BUENAVISTA, MARINDUQUE, REPRESENTED BY MR. FREDERICK MORIAL

On September 28, 2018, during the 84th Regular Session of the Sangguniang Panlalawigan of Marinduque, the Honorable Board Member Reynaldo P. Salvacion delivered a privilege speech regarding the alleged land ownership dispute between Atty. Arceli Adan-Rubin and some residents at Sitio Sapinit, Brgy. Bagtingon, Buenavista, Marinduque, represented by Mr. Frederick Morial. Portion of his privilege speech reads as follows:

"Mr. Presiding Officer, let me render my short privilege speech concerning the community of the Sapinit area that Adan family is trying to claim it, to have a title. Ang report sa akin ng ating kababayan doon sa Sapinit po, dahil ito ay isang komunidad doon na nauna kaysa kina Mr. Adan at gusto pong patituluhan iyong kanyang lugar. Sila po ay lumapit kay kapitan subalit ang ating Kapitan po ay nakasuhan ng Administrative Case. So, ng nagusap-usap po sila doon, ang ginawa lang po ni Kapitan ay winidraw ang kanilang resolution na kini-claim din po nila iyong lupa na iyon. So, naiwan po iyong mga tao, nawalan po sila ng tagapagtanggol at ang gusto po ng family Adan ay ito ay mapasakanila, mapatituluhan sa kanila, because sila daw iyong adjacent lot doon lupa na iyon. Ang sabi ko naman naging adjacent lang po sila doon dahil nabili nila iyong lupa na kinatatayuan po ng Grotto. So, for the purpose and clarification po ay minabuti ko na ito ay idulog dito sa ating kabahayan at maipatawag natin ang concerned people doon, katulad ni Atty. Adan and the family. Maybe Atty. Adan by herself, kasi siya po ang representative ng Adan family and probably the Captain po ng Bagtingon at iyon pong sumulat sa akin dito ay si Mr. Frederick Morial at ganoon din po sulatan din natin si Ms. Imee Diaz. Iyan po ang sulatan natin para po mapagharap-harap natin at mabigyan lang ng linaw naman iyong mga tao doon sa Sapinit at magkaroon ng katahimikan dahil ngayon po sila ang sabi huwag silang magpaparami doon ng bahay dahil iyon daw ay kini-claim nila Mr. Adan. Ako po kasi ay isang witness sa buhay doon sa lupa na iyon, iyong lugar na iyon, doon ako nagu-ula ng kalabaw, alam ko iyong lugar na iyon."

The said issue was referred to the Joint Committee on Rules, Laws and Ordinances and Committee on Barangay Affairs, which called for a Joint Committee Hearing last February 13, 2019. Present during the hearing are the residents of Sitio Sapinit, Mr. Frederick Morial, Kagawad Johnny Francisco, Atty. Araceli Adan-Rubin, the Provincial

Assessor - Engr. Rodrigo Opis, Mr. Simon Diaz of the DENR accompanied by their Legal Consultant Atty. Rommel Fernandez, and Engr. Cesar Montante. The result of is the said hearing is hereby presented to the Sangguniang Panlalawigan, through the Honorable Vice-Governor and Presiding Officer.

Board Member Harold Y. Red, the new chairman of the Committee Chairman of the Committee on Rules, Laws, and Ordinances informed the Body that the matter was actually referred to the then Committee on Rules, Laws, and Ordinances; however, because of the committee re-organization in the Sangguniang Panlalawigan, he became the new Chairman of the committee; hence, he has to absorb the concern and decided to properly address since there are sixty-two (62) families which will be affected by the claim of the Adan Family.

Each of the invited resource speakers were given the chance to air their concerns, opinions, positions, and sentiments on the issue, which are herein presented as follows:

Barangay Kagawad Johnny Francisco

According to Kagawad Johny Fransisco of the Barangay Bagtingon, Buenavista, there are 62 households or about 65 families which are affected by claim of the Adan Family of the said property. He also said that the former Sangguniang Barangay pass a resolution addressed to the Department of Environment and Natural Resources (DENR) claiming the said property in favor of residents of Sitio Sapinit. However, Atty. Adan-Rubin petitioned the said claim and filed an Administrative Case to Kapitan Mario Fransisco. Because of the said cased, the Sangguniang Barangay was forced to withdraw the said resolution.

Kagawad Fransisco further explained that they had a meeting at Sitio Sapinit with the Sangguniang Bayan of Buenavista regarding the said issue. They also requested the Provincial Environment and Natural Resources (PENRO) to certify that the residents currently living in the Sitio Sapinit; however, the former requested them to submit the necessary documents that will support their claim, as well the result of the survey conducted, to their office. He also said that the area was already being considered as a community, and as a matter of fact, they already requested for the Construction of the Dikes and Evacuation Center. They had also passed a resolution requesting of the development of roads; and also, a resolution requesting the Department of Education to have a primary school on the said area.

Mr. Frederick Morial

Mr. Frederick Morial, the representative of Sitio Sapinit residents explained that their elders and relatives had been living in Sitio Sapinit for almost 60 years now and they don't even know if the area is a private or government property. He said that, the Adan family initiated the survey of the land in 2013, and in 2014 they sought the help of the DENR and PENRO regarding the said concern. Accordingly, the PENRO advised them to write a letter to the DENR to seek help, but they waited for some years but got no response from the DENR. Ms. Simeon Diaz admitted that their office received the said letter, but they have no response yet.

According to Mr. Morial, in 2016, they decided to write another letter addressed to the DENR Regional Office in Malate, Manila which was received and endorsed to PENRO Marinduque office. Days after, Mr. Morial went to DENR Marinduque to follow-up if corresponding actions were taken regarding the said request, instead he was advised to proceed at the DENR Regional Office having told that DENR Marinduque have not received any endorsement from the Regional Office.

He further stated that, while they are waiting for the response regarding their request, together with the residents of the said Barangay, they ask assistance of the Sangguniang Barangay of Bagtison. The Sangguniang Barangay extended help and took appropriate actions to reach the DENR. The DENR then advised them to make a petition letter over the claim of the Adan family and the residents involved in the said request should sign the petition together with their Punong Barangay. He also added that he had a meeting with Mr. Sirleon Diaz and regarding to the legitimate rights of Atty. Rubin over the claim of the land property. As residents, they are worried that someday the Adan family were going to take over the land where they are settling for a long time and they want to know what to do to prevent this from happening. He indicated that to settle the dispute over the land property, they asked for a meeting to be conducted with the Sangguniang Barangay with the presence of the Municipal Mayor and Councilors. According to him, the said authorities present in the meeting agreed to pull back the resolution which Punong Barangay Francisco had made over the claim of the said property. Being the petitioner, Mr. Morial saw this agreement as to save only Punong Barnagay Francisco from being charged with Administrative Case that Atty. Rubin would file against him and this will only benefit the said Punog Barangay and not the entire residents affected by the issue.

Attorney Araceli Adan-Rubin

Being the representative of the Adan family, Atty. Araceli Adan-Rubin clarified that the people who lives in the Sitio Sapinit are the grand siblings of their tenants. She also added that there is no delineation over the land property. She also justified that they are the legitimate owner of the land property, which she related that;

"Since the time of the Spaniards sa amin, sa mga Dela Torre na po yan so yung mga pinsan po namin ay nag kasundo, dahil ayaw nila na madisintegrate ang lupa ng Dela Torre na sa mga pinsan na laang ipaubaya ang pamamahala. So, kami ang napili mag patuloy ng dela torre clan na mamahala ng lupain na yoon sa amin binibigay sa amin binibili to preserve the Dela Torre property."

Atty. Rubin stated that instead of communicating with them regarding their claim of property, Punong Barangay Francisco sided with the complainants and further narrated the following statements;

"Ang ginawa nya nagpasa sya ng resolution claiming this property of us, yung accretion ng aming property na aaplayan nila para madistribute sa kanila ako po ay nag oppose doon, dahil po sa mata ng batas under article 57 of the new civil code, it belongs to the owner of the land and titled land po yaan automatic po yung pagmamay ari namin dyan basta sa amin yaan, gusto namin magkaroon ng titulo, magapply kami for the registration, that's why we make the survey because we will had the survey for that."

She also added that filed an Administrative Case against the said Punong Barangay of Grave Misconduct, because of disobeying the local code which is punishable of dismissal from the service.

Further, she stated that, Punong Barangay Francisco apologized and accepted his mistakes in front of the Sangguniang Bayan of Buenavista. He then pulled out the resolution over the claim of the land property. Atty. Rubin added that she sincerely accepts the apology of the said Punong Barangay, but under certain conditions, they should not introduce any building construction near the premises. She also made a compromise agreement between the residents of the Sitio Sapinit signed by their Punong Barangay.

Provincial Assessor's Office

According to Engineer Rodrigo Opis of the Provincial Assessor's Office, he received an invitation last February 11, 2019 from the Sangguniang Panlalawigan wherein he is being invited to attend a Court Hearing regarding the land dispute between Mr. Frederick Morial and Attorney Adan-Rubin on February 13, 2019.

Having no idea about the issue, Engineer Opis instructed his employee to visit the Municipal Assessor's Office in Buenavista. The information gathered was then reported back to Engr. Opis.

Further, Engineer Opis added that, based on their records, the two properties under the name of Fidel Adan with Cadastral Lot Number 932 and 933 along the riverbed has no title of ownership while the property under the name of the Mary Grace Adan-Rubin with the Cadastral Lot Number of 1352 has the title of ownership. Regarding to Mr. Frederick Morial, based on their record they don't have existing tax declaration under their names that's why they can't establish the title of ownership.

Department of Environment and Natural Resources

According to Mr. Simeon Diaz of the Department of Environment and Natural Resources, he wants to clarify the statements given by Mr. Morial regarding the receiving of the documents. As the head of the Land Management Section or Licensing Patten and Deeds Section, the document is addressed to his name, but the document is filed and recorded through the office itself. He also explained about the accretion of the land property of the Adan family, that a part of land gradually received through the effects of the current of the water.

Further, he said that, the Department of Environment and Natural Resources has the jurisdiction for the determination of the preferential rights to apply and own the land property. The residents of Sitio Sapinit wish to have a discussion regarding their problem over the claim of the land property, so the DENR granted their request and conducted a preliminary investigation regarding the problem. But the investigation has ran out due to the withdrawal of the resolution by the Baranggay, and because of this, they officially given the rights of the claimed property to the Adan family and the issue was settled by the said withdrawal of the resolution. He also stated that, the people are still insisting the claim over the property, so he advised them to make another request for another investigation and as of now the status is still on-going.

Attorney Romel Fernandez

According to Atty. Romel Fernandez, consultant of the DENR, he is one of the private lawyers that were hired by the DENR Secretary Roy Cimatu to help the agencies to guide and give advices regarding the legal issues addressed to their agency. He also stated that, he introduced himself as "AMICUS CURIAE" (friend of the court) to share the legal and objective point of view for the guidance of the committee members rather on the part of the respondent as well as the complainants. He first established the primary issue on jurisdiction and his statements are narrated as follows:

"The first and primary issue we should tackle in this particular controversy is the issue of jurisdiction. Number 1, ano po ba at bakit importante po yung jurisdiction? Kasi ho pag kasi ang isang lupa ay gustong angkin ng isang tao sino ho ba at karinong alensya ng gohyerno kayo pupunta? Sino ang may jurisdiction? Assuming po na tiang lupa na pinag usapan ay accretion ito, ano po sa batas yung accretion? Ho ho talaga ay dati hong ilog. Halimbawa ho nga acquire ho yun nag accretion ho, ho kung tatausin ho na ang dating ilog wala hong may pag namay ari nito kundi ang estado. Okay non, bakit ho sya nag karoon ng accretion? Maari ho sa Civil Code nirecognize ho na ang isang ilog umi-itla ng daloy at takbo ng tubig tama? So kung meron pong accretion, meron din pong sina sabing Alluvion Avulsion, ano po ba yun? Nababawasan ho yung private property dahil sa takbo ng tubig dahil sa ilog, kabatigiran naman po ito yung takbo ng tubig, dingdagagan ang isang lupa na according po to Atty. Rubin may companjera ay private property and according to her representation is a titled property. Now the second question, even assuming that she is correct, that she possesses a title to that property adjacent to the property ho na nag karoon po ng accretion kung saan naman ay kinakatawan nila, tanong at legal issue number 1, who has to settle this controversy number 1? It can either be by applying a title dahil wala ho nga title, it can be under the jurisdiction of the DENR and or saday ho ng jurisdiction na yun ay korte."

According to Atty. Fernandez, there are two types of application for titling a land property, its either Administrative Titling which jurisdiction is under the DENR and the Judicial Titling under the Regional Trial Court. The said controversy is directed to the DENR and has the primary jurisdiction over the controversy since the law disallowed forum shopping, requiring only one agency to acquire jurisdiction on certain issue to avoid misconception with the other government agencies.

Further, Atty. Fernandez stated that, the primary issue that we should resolve here is if the property is really titled. The following statements is narrated as follows:

"Is the property really titled? Because according to the presentation of the Provincial Assessor, apparently the title refers to another land which the land is not approximate or adjacent dun sa nagkaroon ng accretion that's the number 1 issue, so kailangan ho itaga na nagkaroon ng relocation survey kung ano ho yung maginging resulta nung mga yun. Both of them can actually apply for a title, now if the DENR has acquired jurisdiction, then the DENR can very well settle who is entitled to the issuance of the title to that particular land na nagkaroon ng accretion, now if they are not satisfied with the disposition of the DENR, they can go all the way to the Court of Appeals and go up to the Supreme Court for final determination and final settlements of the issue. Now if they want to continue to

claim the land is there a need for Baranggay Resolution? No. They can apply the land by their own private capacity, there's no need for a Baranggay Resolution."

Also, he stated that he had such experience in Metro Manila regarding a concept wherein the Government has the program for the landless people called Community Mortgage Program (CMP). This is the program of the government for the landless people requiring any Local Government Unit to appropriately claim the property to distribute to the qualified landless people.

Engineer Montante

According to Engineer Montante, a private licensed Geodetic Engineer, he is being consulted also by Mr. Mortal to help on the situation regarding their problem on the said issue. He stated that, in the time of Cadastral the area is separated when title is being given based on the approved Cadastral Survey. He also added that the residents at Sitio Sapinit had lived there for almost 60 years peacefully and harmoniously. Pertaining to the law, if a certain people live on a government property for several years, the government can award the said area to those people and it is been mandated on the Presidential Decree in the time of President Marcos. He also added that, for almost 60 years of settlements of the people in Sitio Sapinit, they acquired the rights to own the area because it's been mandated by the law.


RECOMMENDATIONS


Based on the foregoing discussion, the Joint Committee hereby **RECOMMENDS** the following:

2. To request the Provincial Assessor's Office and the DENR to conduct a relocation survey to determine if the land property is indeed a property of the Adan family or a public property.
