
On March 2, 2023 this Office has received an email from a concerned citizen requesting to rescue the three ( 3 ) baby monkeys that are allegedly chained under the custody of a certain Erlinda C. Cabagsang.

The undersigned immediately coordinated with the PCSD personnel for possible assistance. On the same day, the undersigned together with some representatives from the latter office proceeded at the residence of Mrs. Cabagsang located at Barangay Poblacion 5, Coron, Palawan. Upon arrival in the area, the team confirmed the validity of the information, the team immediately unchained the monkeys and removed it from the cage.

As per information gathered by the team the said monkeys were captured in the wild and sold to Mrs. Erlinda C. Cabagsang. The team apprehended the animals and turn it over to PCSD thru a Turn-Over Receipt. The said monkeys will be released back to their habitat.
