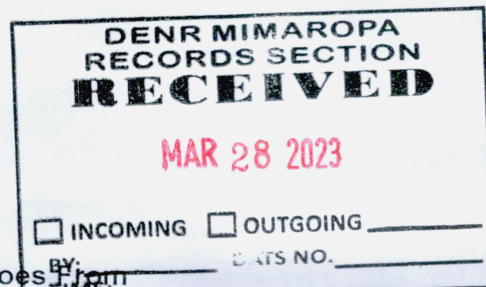

**Subject: Notice of Transfer of Dump Trucks and Backhoes
Mine Site to Bato Port With Request to Supervise**

Dear RED Claudio:

Further to our letter dated March 1, 2023 anent the subject transfer of dump trucks, backhoes and other miscellaneous equipment owned by ALTAI MINING PHILIPPINES, INC. (the "APMC") copy of which was furnished to your office on 03 March 2023, please be informed that APMC shall proceed with the said activity any date from 28 March 2023 to 02 April 2023.

In connection with the above, APMC formally requests your good office to send a representative who shall supervise the actual transfer of dump trucks, backhoes and other miscellaneous equipment on the above-mentioned date in order to ensure peace and order at the area taking into consideration that some anti-mining residents of Barangay España have been barricading thereat with clear intention to prevent the safe passage of APMC's equipment from the mine site to the port based on wrong information being fed to them by their supporters, instigators and agitators that such activity constitute an "operation". Their apparent disregard to the rule of law and disrespect to APMC's property rights should no longer be countenanced. APMC reiterates that such intended activity is for no other purpose than to protect and preserve its properties against possible damage that may be caused by anti-mining residents and other disgruntled groups that oppose APMC's activities. It may be of great help if the representative from your office can also enlighten them as to the nature and purpose of this activity as it relates to the pending Motion For Reconsideration that APMC filed with respect to the Joint Order dated February 6, 2023 that was issued by the Regional Offices of the DENR, EMB and MGB. We trust that you will give due consideration to this request.
