WHEREAS, under Municipal Resolution No. 2020-018, this local government requested the National Mapping and Resource Information Authority (NAMRIA) for a copy of the political map (with Technical Description) of the Municipality of Dr. Jose P. Rizal, Palawan and its component barangays to serve as reference in the amicable settlement of barangay boundary disputes, which was subsequently complied with thru the Land Management Bureau (LMB), but sans the corresponding technical description;

WHEREAS, Section 118(a) of the Local Government Code of 1991 provides that boundary disputes involving two (2) or more barangays in the same  $x \times x$  municipality shall be referred for settlement to the sangguniang  $x \times x$  bayan;

WHEREAS, in the same light, boundary disputes involving two (2) or more municipalities within the same province shall be referred for settlement to the sangguniang panlalawigan concerned;

WHEREAS, in the absence of the technical description, relocation surveys for the determination of the exact pollical boundaries between the municipality's component barangays and with the adjacent municipalities would not be feasible, thus any decision of the Sangguniang Bayan relative to the disposition barangay boundary disputes may bear legal impediment;

NOW, THEREFORE, on motion of Hon. Jalil J. Insani unanimously seconded, be it

RESOLVED, as it is hereby resolved, to request as it is hereby respectfully requested, the Land Management Bureau (LMB) to provide copies of the technical description of the political boundaries of the municipality and its component barangays;

RESOLVED, FURTHER, that the DENR-Land Management Bureau, Municipal Planning and Development Office, Municipal Assessor's Office, Liga ng mga Barangay and all others concerned be furnished with copies of this resolution for their information and appropriate action.
