Please be informed that the activities for step 1-7 of the mainstreaming phase of ICM for the Municipality of Narra, Palawan were conducted on August- November CY 2022. For the continuation of the activities under the mainstreaming phase, the undersigned together with OIC CENRO Renato S. Gonzaga of CENRO Quezon and his staff, attended and participated as resource speaker during the conduct of public hearing for the proposed Comprehensive Land Use Plan (CLUP) of the Municipality of Narra.

Prior to the conduct of the said public hearing, the Sangguniang Bayan of Narra invited the members of the Technical Working Group (TWG) including the undersigned and representative from CENRO Quezon for a briefing on the public hearing.

The public hearing for the proposed Comprehensive Land Use Plan (CLUP) of the Municipality of Narra was conducted on February 1-3, 2023 in five (5) locations namely: Barangay Sandoval, Narra, Palawan for Cluster 1 (Barangays Sandoval, Dumagueña, Tinagong Dagat, Bagong Sikat and Estrella Village), Barangay Antipuluan, Narra, Palawan for Cluster 2 (Barangays Antipuluan, Elvita, Taritien, Malatgao and Panacan II), Barangay Aramaywan, Narra, Palawan for Cluster III (Barangays Aramaywan, Calategas, Tacras, Burirao and Ipilan), Barangay Princess Urduja, Narra, Palawan for Cluster IV (Barangays Princess Urduja, Batangbatang, Caguisan, Teresa and Bata-bato), and Barangay Poblacion, Narra, Palawan for Cluster V (Barangays Poblacion, Malinao and Panacan I).

During the public hearing, among the issues/concerns raised were the land classification of the area within the Proclamation 190, school sites within the unclassified public forest (UPF), the jurisdiction of Arena Island, unvalidated Certificate of Stewardship Contract (CSC) area, presence of quarry area adjacent to school sites and conversion of agricultural landuse to residential and commercial use.

Attached is the copy of the attendance sheet of the 3-day public hearing and the photo documentation of the said activity.

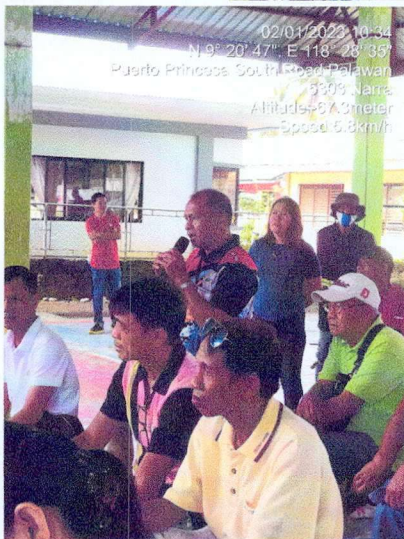
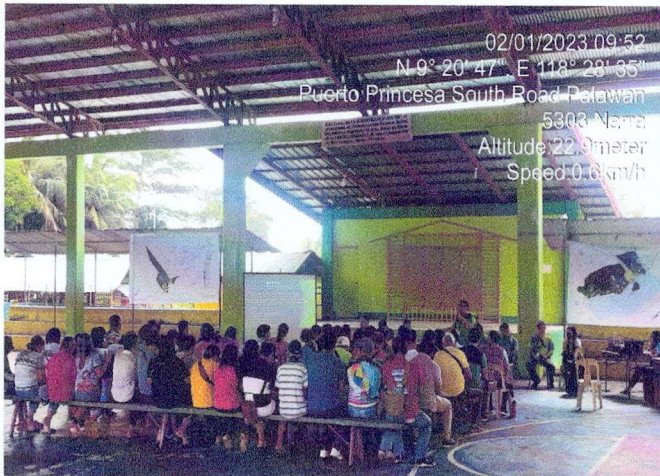

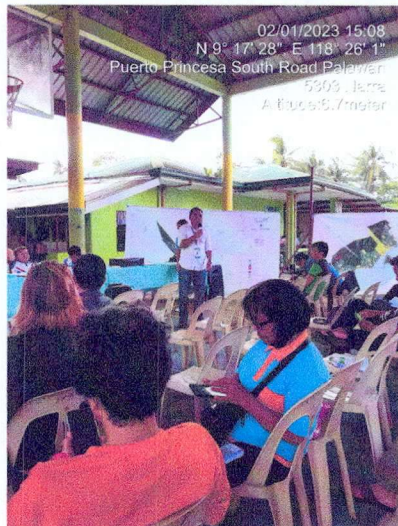

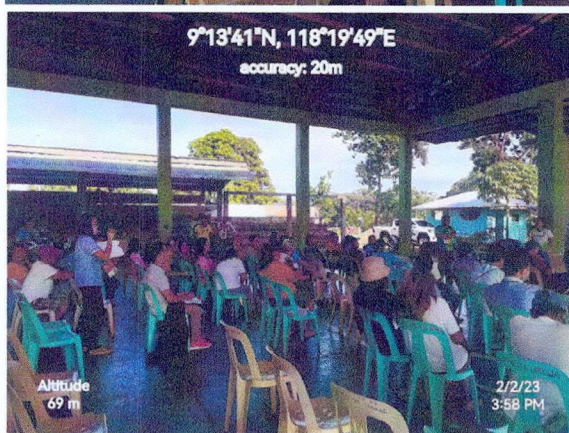
