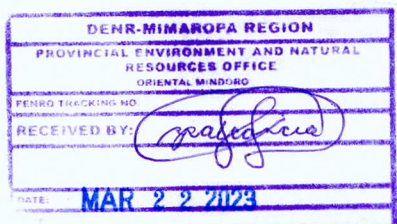

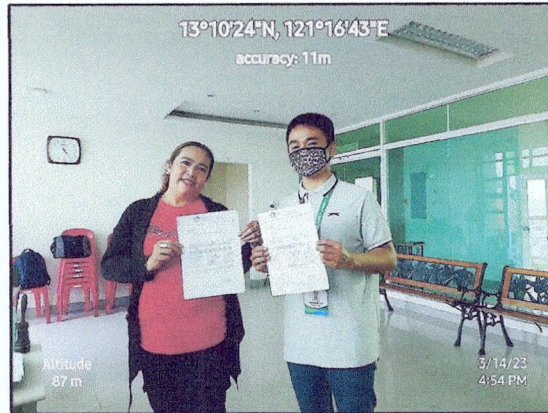


Figure 1. Coordination at Mayor's Office and distribution of communication letter regarding the target and request for electronic copy and shapefiles of CLUP.

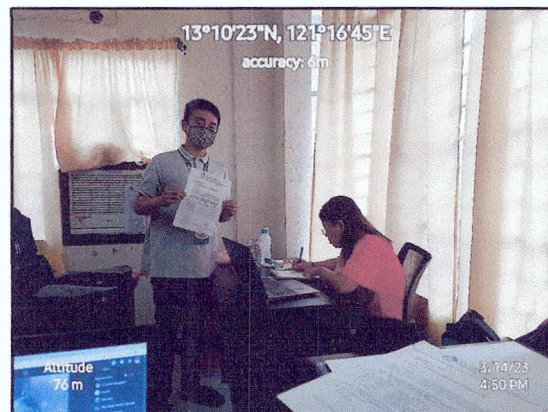


Figure 3. Coordination at MENRO and distribution of communication letter regarding the target and request for electronic copy and shapefiles of CLUP.




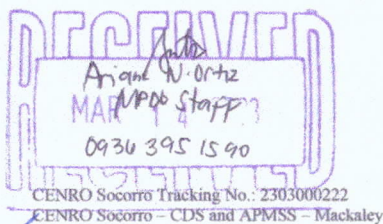
