Respectfully informing your Office that the request for relocation survey of Mr. Ninoy Defino is for a certain parcel of land located at Sitio Tipulo, Brgy. Poblacion, Santa Fe, Romblon which is identified as Lot 495 Cad 548-D Sta. Fe Cadastre with Patent No. (NRDIV-21)-010321 dated November 24, 1984.

With respect to the property at Sitio Hinulugan, Brgy. Poblacion, San Jose, Romblon which Mr. Defino identifies as Lot 530-H in his petition letter dated January 29, 2023, an ocular inspection was conducted in the vicinity, however, the Family of Condes have not resided in the area nor the community has identified their residency or property. Consequently, the Municipal Assessor of San Jose, Romblon issued a certification which states:

"per record on file of this office, JULIAN CONDES, has no record of Real Property declared in his name as of this date in the Municipality of San Jose, Romblon, Philippines."

Further, based on our record there is an annotated petition filed by the Hrs. of Esteban Saligumba dated November 12, 2007 against any further action on Lot 530. A letter by this office dated February 6, 2023 was addressed to Mr. Defino informing him of the inspection.
