Respectfully forwarded the memorandum dated February 21, 2023 from the Investigating Team in relation to PENRO Special Order No. 2023-016 series of 2023 issued on February 1, 2023 with a subject "Creation of investigating team to the complaint against Coron Watershed Beneficiaries Association-Community-Based Forest Management (CWBA-CBFM) in CENRO Coron, Palawan for alleged condoning of illegal forest activities."

Per memorandum, the Investigating Team conducted the validation and investigation on February 17 to 20, 2023 at the CBFM area of Coron Watershed Beneficiaries Association (CWBA) Agro-Forestry Multi-Purpose Cooperative (AMPC) at Barangay San Nicolas, Coron, Palawan. The result of investigation disclosed that pieces of evidence had been gathered including all the required information collected during interviews which manifested and will serve as proof that the complaint is purely malicious in nature and nasty allegations. Therefore, the team recommended the following:

1. The investigating team recommended that series of activities will be conducted for the resolution of the stated boundary conflict between CBFM area and private lots with land titles within Unclassified Public Forest (UPF) surrounded in the CBFM jurisdiction; and
2. The Officers and Members of the CBFM CWBA Agro-Forestry Multi-Purpose Cooperative in partnership of the CENRO Coron need to continue their good deeds for the conservation and protection of the CBFM area and to the environment as a whole.

Further, Mrs. Violeta Mosquera Abaca requested to the investigating team to make research who made the unsigned complaint through email in order to give justice in her name. Likewise, the Chairperson of the CBFM PO Mrs. Consuelo T. Magallanes also requested the team if who made the email and to determine the personality beyond the said email complaint that really besmirched and/or destroyed them.

I. SUBJECT:

COMPLAINT AGAINST CORON WATERSHED BENEFICIARIES ASSOCIATION (CWBA) AGRO-FORESTRY MULTI-PURPOSE COOPERATIVE (AMPC) – COMMUNITY-BASED FOREST MANAGEMENT (CBFM) [CWBA AMPC-CBFM] IN CENRO CORON, PALAWAN FOR ALLEGED CONDONING OF ILLEGAL FOREST ACTIVITIES [E-2023-101414]

II. FACTS OF THE CASE/BACKGROUND:

This case stemmed from the electronic mail dated November 11, 2022 (Friday) more or less 8:00 in the morning from unsigned name Violeta Mosquera Abaca, a Leader of Katutubong Pamayanang Tagbanua ng San Nicolas (KPTSN). The complainant used the email address of violetaabaca81@gmail.com addressed to Office of the Secretary of DENR with email address of osec@denr.gov.ph

Further, the team conducted coordination to the complainant and the complained party the Coron Watershed Beneficiaries Association (CWBA) Agro-Forestry Multi-Purpose Cooperative (AFMPC) – Community-Based Forest Management (CBFM) [CWBA AFMPC-CBFM] located in CENRO Coron, Palawan for the alleged condoning of illegal forest activities. Likewise, coordination and gathering of required information to other involved individuals relative to this case. *(Please refer to attendance sheet as Annex "B")*

V. CHRONOLOGY OF EVENTS RELATIVE TO THE ABOVE-CITED SUBJECT PRIOR TO THE CONDUCT OF FIELD INVESTIGATION

1. The above-quoted complaint dated November 11, 2022 was emanated from Violita Mosquera Abaca, bearing no signature via email addressed to the Office of the Secretary of DENR;
2. That Augusto D. Dela Peña, Undersecretary and Officer-In-Charge, Chief of Staff, sent a letter to Ms. Violeta Mosquera Abaca acknowledging and referring the said complaint to the Undersecretary for Field Operations – Luzon, Visayas and Environment for appropriate action; *(Please refer to the letter to Ms. Violeta Mosquera Abaca as Annex "C")*
3. That on January 05, 2023 Augusto D. Dela Peña, Undersecretary and Chief of Staff forwarded the issue through memorandum for the Undersecretary for Field Operations – Luzon, Visayas and Environment for appropriate action; *(Please refer to Memorandum dated January 05, 2023 as Annex "D")*
4. That on January 13, 2023 Atty. Juan Miguel T. Cuna, CESO I forwarded the issue through memorandum to the Regional Executive Director of DENR MIMAROPA Region for compliant verification and further action; *(Please refer to Memorandum dated January 13, 2023 as Annex "E")*

5. That on January 24, 2023 Maximo C. Landrito, the OIC ARD for Technical Services referred the concern through memorandum to the Provincial Environment and Natural Resources Officer of Palawan directing to conduct investigation to the said illegal activities allegedly perpetrated by CWBA CBFM Officials/Members in coordination with the complainant and Barangay Officials of San Nicolas, Coron, Palawan. Further, requiring to submit report with categorical recommendation/s including pertinent documents within seven (7) days upon receipt to serve as basis for further action by the Regional Office; *(Please refer to Memorandum dated January 13, 2023 as Annex "F")*
6. That on February 1, 2023 PENRO Felizardo B. Cayatoc issued PENRO Special Order No. 2023-016 series of 2023 with a subject "Creation of investigating team to the complaint against Coron Watershed Beneficiaries Association-Community-Based Forest Management (CWBA-CBFM) in CENRO Coron, Palawan for alleged condoning of illegal forest activities"; *(Please refer to PENRO Special Order No. 2023-016 series of 2023 as Annex "G")*
7. That on the same day February 1, 2023 PENRO Felizardo B. Cayatoc sent a memorandum for the Regional Executive Director of DENR MIMAROPA Region requesting for time extension for the submission of report with categorical recommendation/s from February 7, 2023 to be submitted on February 23, 2023 due to the reason that the investigating team have prior equally important fieldworks conducted. The investigation was conducted on February 16 to 21, 2023; *(Please refer to Memorandum dated February 1, 2023 as Annex "H")*

VI. ACCOMPLISHMENTS DURING INVESTIGATION AND VERIFICATION

1. The investigating team properly coordinated with OIC Development Management Officer IV Edwin I. Cac, In-Charge, Office of the CENRO of Coron Palawan on February 16 and 17, 2023. Likewise, coordinated to all concerned personnel for the conducted investigation of CENRO Coron, Palawan;
2. The investigating team properly coordinated with the Barangay Officials of San Nicolas, Coron, Palawan on February 17 and 18, 2023. Further, coordinated to the complainant and the complained party including all the identified individuals during the conduct of investigation;
3. The Officers and members of Coron Watershed Beneficiaries Association Agro-Forestry Multi-Purpose Cooperative of Community-Based Forest Management in Barangay San Nicolas, Coron, Palawan presented their Cooperative's documents, such as:
 - 3.1. List of Officers; *(Please refer to List of Officers as Annex "I")*
 - 3.2. List of Active and In-Active Members; *(Please refer to List of Active and In-Active Members as Annex "J")*

4. The team investigated the complaint of Violeta Mosquera Abaca on February 17, 2023 at Barangay San Nicolas, Coron, Palawan. Mrs. Violeta Mosquera Abaca mentioned that she is the Chairperson of Katutubong Pamayanang Tagbanua ng San Nicolas (KPTSN) and strongly denied the veracity and truthfulness stated in the unsigned complaint. She (Abaca) does not use computer and sent an email complaint to the Office of DENR Secretary because she does not know how to operate/use the computer. *(Please refer to the Malaya at Kusang-Loob na Salaysay ni Violeta Mosquera Abaca as Annex "M")* Instead, Mrs. Abaca alleged Ex-Barangay Captain of San Nicolas Joel Reyes Moreño as the one who made the said complaint due to their cancelled business transactions. On the contrary, on February 18, 2023 Former Barangay Captain of San Nicolas Hon. Joel Reyes Moreño issued "Panayam Tungkol sa Pagpapatakbo ng CBFM kay Former Punong Barangay Joel R. Moreño 2010-2018" signifying all out support to the activities of the CBFM People's Organization. *(Please refer to the Panayam Tungkol sa Pagpapatakbo ng CBFM kay Former Punong Barangay Joel R. Moreño 2010-2018 as Annex "N")* Finally, Mrs. Abaca requested the team to make a research who made the unsigned complaint through email in order to give justice in her name;
5. In support to the investigation process, the team able to facilitate the issuance of Malaya at Kusang-Loob na Salaysay ni Mohammed Canuto G. Soniega, Vice Chairperson of Coron Watershed Beneficiaries Association Agro-Forestry Multi-Purpose Cooperative. *(Please refer to the Malaya at Kusang-Loob na Salaysay ni Mohammed Canuto G. Soniega as Annex "O")* Vice Chairperson Soniega supported the denial as alleged in the unsigned complaint. As such, he pointed certain Mr. Jaypee L. Pascual and Ex-Barangay Captain of San Nicolas Joel Reyes Moreño as the main personalities who made the email complaint as they also considered as regularly criticized the PO's water system project. Of which, Mr. Pascual issued "Concern and Issues with CWBA Waterworks" on February 18, 2023. *(Please refer to the Concern and Issues with CWBA Waterworks as Annex "P")* stating issues and concerns about the PO's water system project only and no other issues raised that are mentioned in the unsigned complaint;
6. Project Manager Ramil F. Malto of CBFM-Agro-Forestry Multi-Purpose Cooperative also prepared his Malaya at Kusang-Loob na Salaysay. *(Please refer to the Malaya at Kusang-Loob na Salaysay ni Ramil F. Malto as Annex "Q")* Mr. Malto opposes the allegations stated in the complaint except the cutting of trees made by their organization. The trees involved in the said permitted cutting were planted trees or Mangium trees that had been used in the replacement of three (3) wooden bridges at Sitios Bantad, Pinamaratan and Tabok, San Nicolas, Coron, Palawan that had been destroyed by the onslaught of typhoon Odette last December 17, 2021 *(Please refer to the Certification dated February 17, 2023 issued by Incumbent Punong Barangay Jerson L. Elbat of Barangay San Nicolas as Annex "R")* and *(Please refer to the Geotagged Photos as Annex "S", "T" and "U")* respectively;
7. On February 19, 2023, CBFM PO Chairperson Consuelo T. Magallanes of Purok 1, Barangay San Nicolas, Coron, Palawan issued her Malaya at Kusang-Loob na Salaysay denying all the allegations except the permitted cutting of Mangium trees. No forest trees cut in the forested area within the AOR of CBFM CWBA Agro-Forestry Multi-Purpose Cooperative. *(Please refer to the Malaya at Kusang-Loob na Salaysay ni Consuelo T. Magallanes as Annex "V")* All the allegations in the unsigned complaint are not true. In fact, Punong Barangay Jerson L. Elbat of Barangay San Nicolas, Coron, Palawan issued a Certification on February 17, 2023 stating that no illegal environmental activities being committed or existed by the members, officers of the CBFM PO and to their area of jurisdiction.

VII. ISSUES/CONCERNS

The investigating team with full participation of the concerned individuals noted that the allegations in the unsigned complaints are not true. Pieces of evidence that have been presented herein including information gathered during interviews are proofs that the complaint is purely malicious in nature and unwarranted allegations.

In some instances, the investigating team found that may be the complaint is the result of boundary conflicts between the CBFM area and to all the concerned individuals occupied in the nearby private lots like spouses Henry and Juanita Bernel and Jesus Vicente Fernandez. As such, an exit conference had been conducted on February 20, 2023 at more or less 1:00 in the afternoon and religiously discussed the conflicting issues on boundary disputes. There are follow up activities pertaining to the said boundary conflict to be conducted soon by the personnel of CENRO Coron. *(Please refer to the Letter Request of Chairperson Consuelo T. Magallanes and Attendance Sheet as Annex "Z" and "AA")* respectively.

VIII. OTHER ACCOMPLISHMENTS

1. The investigating team able to gather the opinion and views of SEMS/Asst. CENRO (DMO IV) Edwin I. Cac and OIC CENRO Rodney G. Verian pertaining to the letter request dated January 30, 2023 of Municipal Mayor of Coron, Palawan addressed to our DENR Secretary Ma. Antonia Yulo-Loyzaga appealing for humanitarian consideration, to consider the previous decision to lift the suspension order and to allow the Municipal Government of Coron, Palawan to push through the construction of permanent and new Coron Public Market located at Barangay Poblacion 6, Coron, Palawan. According to them, since the letter was already sent to the Secretary, they will wait for the instructions from DENR higher authorities and make no comment to the said letter request; and
2. The team also discussed to the Monitoring and Enforcement Personnel of CENRO Coron on February 20, 2023 more or less 2:30 P.M. relative to the issues and concerns about the implementation of environmental laws, documentation process, time and necessary legal documents for the submission of required targets and reports stipulated in the Work and Financial Plan for CY 2023. *(Please refer to the Documents Discussed and Attendance Sheet as Annex "BB" and "CC")* respectively.

IX. RECOMMENDATION


1. The investigating team recommended that series of activities will be conducted for the resolution of the stated boundary conflict between CBFM area and private lots with land titles within Unclassified Public Forest (UPF) surrounded in the CBFM jurisdiction; and
2. The Officers and Members of the CBFM CWBA Agro-Forestry Multi-Purpose Cooperative in partnership of the CENRO Coron need to continue their good deeds for the conservation and protection of the CBFM area and to the environment as a whole.






Introduction

The CWBA-AMPC wishes to express and extend to the management of the Forest Foundation Philippines our sincere appreciation for extending financial support to the organization. By extending the financial support, the treat for illegal settlers within the CBFM area is now being nullify. The perimeter fencing has been established to determine the exact area of the CBFM and the stakeholders started to become aware of the area. To the DENR personnel's who patiently guide us during the formulation and development of the Community Resource Management Framework (CRMF) and in the conduct of boundary delineation.

The CWBA-AMPC aims to protect, manage and develop the CBFM area with strong and organized organization and improve the living condition of the members through proper use and sustainable livelihood management strategies. With this, the organization is now ready for the full implementation of conservation and protection aspects since it has been identified and demarcated.

Highlights of the Report

The final report covers the activities that has been undertaken and conducted during the period based on the agreed Grant Agreement by both parties signed on October 26, 2019.

A. Ground Delineation Survey

The ground delineation survey was administered by technical personnel of DENR CENRO, Coron, Palawan by virtue of CENRO Special Order No. 033 on November 06, 2018 led by the CBFM Desk Officer and being assisted by members of the cooperative.

Several meetings were conducted and strategies were implemented due to late implementation of the identified activities. During the meeting, the objectives had been discussed and elaborated to the Team to determine: a) Ground Delineation of CBFM Area, b) Map-out of the existing river for water source, and c) To update the Community Resource Management Framework (CRMF).

To rationalize the implementation of ground delineation survey, the group had created a Team to implement the activity. Three (3) groups were formulated to conduct the ground delineation. The **Team A** was created for Barangay San Nicolas, **Team B** for Barangay Borac, and the **Team C** for Barangay Guadalupe and Barangay 6, Coron, Palawan.

The ground delineation survey was started only on the last week of January 2019 and immediately ends also on the first week of February 2019. The delayed implementation of the activity was caused by the other tasks and responsibilities of the leading Team in the office. However, despite of the uncontrolled situations on ground delineation survey, the activity was successfully accomplished and the exact boundaries are also established and demarcated.

The CBFM area was determined having an area of 2,115 hectares and could be found within the four (4) Barangays of Barangay San Nicolas, Barangay Poblacion 6, Barangay Guadalupe and Borac all are within the municipality of Coron, Palawan.

The installation of concrete monument was temporary installed within the identified boundaries. It was initiated by the organization as their counterpart using the concrete PVC. Installation of temporary monument has been implemented since the Banana, Mangkono and Kakawati as planting materials for permanent marked at that time are not available.

B. Map-out of the existing river for water source

During the conduct of delineation survey, identification of existing potential rivers was also identified and marked out. The identified water source has been considered as priority sites for protection and conservation area. The Water Refilling Station of the Cooperative is now operated and directly supplying the residents of Barangay San Nicolas and the other nearby Barangay's and the area has been considered as additional potential source of water in the future.

C. Nursery operation and plantation establishment

The nursery operation and other activities was also implemented particularly in potting of kakawati and the other planting materials used for permanent markings. The out-planting activities for Banaba, Mangkono and Kakawati seedlings along the identified boundaries were also conducted only during onset of the rainy season within the identified boundaries to attain the highest percentage of survival rate.

D. Updating of Community Based Resource Management Framework

The updating of Community Resource Management Framework (CRMF) of the Cooperative has been facilitated by the technical personnel from DENR and actively participated by the concerned Barangay and other stakeholders. Series of meetings has been implemented to gather relevant information in the area.

CBFM Vision : Protect, manage and develop the CBFMA with a strong and organized organization and improve the living condition of CBFM members through sustainable livelihood.

CBFM Mission : To protect and develop the 2, 115 hectares and to be a strong organization with sustainable livelihood.

Goals :

1. To promote sustainable protection of our Forest Land and Resources
2. To increase number of members and good examples from others.
3. To strengthen the linkages with other entities that could provide assistance.
4. To improve living condition of the members.

Objectives :

1. To develop, maintain and protect the forest resources within CBFM area.

The members of the CBFM are residing adjacent to the CBFM area. Only of seven households are within the CBFM area and now cultivating portion of the CBFM area. Most of the members are Cuyono and Cuyunin is the local dialect widely used in the community. The other members are Tagalog and Cagayanen.

The level of education attained by the CBFM members are High School, some are College but few of them graduated in College.

The average income earned by each family is below Php 92,000 per annum which obtained from farming activities like vegetable farming, poultry, and hog raising. The major agricultural products produced by the members are banana, cassava, pineapple and cashew.

The land cover of the CBFM based on 2015 land cover map from the NAMRIA, the area has open forest, shrubs, grassland and annual crop and built up area.

E. Procurement of office Supplies and Materials

The office equipment and supplies was already purchased and now being used by the Cooperative during the conduct of the whole activity. The supplies and materials has been utilized during the preparation of the required reports.

F. Conservation initiatives

The People's Organization (PO) was hired local laborers who are conducting the foot patrol within the periphery of the CBFM and within the established NGP plantations. The activity has been implemented to prevent the occurrence of unwanted forest fires due to dry and hot weather condition experienced brought by El Niño. Likewise, fire brigade volunteer was being organized to man in the area once the grass fire/forest fire has been occurred.

The Information Education and Communication (IEC) Campaign have been conducted at Barangay San Nicolas, Coron, Palawan led by the NGP Team to remind the stakeholders on Fire Prevention due to extreme hot and dry condition experienced in the area.

Since rainy season has been experienced the CWBA-AMPC participated during the conduct of Tree Planting activities to support environmental protection and conservation aspects as initiated by different organizations.





I am Jaypee L. Pascual of San Nicolas, Coron, Palawan. Filed an Inquiry with the National ^{Water} Resources Board againsts operation of CWBA Waterworks due to their unjust and unfair services.

1. CWBA Waterworks operates for over ten years with no improvement in their services. There is no reservoir tank, no filtration or treatment facilities.
2. Despite having three sources of water, consumers are experiencing daily water supply outages during summer season. This problem occurs every year and no solution has been developed to address it. Furthermore, during rainy season, they distribute even muddy water, despite the fact that is not usable.
3. CWBA Waterworks endangers the health and safety of its customers by distributing water that has not been treated or filtered.
4. CWBA Waterworks implements water tariff rates that have not been approved by the national Water Resources Board.
5. CWBA Waterworks does not have a Certificate of Public Convenience and other permits from other government agencies.


