
Respectfully forwarded is the memorandum of CENRO Quezon, Palawan dated February 9, 2023, relative to the above-cited subject.

Per memorandum, the apprehension was made on November 20, 2022, at around 06:00 P.M. by the PNP-MG led by PEMS Richard P. Rodriguez, PNCOIC conducted an anti-illegal logging operation that led to the successful apprehension of a certain Rhoan G. Pahayahay who is caught in the actual possession of undocumented Apitong lumbers having a total volume of 264 board feet.

Due to lack of permit presented by the respondent, the apprehending team declared apprehension, and the apprehended item was deposited at Barangay Aramaywan, Quezon, Palawan for temporary custody of kagawad Reynald G. Gimotea. The apprehended item has an estimated fair market value of Php13,200.00 for the twelve (12) pieces of Apitong lumbers. One (1) Notice of Hearing dated December 1, 2022 was sent to the concerned parties for December 16, 2022, scheduled hearing in relation to Section 07 of DAO 1997-32.

We concur with CENRO recommendation for the forfeiture of the apprehended Apitong lumbers in favor of the government and the institution of the appropriate legal sanction against the offender in the proper court.





**SUBJECT** : **MINUTES OF ADMINISTRATIVE HEARING ON THE APPREHENSION AND SEIZURE OF 12 PIECES APITONG LUMBERS WITH A TOTAL VOLUME OF 264 BOARD FEET AT SITIO LUBGOB, BRGY. ARAMAYWAN, QUEZON, PALAWAN**



Submitted herewith the minutes of the Administrative Confiscation Proceedings together with pertinent documents anent the above-cited subject treated under DAO 97-32. The hearing was conducted on December 16, 2022 at DENR-CENRO Quezon, Palawan.

Please be informed that prior to the conduct of hearing, a notice of hearing was given to the respondent informing him that he has a privilege to exercise his right to hire a legal counsel of his own choice pursuant to the provisions of the New Constitution. However, despite the considerable period of time since the notice of hearing was served, this office did not received any notice or motion from the respondent to re-schedule the hearing due to non-hiring of lawyer.

Further informed that during the scheduled date of hearing, the respondent asserted to proceed the hearing even without the assistance of his own legal counsel.

**I. FACTS OF THE CASE:**

**WHAT:** Apprehension and seizure of 12 pieces of undocumented Apitong lumbers having a total volume of 264 board feet.

**WHEN:** On or about 6:00 PM of November 20, 2022

**WHERE:** Sitio Lubgob, Brgy. Aramaywan, Quezon, Palawan

**WHO:** Mr. Rhoan Gonzaga Pahayahay, resident of Brgy Aramaywan, Quezon, Palawan.

**HOW:** On or about 6:00 PM of December 16, 2022, the PNP-MG led by PEMS Richard P. Rodriguez, PNCOIC conducted an anti-illegal logging operation that led to successful apprehension of a certain Rhoan G. Pahayahay who is

caught in the actual possession of undocumented Apitong lumbers having a total volume of 264 board feet.

Due to lack of permit presented by the respondent, the apprehending team declared apprehension. The apprehended items were deposited at Barangay Aramaywan, Quezon, Palawan.

## **II. PRESENTATION OF PARTIES CONCERNED (*Apprehending Officers and Respondents*):**

1. During the hearing, the apprehending officers were not present but they were able to submit their “Malayang Sinumpaang Salaysay”. Based on the malayang sinumpaang salaysay of PMSg Ronil A. Dago and PSSg Willard M. Coyoca, on or about 3:00 PM of November 20, 2022, the PNP-2<sup>nd</sup> SOU-MG has received an information from a concerned citizen about the on-going illegal logging operation in Brgy. Aramaywan, Quezon, Palawan. In response, on or about 4:00 PM on that day, they immediately dispatched a team to respond the said information.

Upon arriving at Sitio Lubgob, Brgy, Aramaywan, Quezon, the team has noticed a cart loaded with lumbers being towed by a carabao. They immediately approached the person (respondent) guiding the carabao and ordered him to stop and subsequently identified their team as members of PNP-MG. In the course of field verification/investigation, the respondent failed to present any legal documents for the possession and transport of lumbers.

Due to lack of permit presented, on or about 6:00 Pm of the same day, the team declared arrest and apprehension and they informed the respondent of his violation of Section 77 of PD 705 and subsequently informed his rights under the Miranda Doctrine.

The arrested person was brought to the PNP-2<sup>nd</sup> SOU-MG station for further investigation and documentation while the apprehended lumbers were deposited at Brgy Aramaywan, Quezon, Palawan.

2. In the same hearing, Mr. Rhoan G Pahayahay acknowledged that he is the one being apprehended/arrested by the PNP-MG in possession and control of the undocumented Apitong lumbers having a total volume of 264 board feet. Mr. Pahayahay explained that he is not the actual owner of the lumbers and insisted he was just hired to haul the lumbers with corresponding hauling fee in the amount of Php 5.00 per board feet. When Mr. Pahayahay was asked to name the owner, however, Mr. Pahayahay could not tell the name of the owner who allegedly hired him.

## **III. APPLICABLE LAWS AND POLICIES:**

1. *Section 77 of PD 705 as amended or Revised Forestry Code of the Philippines “ Cutting, Gathering and/or collecting Timber or other Forest Products Without License- any person who shall cut, gather, collect, remove timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties*

*imposed under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code; Provided, that in the case of partnerships, associations, or corporations, the officers who ordered the cutting, gathering, collection or possession shall be liable, and if such officers are aliens, they shall, in addition to the penalty, be deported without further proceedings on the part of the Commission on Immigration and Deportation.*

2. Department Administrative Order No. 97-32 dated 1997 Rules for the Administrative Adjudication of Illegal Forest Products and the Machinery, Equipment, Tools and Conveyances used in the commission of crimes.

#### **IV. FINDINGS/EVALUATION**

1. The possession of 12 pieces of Apitong lumbers having a total volume of 264 board feet is not covered by appropriate DENR documents/permit, hence a patent violation of Section 77 of PD 705 as further amended;
2. In view of the above findings and facts presented, it was found that there were sufficient and convincing evidences to support the finding of probable cause to charge **Mr. Rhoan Gonzaga Phayahay** for violation of Section 77 of PD 705 as further amended by E.O. 277 and R.A. 7161.

#### **V. RECOMMENDATION**

1. In view of the above findings and evaluation, it is recommended that the 12 pieces of Apitong lumbers having a total volume of 264 board feet be confiscated in favor of the government in addition to the filing of case against the above –mentioned offender for violation of Section 77 of PD 705 as further amended by E.O. 277.

Aramaywan at pinaniniwlaang ito’y walang kaukulang dokumento o papeles na galing sa kinauukulan o anumang ahensya ng ating Gobyerno ang DENR o PCSD. Dahil dito bumuo ng grupo ang PNP-Maritime upang tugonan ang nasabing impormasyon at noong 5:30 ng hapon y nakarating na ang Maritime group sa nasabing lugar, habang binabaybay ng tropa ang lubak-lubak na daan na sakop ng Bgy. Aramaywan ay napansin nila ang isang kariton na hila-hila ng kalabaw na may kargang mga mga putol na kahoy, agad nila itong pinahinto dahil tugma ito sa sumbong na natanggap nila na impormasyon at agad naman silang nagpakilala na sila ay nagmula sa 2<sup>nd</sup> SOU PNP MARITIME GROUP QUEZON SBU, na naka base sa Sitio Bliss, Bgy. Respectfully submitted is the report on the actual scaling / evaluation of lumber apprehended by the PNP Maritime Group on November 20, 2022 at Sitio Lubgob, Barangay Aramaywan, Quezon, Palawan.
