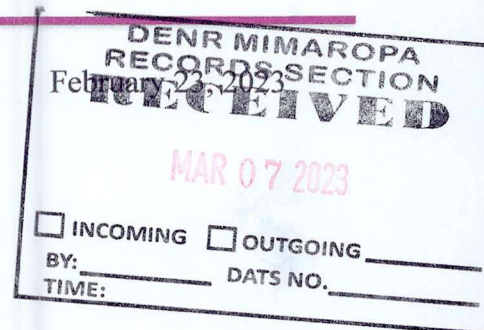

SALEINTS POINT OF DISCUSSION:





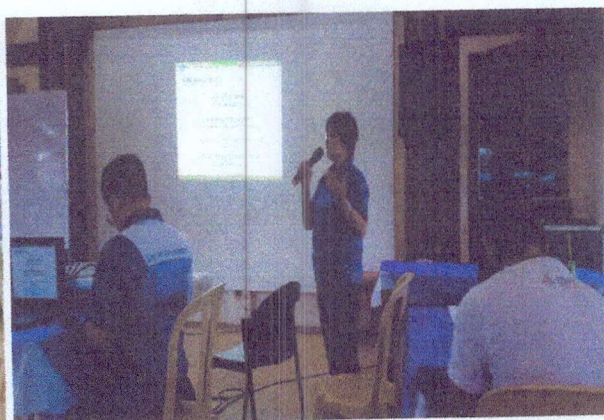
