Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated February 10, 2023 relative to the above subject in compliance further to the mail from the Assistant Regional Director for Technical Services Maximo C. Landrito and memorandum dated February 9, 2023 from the OIC-Director for Environmental Law Enforcement and Protection Service (ELEPS) Reuel N. Sorilla.

Per reported data, there were nine (9) current hotspot areas in the Municipality of Taytay and four (4) in the Municipality of El Nido, Palawan. For the Stockpiled of Illegally-cut wood apprehended lumbers were piled at the respective Forest Product Monitoring Station (FPMS) I-VI, while others are in the custody of Barangay Officials. The number of illegal cases within the AOR for CY 2017-2022 has a total of thirty-four (34) including the apprehensions conducted by other law enforcement agencies. In addition, there were forty (40) operations/apprehensions conducted with corresponding seventeen (17) pending cases for violations of PD 705, as amended and other relevant environmental laws.
