Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated February 13, 2023 relative to the above subject.


Per memorandum dated February 9, 2023, the apprehension was made on November 9, 2022 at around 11:05 P.M. thru a phone call from a concerned citizen regarding the transport of alleged illegal lumber in Sitio Kabanatsi, Barangay Sandoval, Taytay, Palawan. A team from Forest Product Monitoring Station V immediately conducted a mobile checkpoint at the said barangay and after a few hours, the said conveyance loaded with fresh-cut kalantas hull was encountered by the team of FPMS V. However, the four individuals which are the driver and helpers escaped during the operation.

The apprehended undocumented lumber of Kalantas species has a total of 102 board feet with an estimated fair market value of Php8,160.00 while the one (1) unit topdown (EURO 125) has an estimated value of Php60,000.00. The apprehended items were brought to the compound of FPMS V, New Ibajay, El Nido, Palawan for safekeeping purposes.

Three (3) notices to the public were posted in different public places on November 23, 2022, December 1, 2022 and December 7, 2022 for the scheduled February 3, 2023 administrative hearing in relation to Section 8, Item No. 3 of DAO 1997-32. However, no claimant appeared in the CENRO Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended vehicle and lumbers.

This report is respectfully submitted pursuant to Department (DENR) Administrative Order 97-32 dated October 10, 1997.

WHAT

This is the final report on the administrative adjudication of the one (1) unit topdown (EURO 125 CC) loaded of one (1) pc fresh cut Kalantas hull equivalent to one hundred two (102) board feet.

WHEN

The interception/recovery took place last November 9, 2022 and the corresponding report was submitted and received in the Office on November 21, 2022 (Annex A to A₁) plus the geo-tagged pictures (Annex B), Tally Sheet (Annex C), and Apprehension Receipt (Annex D to D₂).

WHERE

The conveyance and the forest product was recovered in Sitio Kabanatsi, Barangay Sandoval, Taytay, Palawan and FPMS V, Barangay New Ibajay, El Nido, Palawan.

WHO

The so-called Apprehension Receipts bear no name of probable culprits. The operating enforcers were personnel from the Protected Area Management Office (PAMO) of El Nido-Taytay Managed Resource Protected Area (ENTMRPA) led by Forest Ranger Leo D. Tabernilla.

WHY

The subject items of forest products were taken and seized for failure by anybody to claim with valid documents despite invitation in public notice posted in three consecutive weeks.

HOW

The essential portion of the report is quoted as follows:

“...the received a phone call from concerned citizen regarding the transport of alleged illegal lumber in Sitio Kabanatsi, Brgy. Sandoval, Taytay, Palawan. We immediately proceeded to the abovementioned area to conduct mobile checkpoint. Few hours later, the team encountered the said topdown loaded with fresh cut kalantas hull without legal documents, however, the Four

(4) individuals which are the drivers and helpers were escaped during the hot pursuit. The team brought the topdown and forest products to FPMS V for safekeeping”.

ADJUDICATION PROCEDURE

Seizure Receipt (Annex E) and Seizure Order (Annex F to F₂) were facilitated on November 23, 2022 in order to acquire jurisdiction over the intercepted items. The lumber have an estimated value of eight thousand one hundred sixty (8,160.00) pesos while the topdown is sixty thousand (60,000.00) pesos. Public notices (Pabatid sa Publiko) were posted consecutively every week on November 23, December 1 and 7, 2022 (Annexes G to G₂). The Certification of the Records Officer dated December 14, 2022 was then issued upon completion of the posting of Pabatid to the Public (Annex H).

In the absence of claimant, the undersigned opted to adjudicate the issue on the basis of the report submitted. This Office sent invitation to Forest Ranger Leo D. Tabernilla et. al, and Punong Barangay Manuelito L. Legion of Barangay Sandoval, Taytay, Palawan to a hearing on 27th day of January, 2023 at 3:30 in the afternoon (Annex I to I₁).

The examination pushed through as evidenced by the Attendance Sheet (Annex J). Preliminaries such as attendance check and the IEC presentation was set aside since all of the attendees were personnel from this Office.

On the examination, *Hearing Officer* directly asked on the present location of the lumber. *FR Tabernilla* answered that the lumber and the topdown were in the FPMS V, New Ibajay, El Nido, Palawan for safekeeping. *HO* then followed up the inquiry if follow-up operation was conducted by the enforcement team after the incident. *FR Tabernilla* answered the following day, the team went to the barangay to coordinate and investigate the owner but the Barangay Officials were also silent on the possible owner of the items. *FR Tabernilla* also added that they declared the items as abandoned since the violators jumped and immediately ran away hence the team identify no one. *HO* then declared the items to be abandoned.

Transcript of the minutes is Annex K.

CONCLUSION AND RECOMMENDATION

The items listed down in the Seizure Order and Seizure Receipt are deemed abandoned thus hereby recommended for the issuance of Order of Forfeiture.

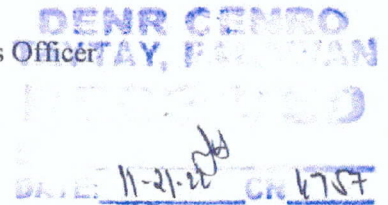

This report is respectfully submitted pursuant to the memorandum of the Undersecretary for Field Operations, Enforcement and Muslim Affairs dated July 01, 2020.

WHAT

This is the report of the apprehended One (1) unit top down (EURO 125 CC) loaded fresh cut kalantas hull with the total volume of 102 board feet at Sitio Kabanatsi, Brgy. Sandoval, Taytay, Palawan.

WHEN

The apprehension took place November 9, 2022 at around 11: 05 o'clock in the evening and the corresponding report was submitted and received in the Office on November 14 (Annex 1) along with the geotagged photos (Annex 2), tally sheet (Annex 3) and Apprehension Receipt (Annex 4).

WHERE

The apprehension took place at Sitio Kabanatsi, Brgy. Sandoval, Taytay, Palawan and the said forest product and conveyance were brought to FPMS V, Brgy. New Ibajay, El Nido, Palawan for safekeeping.

WHO

The owner of the said item is unidentified because they escaped during the hot pursuit operation. The enforcement personnel were representing our Forest Product Monitoring Station V namely Forest Ranger Leo D. Tabernilla, Forest Protection Officer Michael John Dordines, Forest Protection Officer Edjay Adon, Forest Protection Officer John Harold Caparnio and Forest Protection Officer Catalino Cabalda Jr.

WHY

The said forest product was taken and seized in violation to Section 77 of Presidential Decree 705 as amended otherwise known as Revised Forestry Code of the Philippines as stated as "Any person who shall cut, gather, collect, or remove timber or other forest product from any forest land, or timber from alienable or disposable public lands, or from private lands, without any authority, OR POSSESS TIMBER OR OTHER FOREST PRODUCTS WITHOUT THE LEGAL DOCUMENTS AS REQUIRED UNDER EXISTING FOREST LAWS AND REGULATIONS, SHALL BE PUNISHED WITH THE PENALTIES IMPOSED shall be guilty of qualified theft as defined and punished under Article 309 and 310 of the Revised Penal Code.



HOW

The team received a phone call from concerned citizen regarding the transport of alleged illegal lumber in Sitio Kabanatsi, Brgy. Sandoval Taytay, Palawan. We immediately proceeded to abovementioned area to conduct mobile checkpoint. Few hours later, the team encountered the said top down loaded with fresh cut kalantas hull without legal documents, however, the Four (4) individuals which are the drivers and helpers were escaped during the hot pursuit. The team brought the top down and forest products to FPMS V for safekeeping.
