This has reference to the letter dated April 3, 2023 of Mr. Felimon M. Jaurigue submitting a copy of Certificate to File Action issued by the Lupon ng Tagapamayapa of Bgy. Masikap, Puerto Princesa City involving a parcel of land described as Lot No. 524, Cad. 800-D identical to portion of Lot No. 165, Cad. 37 containing an area of 103 square meters located in Bgy. Masikap, Puerto Princesa City.

Be informed that the aforementioned parcel of land has been the subject of complaint of one Myrna Bacuel Alutaya which was lodged at 8888 Citizen's Complaint Hotline. In response to her complaint, the office has informed her in writing of the following:

- 1. That the office has nothing to do with any private transactions made by any of its personnel, which appearing to be outside of the DENR's mandate;
- 2. That the Office is not the proper agency to answer her query regarding the annotation made on the tax declaration issued over the subject lot, hence, she was advised to directly coordinate with the City Assessor's Office regarding the matter;
- 3. That from verification of the Allocation Book of the Office, it shows that Lot 524, Cad. 800-D is listed in the name of COMADO TATLONG HARI while its identical lot, which is Lot No. 165, Cad. 37 is listed as GOBIERNO INSULAR VS. JUAN ALISANCO MARRIED TO VICTORIA BOLILES;
- 4. That considering the conflicting findings, Ms. Alutaya was further informed that she may opt to file a formal protest in due form pursuant to DAO 2016-31 dated December 29, 2016.

However, it was later found out that a **DECISION** was rendered on April 3, 1916 by one Bartolome Revilla, Juez del Decimo Distrito from the Decimo Distrito Judicial covering a land case, entitled "EL GOBIERNO DELLAS ISLAS FILIPINAS, SOLICITANTE contra ANTONIO ABOROT Y OTROS, OPOSITORES", where, among the lots involved is Lot No. 165, Cad. 37, which is the lot subject of the herein conflict.

Quoted from the said Decision (found on page 25) is an information about the subject lot, which was written in Spanish and translated to English with the aid of Google Translate:

Statement in Spanish:

"Lot No. 165 – Este Lote se adjudica a favor del Gobierno Insular, por no haber probado el reclamante Juan Alisanco, casado con Victoria Boliles, su derecho a la posesion de dicho terreno."

Google Translation to English:

"This lot is awarded in favor of the **insular government**, for not having proven the claimant Juan Alisanco, married to Victoria Boliles, his right to possession of said land."

Further quoted from the said Decision are the following (found on pages 25 to 26):

Statement in Spanish (9th paragraph of p25):

"En cuanto a las careteras, caminos, calles, callejones, cauces de agua y otras partidas de terreno no enumerados como lote, o los numerados pero que no han sido solicitados por nadie, o no hayan acreditado su derecho de propriedad o posesion sobre dichos terrenos, situados dentro del perimetro de la masa total del terreno, pbjeto de este espediente, se decharan propiedad del Gobierno de las Islas Filipinas."

Google Translation to English:

"Regarding the highways, roads, streets, alleys, watercourses and other items of land not listed as lots, or those numbered but that have not been requested by anyone, or have not proven their right of ownership or possession over said lands, located within the perimeter of the total mass of the land, subject of this file, will become the property of the government of the Philippine Islands."

Statement in Spanish (2nd paragraph of p26):

"Una-hecha por la oficina de Terrenos Publicos la relacion de gastos ocasionados por la medicion y amohojamiento de terreno, y por la oficina General de Registro de Terrenos la relacion de gastos de registro y tramitacion, se dictara una orden especial para fijar la parte proporcional de derechos que cada interesado debe abonaar, en la forma prescrita por la Ley del Catastro".

Google Translation to English

"Once made by the public land office the list of expenses caused by the measurement and marking of the land, and by the general land registry office the list of registration and transmission expenses, a special order will be issued to fix the proportional part of rights that each interested party must pay, in the manner prescribed by the cadastre law."

Statement in Spanish (3rd paragraph of p.26):

"Se ordena al Escribano de este Juzgado, remita copias certificadas de esta decision al Jefe de la Oficina General del Registro de Terrenos, al Tesorero Provincial de Palawan, al Registrador de Titulos de la provincial de Palawan, al Registrador de Titulos de la provincial de Palawan, al Fiscal General de las Islas Filipinas y Director ode Terrenos".

Google Translation to English

"The Clerk of this Court is ordered to forward certified copies of this decision to the Head of the General Land Registry Office, the Palawan Provincial Treasurer, the Palawan Provincial Registrar of Titles, the Palawan Provincial Registrar of Titles, Palawan, to the Attorney General of the Philippine Islands and Director of Land."

Statement in Spanish (4th paragraph of p.26):

"Se ordena ademas, al mismo que, tan pronto como se dicte la referida orden especial de distribucion de costas, notifique a cada reclamante en este excediente de la parte de esta decision que la corresponda, conzignando al mismo tiempo la cantidad o parte alicuota que debe pagar, segun dicha orden especial.

Asi se ordena.

- 3. If disposable, who will issue the Special Order to fix the proportional part of rights that each interested party must pay?

Moreover, may we request for a copy of the technical description of Lot No. 165, Cad. 37 to overlay its metes and bounds in Cad. 800-D.

Further requesting information whether Lot No. 524, Cad. 800-D identical to Lot No. 165, Cad. 37 is within the Provincial Reservation (PR) 165.

I would like to reiterate that I am the lawful owner, claimant, and actual occupant of the Re: Lot No. 524, Cad, 800 D Located in Bgy. Masikap, Puerto Princesa City, Palawan.

The above-described parcel of land has NOT been transferred to Felimon Jaurigue.

The document "Waiver of Rights and Interest" made by his partner in crime Atty. Gideon Rey V. Guayco which we signed on November 12, 2021 was supposedly for Mortgage only. I did not intend to waive my rights over the said parcel of land in favor of Felimon Jaurigue the Forest Ranger who worked in DENR. The said document was executed only for the sole purpose of securing my loan from him with no duration but in the acknowledgement receipt they insert wrong year of duration and not notarized.

When I discovered that the document was not for mortgage and was in fact a waiver. I obliged Felimon Jaurigue and the notary public to revise such document to Real State Mortgage (Unregistered Land). However, I was Advised that we should just execute an Acknowledgement Receipt and that the mortgage transaction shall be incorporated therein.

Due to their explanation, I was convinced that the said acknowledge receipt will prevail over the waiver of rights and interest and thus, I did not force them to cancel the said Waiver.

I was also in dire need of money at that time because I have to pay the balance for the hospital bills of my mother who suffered from stroke and was confined six (6) times in the Cooperative Hospital for almost one (1) year. I also have to pay the funeral expenses in St. Peter for my mother because she did not survive her illness.

I talked to her agent last October 2022 personally because she remind me about the mortgage at nakiusap ako sa agent niya named Anna V. Domingo na babayaran ko ang nai-loan kung pera kay Felimon Jaurigue dahil hindi ko ipaparemata ang lupa na naging collateral ko sa Loan. Sinabi ko rin sa kanya na babayaran na ang Beach namin na ibinibinta at naka-schedule na itong bayaran by December 2022 kaya kaagad-agad niyang tinawagan si Felimon Jaurigue sa harapan ko sa loob ng office ni Atty. Onos B. Mangotara sabay sabing "Sir Mon, babayaran raw ni Myrna sa December ang Loan niya sayo" sa harap ng maraming to niya ito sinabi dahil nagpapanotaryo ako ng documents ko that time. Sa di inaasahan na pangyayari may dumating na bagyo nong December 2022 kaya hindi natuloy ang bayaran at agad naman akong nagtext Kay Anna to inform her na hindi natuloy ang bayaran namin pero nakiusap ako na once na matuloy ang bayaran namin ako MISMO ang maghahatid ng pera pambayad sa nai-loan ko kay Felimon Jaurigue. Dahil Ang sabi niya sakin dapat siya ang una kong kausapin at hindi ako dapat magdirect sa financer na si Felimon Jaurigue dahil ibabalik rin raw AKO sa kanya para kausapin patungkol sa nai-loan kong pera. I discovered recently that Felimon Jaurigue has no licensed in Lending Investment na mag-poporfit ng mga Mortgage and his agent also was not a registered real state broker. Their given interest is 10 percent sa nailoan kung pera na nagkakahalaga ng 1.2 M. Tinanggap ko ang 10 percent na interest nila dahil sa laki ng pangangailangan ko para sa aking namatay na ina kahit hindi ito makatao dapat maunawaan nila kung bakit nadedelayed ang pagbabayad ko dahil sa sunod-sunod na trahidyang dumating una na dito ang pagkamatay ng aking ina, pangalawa kasama kami sa lahat ng naapektuhan ng bagyo Odette naubos ang aming kabuhayan at ang aming inaasahan nalang ay yong mabayaran kami sa ibinibinta naming lupa. Nagulat ako na ipina-anotate na ni Felimon Jaurigue sa Tax Dec namin na siya na ang Administrator at agad naman itong inilipat ng Assessor dahil sa ipinakitang Waiver of Rights nito ngunit nong nakipagugnayan kami sa DENR-CENRO ang sabi nila sa amin kahit may waiver of rights siyang ipinakita dapat hinanapan ng Assesor ng Certification coming from DENR-CENRO na pwede niya ng ilagay ang pangalan niya as Administrator sa Tax Declaration namin at nagconduct muna sila ng investigation dahil isa sa pumirma sa SPA ko ay ang akong ina na patay na.

Ang iniirereklamo namin ay bakitang bilis niya itong nagawa dahil ba taga DENR-CENRO siya at may mga kapit siya kaya agad-agad niya ito nailagay sa pangalan niya samantalang ako na anak bago ko isinanla ang lupa ay nagprocess ako na mailagay na sa pangalan ko dahil patay na ang tatay at nanay pero sa kanya walang kaabog-abog ay mabilis nilang nailipat sa pangalan ni Felimon Jaurigue. Hindi ata makatarungan ang ganitong pangyayari kaya po ako dumulog sa sa inyong ahensiya dahil ginamit niya ang kanyang trabaho sa maling pamamaraan and they violated my human rights. Pareho nila akong niloko ng kanyang

Attorney. Dahil i'ang waiver of rights na pina-execute nila sa akin ay ipinalabas nilang nabili na ni Felimon Jaurigue ang aming lupa sa lahat ng ahensiya na dinadaanan para mai-process ang mga Land Documents in his name.

At ngayon po ay kami na niyang ipinatawag sa Barangay para sa reklamo niya na "Recovery of land ownership" dahil nais ni Felimon Jaurigue na kami ay paalisin sa aming tinitirahan. Di ba po ito ay illegal. Kami po ay umaasang matulungan niyo po kami na mabigyan ng hustisya sa ginagawa ng taong ito na ginamit niya ang kanyang posisyon o trabaho sa DENR upang Gawin ang ganitong maling gawain. Hindi lang po kami ang kanyang niloko, ganito rin po ang ginawa niya sa ibang nagsanla sa kanya na pilit niyang iremata ang lupa. Kawawa naman po ang mga nabiktima niya.

Umaasang po kami sa inyong aksyon sa kanyang ginagawa. Isa lang po siyang Forest Ranger pero kaya niyang magpa-utang ng Milyon dahil jan sa kanyang maling gawain.
