As compliance with the issued PENRO Special Order No. 2023-036 dated March 28, 2023 re: Reactivation of PENRO Marinduque Quick Response Team (QRT), the team under Technical Services Division- Monitoring and Enforcement Section (MES) were mobilized to conduct the functions stipulated in the said special order.

Please be informed that the team was divided into three (3) teams strategically situated in the major entry/exit point of Marinduque. The said sites are the Buyabod Port-entry/exit point of Marinduque to General Luna, Quezon and Catanuan Quezon and vice-versa, Brgy. Dos, Gasan pier-entry/exit point of Marinduque to Pinamalayan, Oriental Mindoro and the major entry/exit point of Marinduque, the Balanacan Port to Talao-talao point where all the passengers, vehicles and conveyances going to mainland Luzon area are using.

On April 04, 2023, the team personnel of MES coordinated to other agencies particularly with the PNP, PNP Maritime, PPA, Coast Guards and BLGUs regarding the activity and request for a collaborative effort to monitor the possible movement of undocumented forest products from the province to other provinces outside Marinduque. Be informed that our coordination received a positive response and support from our partner agencies.

The monitoring starts on April 05, 2023 until April 10. The team conducted the standard plain-view inspection particularly to private vehicles and some document verification in case of trucks and close van.

Rest assured that the team would continue to conduct the same activity regularly to prohibit the illegal movement of undocumented forest products and to apprehend any offenders.







