WHEREAS, pursuant to Republic Act No. 9322, a portion of the territory of Barangay Ransang in the Municipality of Rizal, Palawan consisting of 512.80 hectares of land covered under Project Number 13-G, Block A of Land Classification Map No. 3400 was reclassified as agricultural land open for disposition;

WHEREAS, Section 2 of that Act provides that the Department of Environment and Natural Resources (DENR) was tasked to provide the necessary implementing circulars, quidelines, and maps for its effective implementation;

WHEREAS, from its effectivity on 8 August 2004, several requests to the DENR were made by the Sangguniang Bayan through Resolutions No. 2017-114, 2020-016, 2021-217, 2022-111 and most recently 2022-260 to furnish this municipality of the Implementing Rules and Regulations (IRR) and map of the subject alienable and disposable (A&D) land in Barangay Ransang;

WHEREAS, as enshrined under the 1987 Philippine Constitution and the Local Government Code of 1991, it is the mandate of the local government unit (LGU) to prioritize among others, the general welfare of its constituents, and it is common knowledge that A&D lands, most commonly referred to as *released lands*, are vital to the economic prosperity and development of LGUs resulting from the growth in investment and business opportunities due to security of tenure of lands;

NOW, THEREFORE, on motion of Hon. Arvin C. Fuentes unanimously seconded, be it

RESOLVED, as it is hereby resolved, to respectfully request as it is hereby respectfully requested, the Department of Environment and Natural Resources, thru the MIMAROPA Regional Executive Director, Ms. Lormelyn E. Claudio, CESO IV, to furnish this municipality of a copy of the approved map of the 512.80 hectares of public land and declared as alienable and disposable pursuant to Republic Act No. 9322;

RESOLVED, FURTHER, that Ms. Lormelyn E. Claudio, CESO IV, Regional Executive Director, DENR MIMAROPA and all others concerned be furnished with copies of this resolution for their information and appropriate action.
