





MARCOS, President of the Philippines, do hereby withdraw from sale, ~~and~~ settlement or any other form of disposition, exploration or exploitation, and reserve as a pasture reserve, subject to private rights, if any there be, a certain parcel of land of the public domain situated in the island of Busuanga, Province of Palawan, which land is more particularly described as follows:

"A parcel of land (H.L. Survey Plan SW0-04-000080) bounded on the North by Mindoro Strait and Balneke Mountain Range; on the East by the barrios of San Nicolas and Guadalupe, Coron, Palawan; on the South by the barrio of Bintuan, Coron, Palawan; and on the West by portion of the Municipality of New Busuanga, Palawan; situated in the Municipalities of Coron and New Busuanga, Province of Palawan, Island of Busuanga; containing an area of FORTY THOUSAND (40,000) HECTARES, more or less."

NOTE: The data are approximate and subject to future survey.

WHEREAS, Proclamation No. 1387 (s. 1975) withdrew from any form of disposition, exploration or exploitation; and reserved as a pasture reserve a parcel of land of the public domain in Busuanga, Palawan;

WHEREAS, pursuant to Section 3 of Commonwealth Act (CA) No. 452, the Bureau of Forestry (presently the FMB of DENR) shall have jurisdiction and authority over the administration, protection, and management of pasture lands;

WHEREAS, Proclamation No. 2057 (s. 2010) authorized the Philippine Forest Corporation (PFC) to administer the development of the area covered by the Busuanga Pasture Reserve delineated by Proclamation No. 1387 (s. 1975);

WHEREAS, the Administrative Code of 1987 grants the President the continuing authority to reorganize the executive department.

NOW, THEREFORE, I, BENIGNO S. AQUINO III, President of the Philippines, by virtue of the powers vested in me by law, do hereby repeal Proclamation No. 2057 (s. 2010) and transfer the administration of the area covered by the Busuanga Pasture Reserve to the Forest Management Bureau of the DENR.

WHEREAS, the Municipal Government of Coron, Province of Palawan highly commends and strongly supports the recent issuance of an Executive Order by His Excellency President Rodrigo Roa Duterte mandating all government agencies and instrumentalities to cause the implementation of identifying lands owned by the government devoted to or suitable for agriculture for distribution to qualified beneficiaries;

WHEREAS, the Municipality of Coron is an island municipality in the northernmost tip of the Province of Palawan with Three Thousand Five Hundred Thirty One (3,531) registered farmers and with approximately Thirty-Three Thousand (33,000) hectares of agricultural lands;

WHEREAS, portions of said agricultural lands in various barangays of this Municipality had already been distributed to qualified beneficiaries through RA 6657 otherwise known as the "Comprehensive Agrarian Reform Law of 1988" by instituting the Comprehensive Agrarian Reform Program (CARP) and providing mechanisms for its implementation;

WHEREAS, notwithstanding the government's effort to provide sustainable agricultural farming especially for the marginalized farmers by giving them their own lands to till through RA 6657 otherwise known as the "Comprehensive Agrarian Reform Law of 1988", this measure avers that like in many parts of the country, the Municipality of Coron is still beset by clamor from local farmers and interest groups continually struggling to own the agricultural lands they are cultivating particularly those farm lands within the **BUSUANGA PASTURE RESERVE (BPR)** created under Presidential Proclamation No. 1387 issued on February 13, 1975, which provides, "**Reserving and establishing as a Pasture Reserve a certain parcel of land of the public domain situated in the Island of Busuanga, Province of Palawan" with an approximate area of 40,000 hectares located in the island of Busuanga, Province of Palawan known as Busuanga Pasture Reserve (BPR);**

WHEREAS, the LGU of Coron has been striving to seek the help of concerned Government Agencies to provide permanent solutions for the welfare and interest of our local farmers who are occupying public lands mostly within agricultural lands;
