Dear **Executive Director Claudio**:

The Coast Guard Surface Patrol Force (CGSPF) is a unit of the Maritime Security Law Enforcement Command (MARSLEC) of the Philippine Coast Guard (PCG) mandated to develop, prepare, plan, train and equip CGSPF personnel and surface assets for the conduct of maritime security and law enforcement operations.

The CGSPF has been tasked with revising and improving the current PCG Maritime Law Enforcement Manual to assist PCG personnel in carrying out their responsibilities as law enforcers in maritime zones in order to increase their effectiveness and efficiency. The PCG's enforcement of maritime law depends on the country's maritime jurisdiction, which extends from territorial waters to the Exclusive Economic Zone (EEZ). Furthermore, the PCG was mandated with assisting the other agencies in carrying out their charter.
