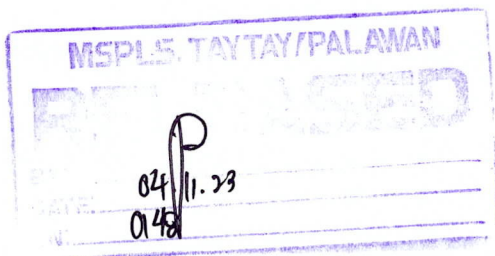

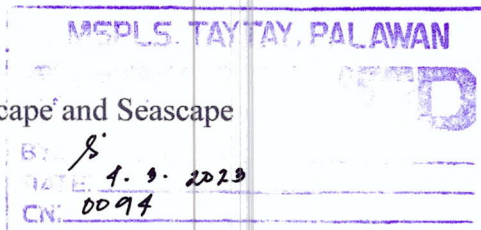

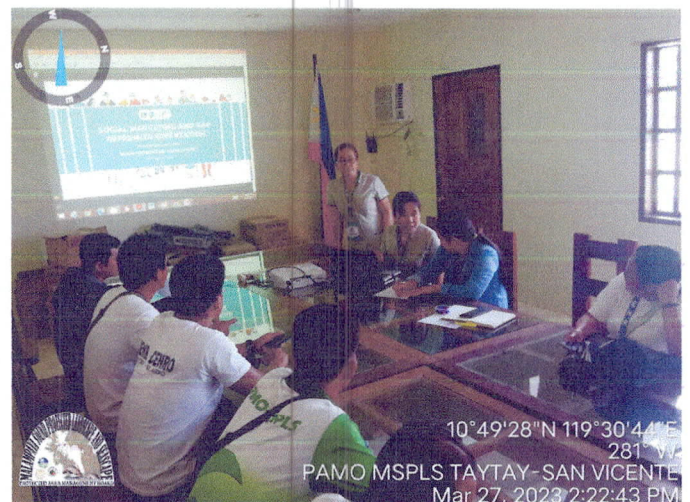


Figure II. The undersigned with PAMO-MSPLS personnel conducted extraction Crown-of-Thorns within MSPLS and attended KAP survey orientation.

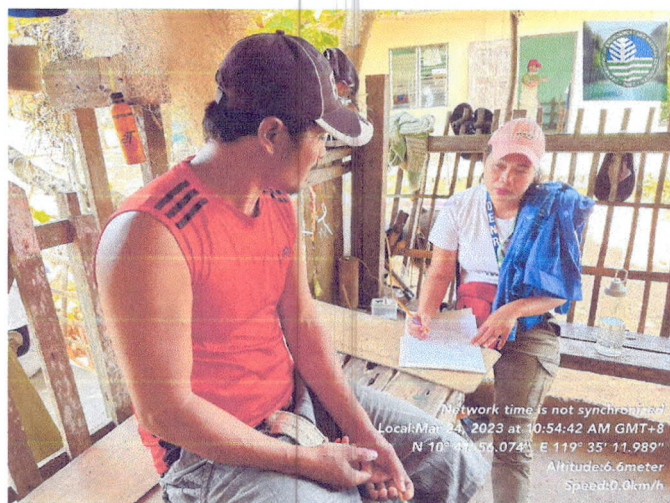

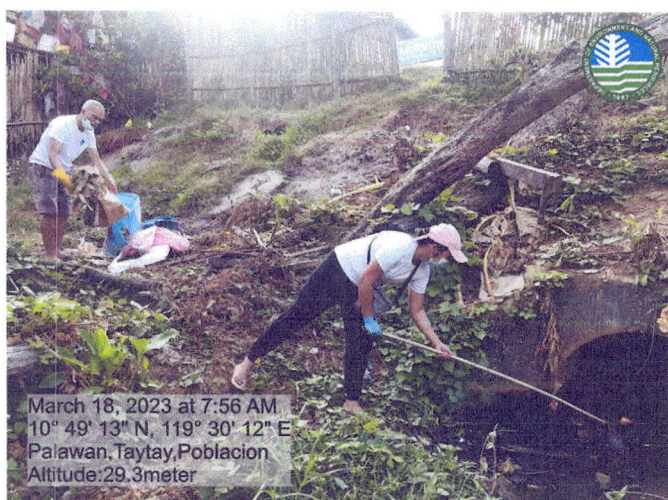


Figure IV. The undersigned participated in the river and coastal clean-up activity in celebration of the World Water Day and Month of the Ocean.
