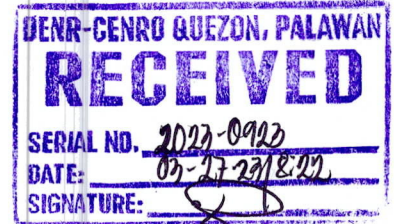

HIGHLIGHTS

Lionheart Farms (Philippines) Corporation (LFPC) seeks to conserve the remaining forest through protection, reforestation of denuded areas, assisted natural regeneration (ANR) of remaining forest, and secure the protection and maintenance of planted trees.

The Forest Protection project also aims to achieve the following:

- (1) Compliance with the JVA requirements;
- (2) Strengthening existing collaboration(s) with the MENRO, PCSD, DENR, Municipal LGU, and Local Government Units (LGU) of Ransang and Candawaga, Rizal and other local communities and partners primarily with the protection and reforestation of the denuded forest;
- (3) Supporting the National Greening Program of the Government (NGP);
- (4) Further enhancement of the awareness and capabilities of the local communities in the protection, reforestation of denuded forest and establishment of endemic fruits & trees, and high-value fruit tree plantation;
- (5) Effective mobilization of local communities towards the protection of the remaining forest and establishment of high-value fruit tree plantation; and
- (6) help improve the living condition of IP's and non-IPs through the promotion of raising the indigenous tree and fruit tree seedlings.



For this month of February 2023, the Lionheart Farms (Philippines) Corporation (LFPC) has accomplished the following activities:

- A. Last February 2023, Lionheart Farms (Philippines) Corporation (LFPC) Foot Patrol Unit continued conducting regular monitoring of illegal activities inside the approved Agroforestry Development Project (AFDP) and neighboring areas. As of February, based on the report made by the Foot Patrol Unit, there is no trace of illegal activities such as illegal logging, timber smuggling, illegal trade of non-wood forest products, poachers of wildlife as well as slash and burn of farms monitored in the approved areas of Agroforestry Development Project (AFDP) that is because of the presence of CENRO, KSK, Barangay and also the foot patrol monitoring team of LFPC. ***(Please see photos attached as ANNEX A)***
- B. Lionheart Farms (Philippines) Corporation (LFPC) nursery caretaker personnel continued conducting the Seedling Care and Maintenance activities of Fifteen thousand seven hundred fifty-four (15,754) seedlings in the nursery. The following activities done regularly are watering, weeding, sorting, hardening and application of foliar fertilizer & pesticide. ***(Please see photos attached as ANNEX B)***
- C. Last February 2023, Lionheart Farms (Philippines) Corporation (LFPC) personnel assigned to the forest protection project continued conducting silviculture activities inside and outside approved project of the company particularly in Sitio Sitio Malutok, Dinakpan, Maruso Ransang, Rizal, Palawan. The following activities undertaken are strip brushing, ring weeding, application of fertilizer & pesticide and replacement of seedlings mortality. Seedlings inventory of planted trees and bamboo were conducted. ***(Please see photos attached as ANNEX C)***
- D. Last February 2023 Lionheart Farms (Philippines) Corporation (LFPC) personnel assigned to the Land Negotiation conducted an Information Education Communication (IEC) in the different sitio's in barangay Ransang & Canadawaga, Rizal, Palawan. The LFPC Land negotiator personnel explained the importance of the protection of remaining forest, watershed and conservation of biodiversity. They also explained




the importance of planting different tree species to prevent worldwide climate change. ***(Please see photos attached as ANNEX D)***

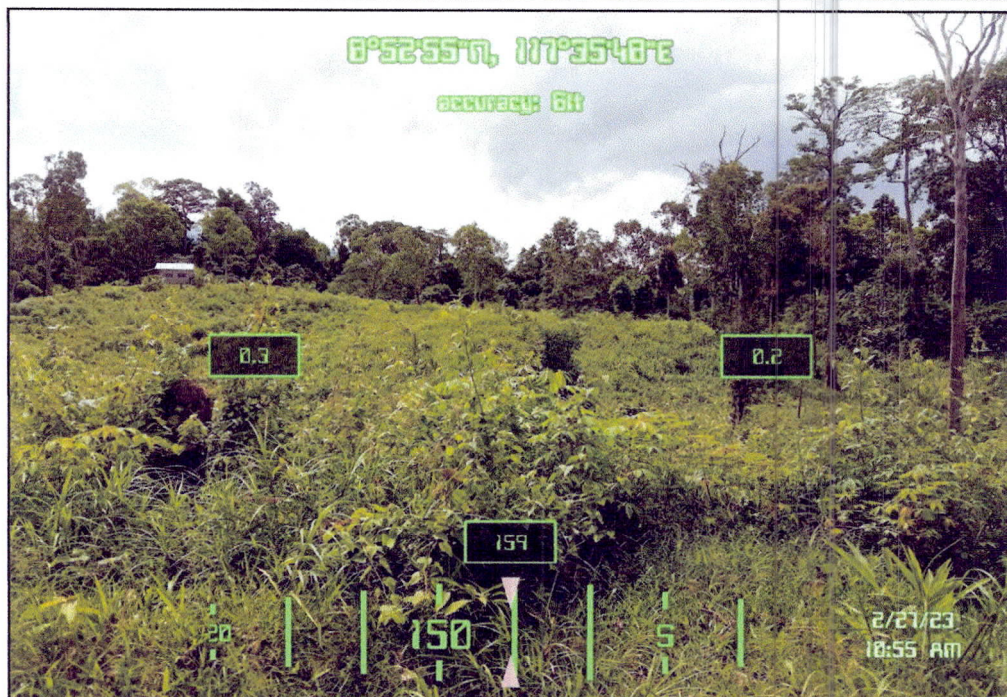

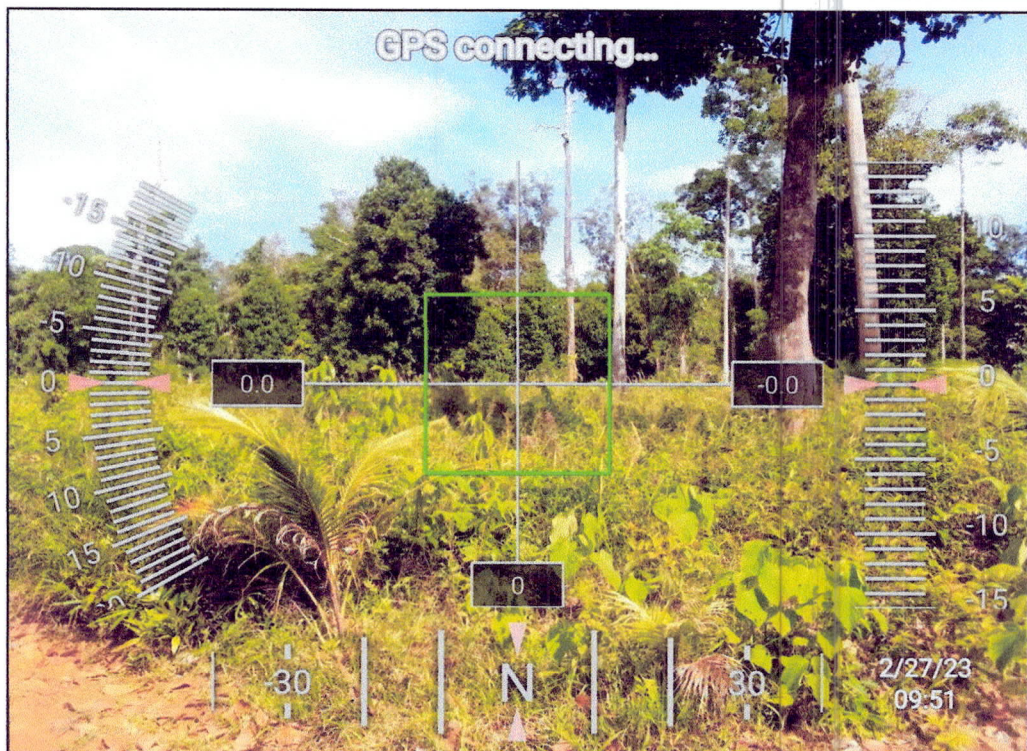

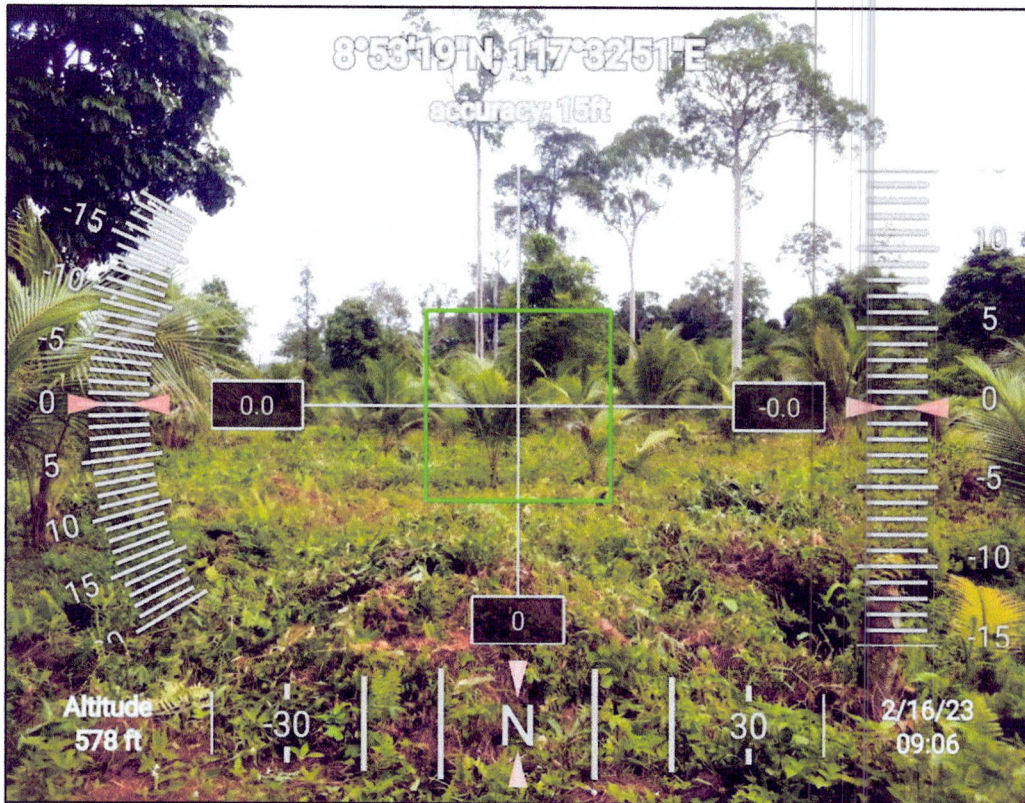

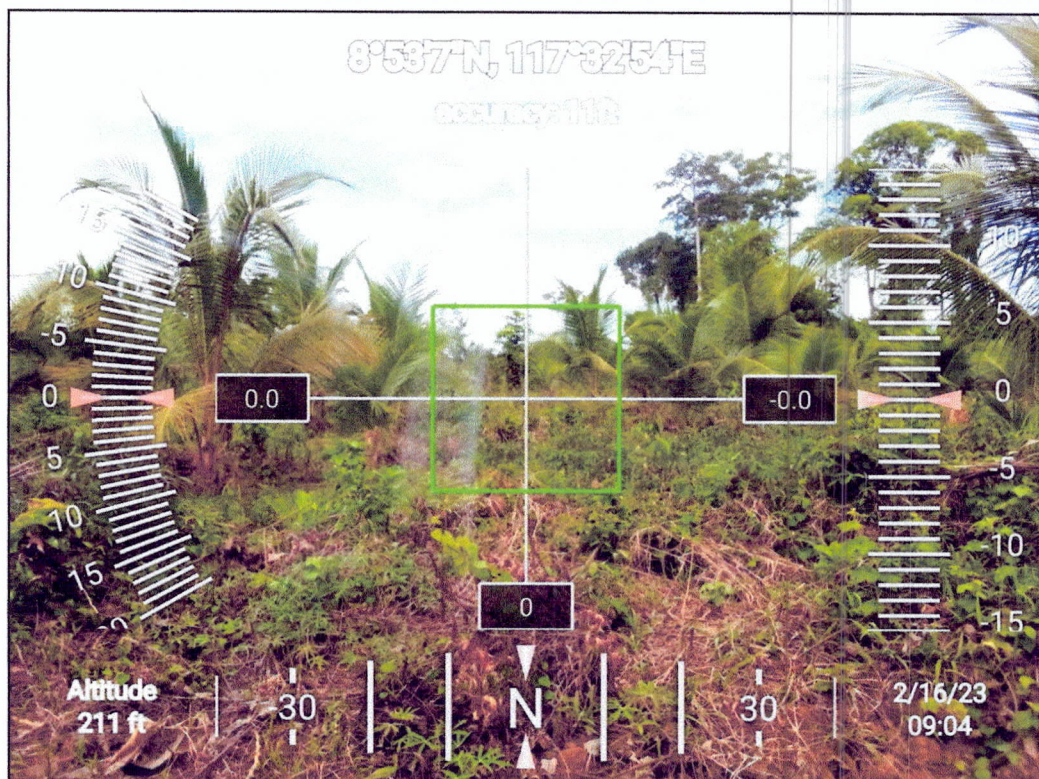

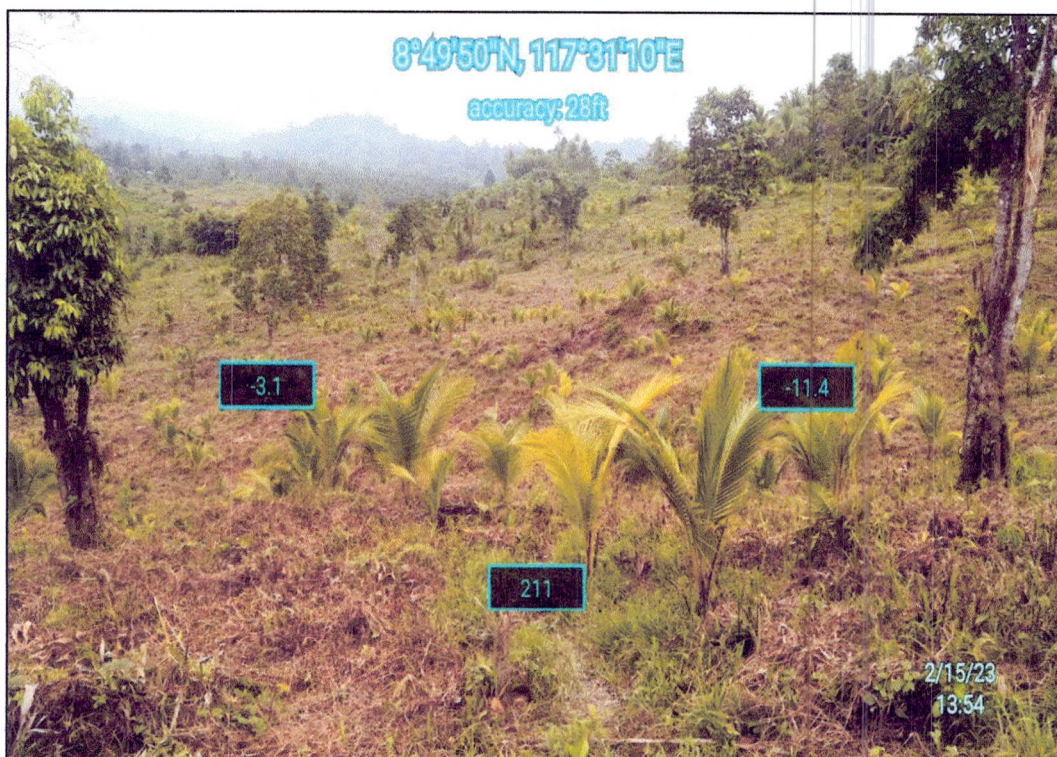
