On April 27, 2023, the Chief, Technical Service Division directed the undersigned to attend a meeting on the **2022 REPORT ON THE ECONOMIC PERFORMANCE OF MIMAROPA REGION NEWS CONFERENCE**.

The Resource Speaker of the meeting are **Leni R. Rioflorido, Director of PSA, Agustin C. Mendoza, Director of NEDA and Jomar S. Garachico, Statistical Specialist II, Macroeconomic, Accounts Service –PAD**. Other personnel who facilitated the meeting are Rea Mae C. Bagui, Assistant Statistician, Ma. Tricia Yvone A. Dinglasan, Statistical Specialist I (COSW), Ma. Leizel L. Magbojos, PSA Statistical Specialist, PSA RSSO MIMAROPA, SOCD, Gemma N. Opis, Chief, Statistical Specialist, PSA, Marinduque and Johnny F. Solis, Chief, Statistical Specialist, PSA Romblon.

Leni R. Rioflorido, Regional Director PSA presented the highlights of the 2022 Gross Domestic Products and Gross Regional Expenditure of MIMAROPA.

In the PRESS RELEASE signed by Leni R. Rioflorido dated April 27, 2023, the MIMAROPA Region's Surpasses Pre-pandemic Level with 6.30 Percent Growth in 2022.

The MIMAROPA's Gross Regional Domestic Product (GRDP) expanded by 6.3% in 2022, from 3.30% in 2021, surpassing the 2019 pre-pandemic levels. The **Industries with largest growth rates were Transportation and Storage, 41.30; Accommodation and Food Service Activity, 38.20%; Construction, 13.50% and Other Services 12.80%.**

On the other hand, the **industries that exhibit decline were Mining and Quarry with -5.10% and Agriculture, Forestry and Fishing with -2.40%.**

Among the major industries, **Services accounted for the biggest share of 47.90%, followed by Industry with 34.10% and Agriculture, Forestry and Fishing with 18.0% share. Data sources is the information and/or figures given by the Forest Management Bureau, Department of Environment and Natural Resources, Department of Agriculture and other government agencies.**



In the PRESS RELEASE signed by Leni R. Rioflorido dated April 27, 2023 on MIMAROPA Region's Exports of Services Recovered in 2022.

At the **Expenditure Side**, **Imports of Goods and Services from the Rest of the World** posted the highest growth among the expenditure item with **47.3-%**, followed by **Exports of Goods and Services with 39.0%** and **Gross Capital Formation with 16.70 %**.

Household final consumption expenditure, and Government final consumption expenditure also posted positive growth in 2022, with 8.20% and 4.20%, respectively.

Ther **Per Capita Household** final consumption expenditure in the regional **increased by 7.0% in 2022**. The recorder **per capita HFCE, at constant 2018 prices**, in the region was **Php 106,825, 18.20 %** lower than the national level which amount to **Php 130,590**.

The NEDA Director disclosed regarding the current Oil Spill of Oriental Mindoro contributes only a diminutive effect on the econmy of the region since its tourism and fishing industry can be diverted to othe place of MIMAROPA not affected by oil spill. Moreover, the MIMAROPA Region has high demand of housing construction and less of investment. Its economic growth is slow since the Mining Industry and Malampaya operation is declining . Although the region is second slowest growth among the seventeen (17) region in the Philippines with an expanded 6.30% performance of Economic Growth in 2022, from 3.30% in 2021 still the region has a good economic performance.
