A Notice of Violation (NOV) was already issued to Mr. Edgardo O. Trinidad (copy attached).

The report traces the circumstances back since sometime in May 2021 and there has been no fruitful outcome in the actions so far; hence we proposes the following subject to your instructions and the support of the PAMB.

- 1. Post a public notice in the area informing the claimant to self demolish the structures within fifteen (15) days or the structures shall be demolished by the composite team furnishing copy to the LGU, BLGU, MTC, Provincial Prosecutor's Office:
- 2. Create a composite team to carry out the demolition composed of the following:
 - 1. PAMB Committee on Law Enforcement Committee
 - 2. Barangay LGU of Maligaya and MLGU of El Nido
 - 3. PENRO-CENRO-PAMO Enforcement Team
 - 4. Municipal Police Station
 - 5. PCSD representative
 - 6. NGO representative
 - 7. Media representative

NOTICE OF VIOLATION

DENR CENRO TAYTAY, PALAWAN RELEASED

Sir.

This is to notify you that based on the investigation conducted by the CENRO Taytay and El Nido Managed Resourced Protected Area-Protected Area Management Office (ENMRPA-PAMO) Team pursuant to Section 20 of National Integrated Protected Areas System (NIPAS) Act of 1992 or Republic Act (RA) 7586 as amended by Expanded NIPAS Act of 2018 or RA 11038, it was verified that you are illegally occupying, fencing and underbrushing a portion of **forested area stretching from Barangay Masagana to Barangay Maligaya**, El Nido, Palawan identified as Lot 471 and 801 of CAD 1037-D which is classified as protected area under Presidential Proclamation No. 32. Hence, your continuous occupation and possession of the subject area without any clearance and/or permit from the Protected Area Management Board (PAMB) and the Department of Environment and Natural Resources (DENR), respectively, constitute a criminal offense. Section 18 (c), (n) and (o) of RA 11038, as amended, provides that:

SECTION 18. Section 20 of Republic Act No. 7586 is hereby amended to read as follows:

-xxx-

- (c) Cutting, gathering, removing or collecting timber within the protected area including private lands therein, without the necessary permit, authorization, certification of planted trees or exemption such acts are done in accordance with the duly recognized practices of the Ips/ICCs for subsistence purposes.
- (o) Constructing, erecting, or maintaining any kind of structure, fence or enclosure, conducting any business enterprise within the protected area without prior clearance from the PAMB and permit from the DENR, or conducting these activities in a manner that is inconsistent with the management plan duly approved by the PAMB.

In view hereof, you are hereby ordered to VACATE, REMOVE AND SELF-DEMOLISH THE STRUCTURE you have built in the subject land within FIFTEEN (15) DAYS upon receipt hereof or submit your proof of claims/tenurial instrument over the subject area. Otherwise, we will be compelled to take the necessary action on the matter.

We are hoping that you will give this matter your utmost and preferential attention.

This pertains to the Memorandum Report from Assistant PASu Jenuel P. Casel dated October 24, 2022 re clearing and installation of wooden posts and barbed wire in the forested area of Barangay Maligaya, El Nido, Palawan.

On November 17, 2022, the undersigned along with Park Rangers John Vincenth O. Cuyo, John Everette M. Pable and Ryan J. Cacacha conducted investigation in the area.

Based on investigation, the following were found out:

- 1. On May 28, 2021, ENTMRPA-PAMO staff with the presence of barangay officials conducted verification on the alleged fencing activity within the watershed area of Barangay Maligaya, El Nido, Palawan;
- 2. The report indicates that the team spotted four (4) persons/laborers conducting fencing activity instructed accordingly by a certain Edgardo Trinidad.
- 3. The area is initially identified as timberland per Land Classification map; falls within the jurisdiction of ENTMRPA; and is within the identified watershed of the said barangay.
- 4. On February 28, 2022, a memorandum dated February 18, 2022 from CENRO Alan L. Valle was received by ENTMRPA PAMO pertaining to the alleged fencing activity within the watershed area reiterating the submission of GIS map indicating the relative position of the structure and land classification.
- 5. On September 29, 2022, ENTMRPA-PAMO staff conducted initial inspection in the area due to complaint via phone call from officials of Barangay Maligaya. The team initially found out that the area was being claimed by Mr. Edgardo Trinidad and that the clearing, erected wooden posts and installed barbed wires was instructed by the same person;
- 6. Based on the above report, the current Barangay Maligaya officials has never issued certification in the area;

- 7. The report also indicated that a sign board was found in the area informing that the area is owned by Dave Trinidad/Jun Soleta;
- 8. On October 11, 2022, ENTMRPA-PAMO received a letter dated October 11, 2022 from Hon. Aura S. Cayabyab, Barangay Captain of Maligaya, regarding clearing, burning and under brushing activity in the watershed and timberland area in front of Spin Hostel, El Nido, Palawan;
- 9. On October 20, 2022, a letter addressed to Mr. Edgardo Trinidad informing him on the results of inspection dated September 29, 2022. He was further advised to appear at ENTMRPA-PAMO to justify the claim and to refrain further development pursuant to paragraphs c, n and o of Section 20 of RA 11038;
- 10. On October 24, 2022, a letter from Hon. Mayor Edna Gacot-Lim addressing the same issue was forwarded to ENTMRPA-PAMO;
- 11. As a result of investigation conducted by the undersigned dated November 17, 2022, it is found out that the said area being claimed by Mr. Edgardo Trinidad is identified within the portions of Lot 471 and 801 of CAD1037-D of Barangays Masagana and Maligaya based on GIS projection, respectively;
- 12. The said area falls within portions of timberland and portions of Alienable and Disposable (A&D) land per LC map;
- 13. The said area is within ENTMRPA identified having small portion within Multiple Use Zone (MUZ) and portion within Strict Protection Zone (SPZ) of the ENTMRPA Terrestrial Management Zoning per GIS projection;
- 14. It is also noted that the said area is near the identified Biodiversity and Monitoring Station (BAMS) Site located at Barangay Maligaya to Barangay Corong-corong, El Nido, Palawan.
- 15. Portions of the said area is also being cleared/under brushed per monitoring activities of ENTMRPA Park Rangers dated November 19, 2022.

With the above results, the team recommends as follows:

- 1. Inform Mr. Trinidad of the result of this investigation;
- 2. Require proponent to submit justification on his claim over the said area;
- 3. Advise Mr. Trinidad to refrain further development in compliance to paragraphs "c", "n" and "o" of Section 20 of RA 7586 as amended by RA 11038.
- 4. Inform the Protected Area Management Board for information and other recommendations;
- 5. Issuance of Notice to Vacate and Notice of Violation;
- 6. Continuous monitoring in the area.

On September 29, 2022 ENTMRPA staff conducted inspection in the forested area of Barangay Maligaya, El Nido, Palawan. Based on the report, the said area is within the Strict Protected Zone (SPZ) of ENTMRPA and the installed wooden post and barbed wire according to the laborers was instructed by Mr. Ed Trinidad. The team observed the installed signage with datails but the Barangay officials of Bgy. Maligaya informed the team that they never issued Barangay certification for the said area.

This office concurs with the recommendation of the team for more in-depth investigation to shed light on this concern. In this regard, this office would like to request a representative from Monitoring Enforcement Section on the conduct of in-depth investigation as recommended by the team.

Please be informed that this office already sent letter to Mr. Edgardo Trinidad regarding this issue. We furnished copy to Sangguniang Bayan and to the Municipal Mayor for their information.

As response to the issue referred by the officials of Barangay Maligaya, please be informed that Park Ranger Hero Jeff Isidro together with Forest Protection Officers' Jovan Villanueva and Danilo Moreno conducted an inspection in the forested area of Brgy. Maligaya in front of SPIN hotel El Nido on September 29, 2022.

Listed below are the findings during the inspection.

1. According to the Barangay Officials of Maligaya and local residents near the site, clearing and installation of wooden posts and barbed wire in the area was allegedly instructed by Mr. Ed Trinidad.

2. The present administration of Brgy. Maligaya has never issued a Barangay Certification for this area.

3. The area of concern is within the Strict Protected Zone (SPZ) of ENTMRPA.

4. Installed in the area is a sign board with details;





This pertains to your memorandum dated June 9, 2021 with subject: Verification on the Reported Alleged Fencing within the Watershed Area of Bgy. Maligaya, El Nido, Palawan. Based on the said report, there was a fencing activity at the property claimed and occupied by Mr. Edgardo Trinidad at the vicinity of the watershed area of Bgy. Maligaya, El Nido municipality and that same falls within timberland and El Nido-Taytay Managed Resource Protected Area (ENTRMPA). However, same do not have attached GIS map indicating the relative location of the structure and the land classification. This Office facilitated the generation of map using the geotagged photos but the grid coordinates therein shows that part of the structure fall within alienable and disposable land.

On July 13, 2021, this Office sent a memorandum requesting the above map indicating the perimeters of the abovementioned fence against the land classification and the protected area management zones as reference for further dispositive action. However, to date, this Office have not received your compliance related thereto.

In view of the foregoing, this Office reiterates the submission of the requested GIS map for the abovementioned purpose. Further request to refer the above incident to the concerned PAMB Committee and be presented before the Board for their information and further recommendation/s.



In response to the information reached this office pertaining to the above subject, the undersigned conducted verification last May 28, 2021 together with Kagawad Mark Louie Dela Cruz, Barangay Official of Maligaya, El Nido, Palawan and Park Rangers Jordan Paul G. Asuncion, Reden Latube, Bret Hart C. Sanogal and Norrien John Ladao.

The undersigned coordinated to the Barangay Local Government Unit (BLGU) of Maligaya regarding the said alleged fencing within the watershed area of Maligaya. The team proceeded to the subject area and spotted four (4) persons/laborers conducting fencing activity which was instructed by a certain "Edgardo Trinidad" per their statement. The area falls in timberland, within the jurisdiction of El Nido-Taytay Managed Resource Protected Area (ENTMRPA) and within the watershed of Maligaya per Kagawad Dela Cruz.

Please be informed that the said fencing activity is in violation of the provision of Expanded National Integrated Protected Areas System (ENIPAS) Act of 2018 stated as follow: (o) Constructing, erecting, or maintaining any kind of structure, fence or enclosures, conducting any business enterprise within the protected area without prior clearance from the PAMB and permit from the DENR, or conducting these activities in a manner that is inconsistent with the management plan duly approved by the PAMB.

The undersigned recommends for the issuance of Notice of Violation and Order to Vacate to Mr. Edgardo Trinidad.


