Environmental Greetings!

This pertains to the complaint lodged in this office by the following:

1. Melinyo Farmers and Workers Association which was indorsed by Barangay LGU of Buenavista
2. Mrs. Rowena Pe, et. al.
3. Tagbanua Indigenous Cultural Communities of Barangay Buenavista represented by their Tribal Chieftain Mercelita F. Sabater

The complaint is about overlapping claims in parcels of land under Gss-04-000165-D located at Purok Milenyo, Brgy. Buenavista, Puerto Princesa City.

Further investigation however shows that aside from overlapping claims, 5M&E Development Corporation represented by Mr. Edgar Luengo has constructed a guardhouse with barrier within the twenty (20) meter wide salvage zone/easement zone. This is along Camanglit River.

Article 51 of Presidential Decree No. 1067, otherwise known as "The Water Code of the Philippines", a **salvage zone** is defined as "the banks of rivers and streams and the shores of the seas and lakes throughout their entire length and within a zone of three (3) meters in urban areas, twenty (20) meters in agricultural areas and forty (40) meters in forest areas, along their margins are subject to the easement of public use in the interest of recreation, navigation, floatage, fishing and salvage. **No person shall be allowed to stay in this zone longer than what is necessary for recreation, navigation, floatage, fishing or salvage or to build structures of any kind**".

DENR Administrative Order (DAO) No. 2021-07 dated April 28, 2021 under Section 6.6.2 states that:

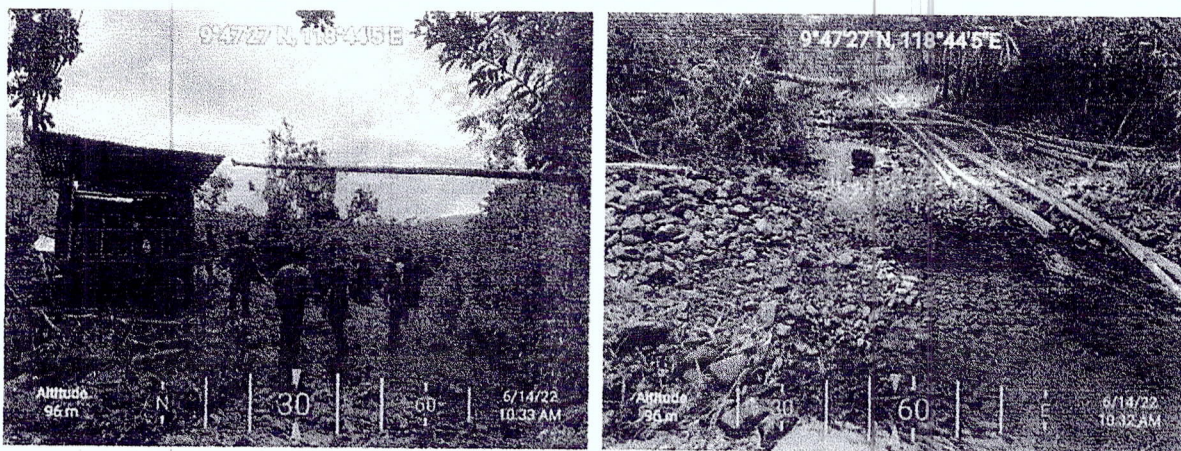
"Banks of rivers and streams with channels at least five (5) meters wide or continuously flowing rivers and streams **even with less than five (5) meters width**, creeks, arroyos, or esteros shall be subjected to legal easement of three meters in urban areas, **twenty (20) meters in agricultural lands** and forty (40) meters in forest lands, measured landward from the edge of the normal high waterline".

Furthermore, under Section 8 of the same Administrative Order, it is stated that “all individuals, or group entities owning or managing the establishments and structures which are found to be in violation of the rules on the establishment of salvage zone and legal easements, whether private or owned by the government, **shall be subjected to possible relocation and demolition**, if warranted”.

City Ordinance 960 dated August 31, 2018 also identified easement/salvage zone as “No Build Zone”.

Mr. Edgar Luengo representing 5M&E Luengo Development Corporation was already issued a Notice to Vacate dated June 22, 2022 to “VACATE THE SAID AREA AND REMOVE ANY STRUCTURES BUILT THEREIN WITHIN THIRTY (30) DAYS UPON RECEIPT”

Below is the photo of the guardhouse with barrier which was built within the 20 meters wide salvage zone/easement (along Camanglit River):



Pursuant to Section 30 of Republic Act No. 7279 or the “Urban Development and Housing Act of 1992”, which states that it shall be unlawful for any person to construct any structure in areas mentioned in Section 29 of the same Act and the **barangay, municipal or city government units has the responsibility to prevent the construction of any kind of illegal dwelling units or structures within their respective localities.**

In this regard, may we request your assistance to **facilitate the demolition of all structures built within the salvage/easement zone more particularly the guardhouse with barrier.**

This office would like to emphasize that the demolition of the said structures will benefit the collective citizenry and give them easy access to the said river.

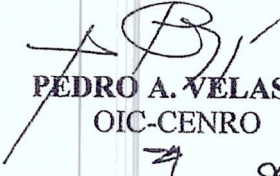

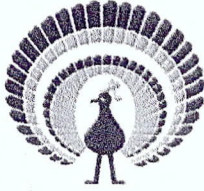

Dear Ms. Pe,

This confirms receipt of your letter dated December 16, 2022 which was indorsed to the undersigned as the Head Secretariat of the Local Committee Against Squatting Syndicates and Professional Squatters (LCASSAPS) on December 28, 2022. As stated in your letter, you are seeking assistance from the City Government of Puerto Princesa (CGPP) regarding your problem with the alleged land-grabbers on the agricultural land you were occupying in Bgy. Buenavista and for the implementation of a Notice of Demolition issued by the DENR-CENRO.

At the outset, and as verbally explained by the undersigned during your visit to the City Legal Office, the LCASSAPS has no jurisdiction to hear complaints or disputes on claims over agricultural land. A protest or claims/conflict case may be lodged to the DENR-CENRO for the administrative adjudication of your land claim over the said property.

As regards your request for implementation of the Notice of Demolition, we have not found any such notice attached to your letter. We only found the following documents, to wit:

1. **Notice to Vacate** addressed to Mr. Edgar Luengo issued on June 22, 2022 by Mr. Pedro A. Velasco, OIC-CENRO, DENR-CENRO Puerto Princesa City
2. **Order of Status of Quo** issued on June 24, 2022 by Mr. Pedro A. Velasco
3. **Letter** dated August 5, 2022 addressed to the Lucilo R. Bayron, City Mayor, by Mr. Pedro A. Velasco requesting "*assistance to facilitate the demolition of all structures built within the salvage/easement zone, more particularly the guardhouse with barrier*".

The letter, however, did not pertain to any Demolition Order issued by the DENR-CENRO. His letter, however, refer to violation of environmental laws, issuances and ordinance due to the allegation of construction of structures within the water easement/danger area/no-build zone. Thus, our assumption is that the DENR-CENRO is requesting for the assistance of demolition of the structures pursuant to the power of the local chief executive for summary demolition under the existing applicable laws, to wit:

1. Section 455 (b) (3) (vi) of Republic Act No. 7160 or the Local Government Code
2. Section 27, 28 and 30 of Republic Act No. 7279 or the Urban Development and Housing Act

Thus, in order to address your concern and to validate the findings of the DENR-CENRO as stated in their letter and Notice to Vacate, please be informed that the undersigned shall indorse this matter to the DAPSASS and other concerned offices of the CGPP, to conduct an on-site investigation before we refer the same to the LCASSAPS.

We will contact you on the schedule of the said on-site investigation. We hope to have assisted you on the matter. Thank you.

NOTICE TO VACATE

This pertains to your occupancy over a portion of **Environmental Bank Protection/Easement Zone** more particularly the **Guard House** you built adjacent to the **creek** located in Bgy. Buenavista, Puerto Princesa City.

Per ocular inspection and investigation on the ground conducted by representatives from this office and based on the approved **Plan Gss-04-000126-D**, it was verified that the said **Guard House** is within the **twenty (20) meters wide Environmental Bank Protection** pursuant to Article 51 of **Presidential Decree 1067**, otherwise known as the **Water Code of the Philippines** and likewise in accordance with **DENR Administrative Order No. 2021-07 dated April 28, 2021**.

It is also within the **No-Build Zone per City Ordinance No. 960 dated August 31, 2018**.

In this connection, you are hereby directed to **VACATE THE SAID AREA AND REMOVE ANY STRUCTURES BUILT THEREIN WITHIN THIRTY (30) DAYS UPON RECEIPT HEREOF**.

Failure to comply on your part will constrain this office to take legal action.

ORDER OF STATUS QUO

Records of this Office show that the aforementioned parcels of lands are listed in the names of various individuals (Edgar Luengo, et. al.) and some of these lots were applied by different individuals and remain unnumbered and/or subsisting while a number of these lots were already patented to other applicants.

On August 07, 2018, a Resolution No. 1124-2018 dated July 9, 2018, entitled, ***"A Resolution Authorizing the Honorable Mayor Lucilo R. Bayron, for and in behalf of the City Government of Puerto Princesa, to apply for a tenurial instrument with the Department of Environment and Natural Resources (DENR) for the Proposed Joint Project with the Provincial Government for a 1,000 Hectare Forest Park in Barangay Buenavista, this City, and to Ensure Full Ownership of the Area"*** which was enacted by the 15th Sangguniang Panlungsod of the City of Puerto Princesa during its 100th Regular Session held on July 9, 2018 was received by this Office. Some of the aforementioned lots are within the said 1,000 hectare Proposed Forest Park.

On June 2, 2022, a Petition dated May 30, 2022 of the Melinyo Farmers and Workers Association represented by its President, Mr. Crispin L. Alaska, which was indorsed by Punong Barangay Juanito D. Capin was likewise received by this Office.

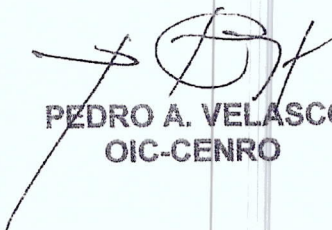
On June 7, 8 & 9, all year 2022, Ms. Rowena G. Pe, et. al filed their letter-complaints against the claimants of some parcels of lands under the aforementioned survey plan.

On June 20, 2022, a "Kapasyahan Bilang 01, Serye 2022" dated May 21, 2022, entitled, ***"Kapasyahang Humihiling Sa Tanggapan ng National Commission of Indigenous People na Makansela at Mapawalang Bisa Ang Aplikasyon ng mga Indibidwal at Samahan/Assosayon na Umaangkin sa Nasasakupan ng Lupaing Ninuno ng mga Katutubong Tagbanua sa Bgy. Buenavista, Lungsod na Ito"*** which was approved by the Tagbanua Tribal Council of Brgy. Buenavista, this City, was likewise received by this Office.

On June 14, 2022, an ocular inspection and investigation was conducted by representatives from this Office and it was found out that there exist an overlapping of claims of different individuals and likewise various issues and concerns had emerged which needed to be addressed and therefore an intervention from the DENR higher office/s is necessary.

WHEREFORE, in view of the various complaints and/or oppositions filed over the subject area and the existence of overlapping claims, the above-mentioned parties are hereby **ORDERED** to continually observe **STATUS QUO** over the aforementioned lots, and therefore directed to stop introducing additional improvements, including fences, building of structures of any type, and planting of any crops until after all the issues and concerns has been addressed and the final instruction and/or advice of action on the matter has been issued. This Order shall remains enforced unless otherwise revoked by the undersigned or higher authority.
