SUBJECT : **COMMUNITY MEETING IN CABUGAO, BULALACAO,
ORIENTAL MINDORO FOR INTENSIFICATION OF FOREST
PROTECTION ACTIVITIES**

Large portion of Bulalacao, Oriental Mindoro is classified as forestland covering 44,102 ha which constitutes 79.40 % of the Municipality's total land area wherein the barangays within forestlands or which mostly encompass forestland are Benli, **Cabugao**, Bagong Sikat and Cambunang (*FLUP 2020*). However, Bulalacao is one of the hotspots municipalities in illegal logging activities within the jurisdiction of CENRO Roxas, Oriental Mindoro. Several filed cases violating Presidential Decree 705 under Section 77 and DENR Administrative Order 97-32 (DAO 97-32) where apprehension and confiscation were done and happened in Bulalacao, Oriental Mindoro.

In connection with this, for the escalation of forest protection in the area, the personnel under Monitoring and Enforcement Section spearheaded an Environmental Lecture held at Brgy. Cabugao, Bulalacao, Oriental Mindoro on April 19, 2023. The main objectives of the meeting are to involve the community in forest protection and to raise their awareness of the strict prohibition of illegal cutting of trees within forest zone.

Please be informed that the meeting was participated by the Barangay Officials, residents of Brgy. Cabugao, and DENR personnel headed by Forester III Reynaldo D. Pudiquet. It was composed of 18 males and 13 females.

The first topic discussed was R.A 9175 or Chainsaw Act and E.O 23 Moratorium on the Cutting and Harvesting of Timber on Natural and Residual Forest and the creation of Anti-Illegal Logging Task Force by Forest Ranger Lingin U. Litaw. He emphasized the importance of having a permit before conducting an activity or work in the forest. The penalties are given to those who will commit a violation under R.A 9175 and E.O 23.
