This is to request clearance from the office of the DENR, Secretary the hereunder listed conveyances and its load forest products containing the necessary data/information:

1) Ten Wheeler Truck with Plate No. CTE-989

- A Criminal Case No. 12-10, 453 was filed in Regional Trial Court (RTC), Branch 39 against Domingo Opulencia and Renato Gupit under Court Litigation by Josephine C. Caranzo, Presiding Judge of RTC, Branch 39, City of Calapan.
- Herein conveyance is not serviceable
- Its load forest products having a volume of 14,074 board feet flitches is on the stage of deterioration
- A Confiscation Order was issued by Concordio D. Zuñiga, Regional Executive Director dated October 10, 2011
- An Order of Finality was issued by Lormelyn E. Claudio, Regional Executive Director dated May 20, 2022

- Herein, vehicle is not serviceable
- Its load lumber having a volume of 750 board feet is fully deteriorated

- An Order of Finality was issued by Lormelyn E. Claudio, Regional Executive Director dated May 20, 2022



3) Eight Wheeler Truck with Plate No. FWP-328

- A Criminal Case No. 13-10, 775 was filed in Regional Trial Court, Branch 40 against Eufrocino R. Fetalco, Edgar R. Beltran et al. under Court Litigation by Charity Grace Alcantara Rico, Presiding Judge of RTC, Branch 40, City of Calapan.
- Herein conveyance is not serviceable
- Its load wood charcoal was already deposited in the sub-station of CENRO Socorro formerly CENRO Calapan for custody and safekeeping located at Barangay San Vicente West, Calapan City, Oriental Mindoro
- A Confiscation Order was issued by Edgardo O. Galeon, Regional Executive Director dated November 14, 2013
- An Order of Finality was issued by Lormelyn E. Claudio, Regional Executive Director date May 20, 2022

4) PUJ with Plate No. DGD-367

- A Criminal Case No. 14-11, 873 was filed in Regional trial Court, Branch 39 against Irene Buhali under Court Litigation.
- Herein conveyance is not serviceable
- Its load lumber having a volume of 468.50 is fully decomposed
- A Confiscation Order was issued by Oscar C. Dominguez, OIC, Regional Director dated April 7, 2015
- An Order of Finality was issued by Lormelyn E. Claudio, Regional Executive Director dated May 20, 2022

5) Elf Mini-Dump Truck with Plate No. PDV-490

- A Criminal Case No. 14-11, 721 was filed in Regional Trial Court, Branch 39 against Reneil Sapungan y dela Cruz under Court Litigation.
- Herein conveyance is not serviceable
- Its load lumber having a volume of 1,688 board feet if fully decomposed
- A Confiscation Order was issued by Oscar C. Dominguez, OIC, Regional Directo dated September 7, 2015
- An Order of Finality was issued by Lormelyn E. Claudio on May 20, 2022

The aforesaid confiscated motor vehicles and its load forest products are requested for the issuance of clearance from the DENR Secretary for disposal of the herein confiscated items. This would serve as an initial step in soliciting court clearance from Regional Trial Court who has the jurisdiction over the criminal case filed in court for violation of Section 77 of Presidential Decree No. 705 as amended.
