


Per record of this Office, the issues/concerns raised by Ms. Dela Austria in her letter/s are reiterations of her previous letters/complaints and allegations since 2018 which were thoroughly investigated by the DENR-PENRO Romblon and by the DENR MIMAROPA Regional Office particularly on the involvement of Mr. Leni Ferry in the survey of a titled parcel of land left to the Heirs of Isidro Forio.

Furthermore, the OIC PENRO of Romblon already wrote a letter dated April 11, 2023, addressed to Ms. Norma F. Dela Austria in response to Ms. Dela Austria's complaint against the PENRO Romblon personnel copy furnished the CSC-CCB and the DENR Action Center Hotline 8888. 
