The team shall perform the following:

# 1. Team Leader

- a. Responsible in the formulation of Annual Work Plan and completion of the assign target per Work and Financial Plan (WFP).
- b. Supervise in the execution of the following surveys;
  - b.1 Public Land Surveys (PLS) covered by Survey Order
  - b.2 Request from Court or government agencies including academe
  - b.3 Instructions from higher office
  - b.4 Request from field offices subject for evaluation and approval of the PENRO
- Supervise the survey team and responsible for the early completion of the assigned task.
- d. Perform other function/s as instructed by immediate supervisor or the PENRO.

# 2. Assistant Team Leader

- a. Execute the surveys and responsible for the preparation of complete survey returns and completion reports for evaluation of the team leader.
- b. Responsible for the proper handling and safety of the survey instrument.
- c. Perform other functions assigned by the team leader.

# Team Members

- a. Provide the reference documents needed in the conduct of the surveys.
- b. Assist in the execution of the surveys.
- c. Perform computation and drafting activities.
- Does other functions assigned by the team leader.

The team shall at all times observe and protect the interest of the government.

All CENRO's are hereby directed to extend full assistance to the team by providing relevant information and documents to facilitate completion of the task.

The team shall submit the complete survey returns thirty (30) days after the execution of Public Land Surveys or to submit report of compliance five (5) days after completion of other type of surveys/requests.

All expenses to be incurred during the conduct of field surveys shall be charged to respective offices/other fund sources subject to usual accounting and auditing rules and regulations.

This Order takes effect immediately and shall be rescinded upon promulgation of any other policy anent this matter from higher office.
