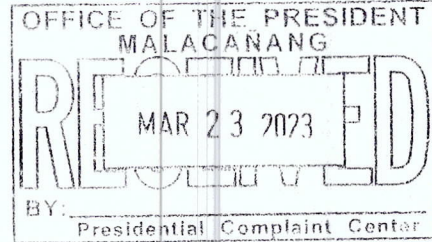

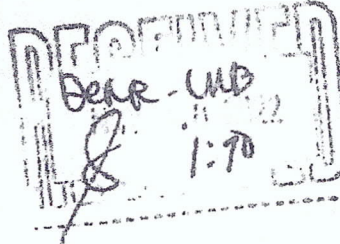

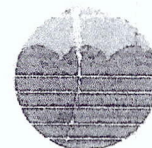

This has reference to the letter dated 09 November 2022 of Assistant Secretary for Real Estate and Installations, Emmanuel Anthony V. Ramos, Department of National Defense, regarding the request for guidance and/or clearance for the release of documents involving the survey plans of the military camps that can be release/provided to any requesting parties.

In the said letter of Asec Ramos, he stated that under Article IV: Confidentiality Clause of the Memorandum of Agreement (MOA) between the Department of National Defense (DND) and the Department of Environment and Natural Resources (DENR) dated 21 October 2022, as amended, it is provided that:

"Each of the Party shall treat all acquired information received from or accessed through the other Party or obtained on account of or due to the implementation of this Agreement as Confidential Information. Hence, extraordinary diligence shall be exercised in handling of such and no information shall be released to a third party without clearance from DND-AFP."

Asec Ramos further stated that in the interest of national defense and security, the DND-AFP finds it necessary not to provide the public of the survey plans and documentations of military camps conducted by DENR-CAR, and all regions concerned, which is deemed covered by the aforesaid 2020 MOA Confidentiality Clause.

Moreover, Asst. Secretary Ramos mentioned that while the release of survey plans of the military camps to any requesting parties may not fall under the exemptions stipulated in Executive Order (EO) No. 2, series of 2016¹ and Memorandum from the

Executive Secretary dated 24 November 2016², based on the legal opinion of the DND, nevertheless, the latter requests that such information be withheld for the time being by virtue of the said MOA sans any legal action, ruling or directive from appropriate agencies/courts to release the survey plans.

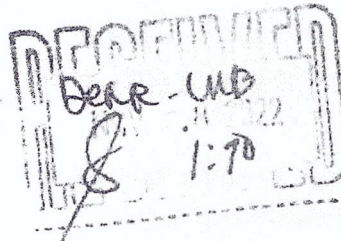
