Accordingly, the area is Unclassified Public Forest (UPF) and falls with El Nido Managed Resource Protected Area (ENMRPA) with a total area of one hundred twenty nine (129) hectares covered by an expired Forest Land Grazing Agreement/Pasture Lease Agreement under the name of Gloria Fernandez.

In connection to the findings on the conducted inspection and verification activity, The Protected Area Management Office (PAMO) and CENRO Taytay concurs with the recommendation of PMF Jenuel P. Casel to conduct performance evaluation and require the proponent to secure tenurial instrument (SAPA). Respectfully forwarded is the memorandum report from Park Maintenance Foreman Jenuel P. Casel dated December 23, 2022 pertaining to the above subject with attachments.

Personnel of this office conducted inspection and verification in the subject area located at Sitio Mirao, Brgy. Pasadeña, El Nido, Palawan. Based on the report, the area is Unclassified Public Forest (UPF) with a total area of one hundred twenty nine (129) hectares covered by expired Forest Land Grazing Agreement/Pasture Lease Agreement under the name of Gloria Fernandez.

During the validation, hereunder are the findings, to wit:

- 1. The area is within the jurisdiction of El Nido Managed Resource Protected Area (ENMRPA).
- 2. The area is now occupied by the heirs of Gloria Fernandez namely Ernesto Fernandez Sr.,Rico Fernandez, Henri Fernandez and Jun Fernandez subdivided as follows:
 - a. The area occupied by Mr. Ernesto Fernandez Sr. is about thirty (30) hectares currently used as an agricultural area such as livestock and poultry practices.
 - b. Thirty (30) hectares occupied by Mr. Rico Fernandez is also used as pasture areas for livestocks and perennial crops farming as well as the thirty (30) hectares occupied by Mr. Henri Fernandez.
- 3. During the inspection it was also disclosed that the Pasture Lease Agreement was issued in 1941 and renewed in 1974 and after another twenty-five (25) years renewal of the said documents was not secured or processed by the agreement holder.

This office concurs with the recommendation of PMF Casel to conduct performance evaluation and require the proponent to secure tenurial instrument particularly Special Use Agreement in Protected Area (SAPA) given that the area is within protected area and falls in Unclassified Public Forest (UPF). The result performance evaluation will also be reference for decision making on the request of the El Nido Sangguniang Bayan per Resolution No. 22-85.

This pertains to the memorandum instruction dated July 26, 2022 of CENRO ALAN L. VALLE relative to the above subject. The undersigned together with PAMO Ranger conducted verification to the proposed Government Site for the unclassified public forest situated at Sitio Mirao, Barangay Pasadeña, El Nido, Palawan containing an area of one hundred twenty-nine (129) hectares approximately and covered by expired Forest Land grazing Agreement of Gloria Fernandez. During the validation findings are as follows;

- The area is within the jurisdiction of El Nido Taytay Managed Resource Protected Area per presidential Proclamation no. 32 dated October 8, 1998
- The area is occupied by the heirs of Gloria Fernandez (deceased) namely: Ernesto Fernandez Sr., Rico Fernandez, Henri Fernandez and Jun Fernandez (deceased)
- The area of Mr. Ernesto Fernandez Sr is about 30 hectares consisting livestock and poultry (38 cows, 8 carabaos, 30 Hogs; unnumbered poultry) grass plantation was also documented, other perennial crops were also observed
- The area occupied by Mr. Rico Fernandez, approximately 30 hectares with 25 heads of cattle and fruit trees
- The area of Mr. Henri Fernandez is 30 hectares more or less with 10 heads of cattle coconut trees and other perennial crops
- The area was issued pasture lease agreement sometimes in 1941 and last renewed on 1974. After 25 years, processing of renewal was not pursued due to the unsecured requirements.

With the above findings and information gathered the undersigned recommends for the conduct of performance evaluation on the issued agreement and shall secure legal instrument applicable in protected areas

Othermore Resolution No. 22-72; a resolution endorsing the Environmentally Critical Areas Network (ECAN) zoning map of the El Nido, Palawan. The same was also presented to the Protected Area Managed Board (PAMB) and duly adopted on November 10, 2022, ENBANC Meeting.




