Please be informed that for this month, the eNGP family contractors conducted regular monitoring and patrolling within the eNGP Regular Target and Co-based bamboo Plantations established in CY 2021 under the 3rd year maintenance and protection activities.

In addition hereto, the hiring of FEOs and DMO has been accomplished for the period from January to June CY 2023 to monitor the established plantations, graduated NGP sites, and preparation of Data Base Management of the established plantations from CY 2011 to CY 2021.

FOR THE MONTH OF APRIL 2023

Please be informed that this month, this office regularly monitors the 3rd Year Maintenance and Protection (M&P) activities of the Regular eNGP and Co-Based Bamboo plantation within the administrative jurisdiction of CENRO, Coron, Palawan.

Patrolling and monitoring are the main activity of the eNGP family contractors within the established plantations. In addition hereto, they were advised also to produce seedlings purposely for re-planting activity onset of the rainy season to attain the standard requirement on survival rate.

Likewise, the hiring of Forestry Extension Officers (FEO) and Data Management Officer (DMO) has been accomplished for the period from January to June CY 2023 to monitor the established plantations including the graduated NGP Sites, and prepare the database of NGP from CY 2011 to CY 2021 plantations.

Further, supervision of the established Forest Nursery has been conducted including continuous monitoring and watering of the produced seedlings located at So. Banga, Brgy, Poblacion 6, Coron, Palawan.

In addition hereto, coordination with the Barangay Captain of Barangay Bintuan, Coron, Palawan has been implemented including the initial assessment of the area for the SMP Target for CY 2023.
