SUBJECT : **INSPECTION/VERIFICATION REPORT ON THE REQUEST OF MRS. MARVILYN F. MOLLO FOR PERMIT TO CUT/UTILIZE ONE (1) TYPHOON DAMAGED ACASIA TREE LOCATED AT BRGY. LIBTANGIN, GASAN, MARINDUQUE.**

In compliance with your instruction to verify the trees applied for tree cutting, please be informed that the undersigned have conducted the inspection and the following facts were gathered, to wit;

1. That the said trees were actually inspected by the undersigned were identified as Acasia tree blown down and deposited along the Barangay road side;
2. That during the inspection, the undersigned found out that the requested tree was felled down along the Barangay road that was affected by Typhoon Paeng and might cause vehicular accident and people passers-by in the area;
3. That the species being requested for tree cutting permit is located within the private land covered with Katibayan ng Orihinal na Titulo Blg. CARP2016000083, Lot No. 1346 Cad 448-D, located at Brgy. Libtangan, Gasan, Marinduque, owned by Uldarico M. Palma, Jr.;
4. That Sps. Uldarico M. Palma Jr. and Emalyn S. Palma legally authorized Mrs. Marvilyn Mollo to process the application for tree cutting permit and other requirements/documents pertaining to the cutting of trees;
5. That accordingly, the trees to be cut will be used for personal and commercial purposes;
6. That per inventory conducted, it has estimated volume of 2.38 cubic meter or 1,009.12 bd ft;
7. That corresponding certification interposing no objection was issued by the concerned local government unit (Barangay);

Please find the attached geo-tagged photos and tally sheet of the said inspected trees.

Remarks/Recommendation.

In view of the above findings gathered, it is hereby recommended the issuance of the necessary clearance/permit, subject to the existing DENR policy, rules and regulations.

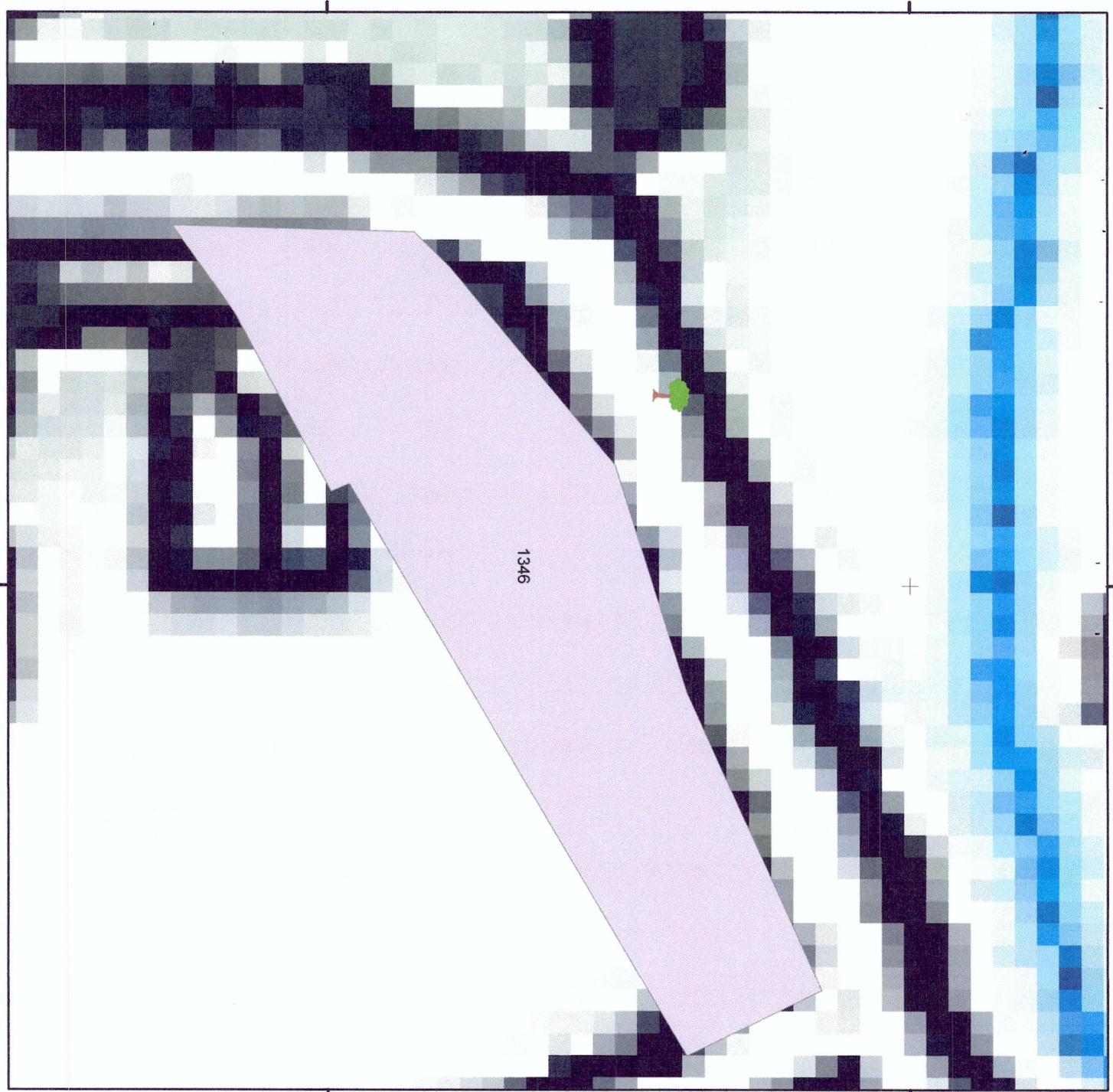

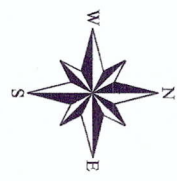

**SUBJECT : REVISED DENR MANUAL OF AUTHORITIES ON
TECHNICAL MATTERS**

Pursuant to Executive Order No. 366 entitled "Directing a Strategic Review of the Operations and Organizations of the Executive Branch and Providing Options and Incentives for Government Employees Who may be Affected by the Rationalization of the Functions of the Agencies of the Executive Branch" and to effectively implement the new DENR Organizational Structure in its regional and field offices and further simplify and facilitate transactions regarding technical matters, DENR Administrative Order (DAO) No. 2016-07, otherwise known as the DENR Manual of Authorities on Technical Matters, is hereby amended for the guidance of all concerned.

All Offices of the DENR, including its bureaus, attached agencies, foreign-assisted and special projects and programs and field offices shall adhere to the provisions of this Revised Manual which forms part of this Order.

This Order supersedes DAO No. 2016-07 and all other orders and circulars inconsistent herewith involving delegated authority.

This Order shall take effect fifteen (15) days after its publication in a newspaper of general circulation and upon acknowledgment of receipt of a copy thereof by the Office of the National Administrative Register, UP Law Center.
