FACTS:

In compliance to the approved Work and Financial Plan C.Y. 2023, under Menu 6 “*Consistent apprehension and mandatory administrative adjudication and confiscation of apprehended forest products including conveyances and other implements*” and under 6.4 “*Inventory or scaling of apprehended and/or seized undocumented forest product, conveyances, tools, equipment, and implement used*”

ACTIONS:

To conduct inventory, verification and scaling on the apprehended forest products including conveyances and other implements within the jurisdiction of Tablas and Sibuyan Island;


1. That on February 03, 2023, the undersigned travelled to Romblon, Romblon to conduct the said activity;

2. That on the same day, the undersigned also coordinated to the personnel of Romblon Municipal Police Station headed by the Officer In-Charge **PMAJ GEMIE MALLÉN** and inform about the activities being undertaken;
3. Conducted inventory and scaling on the apprehended forest products; and
4. Took geotagged during the actual inventory.

FIELD FINDINGS/ OBSERVATIONS:

1. That the apprehension of the forest products was transpired on May 11, 2022 located at Sitio Binagong, Brgy. Bagacay, Romblon, Romblon;
2. That the apprehended forest products were undertaken by the Composite team of Romblon Municipal Police Station, Philippine Coast Guard (PCG) Romblon Station and Monitoring and Enforcement Section (MES) of PENRO Romblon; and
3. The apprehended forest products were under the custody of Officer In-Charge **PCPT RICHARD M OBSID** of the Romblon Municipal Police Station;
4. That during inventory and scaling, said forest products have an aggregate volume of 1.97 cubic meter or equivalent to 835 bd.ft. ; and
5. The abandoned forest products had an issued Notice of Issuance of Order and Certification dated February 01, 2023 from the Regional Office.

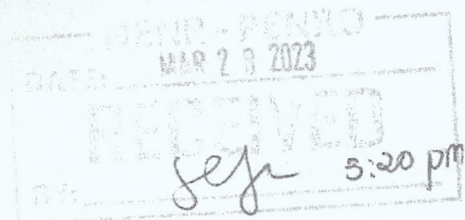

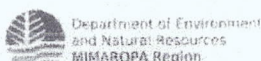

DECISION


Records show that on May 11, 2022 at around 6:07 in the evening, at Sitio Binagong, Barangay Bagacay, Romblon, Romblon, the composite team of Romblon Municipal Police Station, Philippine Coast Guard (PCG) Romblon Station and Monitoring and Enforcement Section (MES) of PENRO Romblon apprehended six (6) pieces of lumber of Apitong species having an aggregate volume of 1.97 cubic meters (835 board feet), with an estimated fair market value of PHP 37,652.00. The subject forest products have no claimant/s during the time of apprehension and were hauled and deposited at the compound of PENRO Romblon for safekeeping. A Seizure Order and Seizure Receipt, both dated October 17, 2022 were issued by OIC, PENRO Arnoldo A. Blaza, Jr., Seizure Officer.

Pursuant to Section 8 of DAO 97-32, the PENRO concerned posted Notices of Hearing on May 16, 2022, May 23, 2022 and May 30, 2022, in conspicuous public places within the locality, informing the claimant/s to appear and show cause why the apprehended items should not be confiscated in favor of the government. However, despite said notices no one came to claim ownership of the same, hence considered "ABANDONED."

WHEREFORE, PREMISES CONSIDERED, the six (6) pieces of lumber of Apitong species having an aggregate volume of 1.97 cubic meters (835 board feet), with an estimated fair market value of PHP 37,652.00, apprehended at Sitio Binagong, Barangay Bagacay, Romblon, Romblon, are hereby **CONFISCATED** in favor of the government to be disposed of in accordance with existing DENR laws, rules and regulations governing the matter.

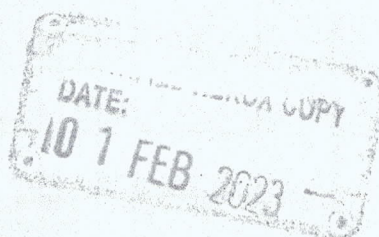



CERTIFICATION

This is to CERTIFY that per records on file in this Office, a DECISION dated FEB 01 2023 was issued in the above-captioned case confiscating the six (6) pieces of lumber of Apitong species having an aggregate volume of 1.97 cubic meters (835 board feet), apprehended at Sitio Binagong, Barangay Bagacay, Romblon, Romblon.

In compliance with Section 8(3), DAO 97-32, three (3) Notices of Hearing dated May 16, 2022, May 23, 2022 and May 30, 2022, over the apprehended items were posted for three (3) consecutive weeks in three (3) conspicuous public places in the locality.

Since no owner, claimant, or other interested party appeared at the proceedings, such failure to appear is deemed as a waiver of the right to appear and of any/all rights to the items apprehended in favor of the Government, as provided under Section 8(3), DAO 97-32.

Moreover, under Section 7, DAO 97-32, a Decision/Order shall become final and executory upon the lapse of fifteen (15) regular business days unless a Motion for Reconsideration is filed. Hence, the said Decision is declared **FINAL AND EXECUTORY**. The confiscated items are deemed permanent property of the Government and shall be entered into the books of the concerned CENRO/PENRO to be disposed of in accordance with the applicable laws, rules and regulations.

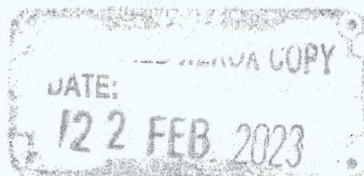


