

This refers to the 1st Indorsement dated November 3, 2021 of Legal Affairs Service Director Norlito A. Eneran, *LL.M.*, *CESO III* forwarding the complete records of the above-cited case with the Decision dated January 30, 2020 dismissing the Appeal dated September 24, 2007 of the Heirs of Primitivo Bahande and affirming the Order dated July 31, 2006 of the then Regional Executive Director Vicente S. Paragas, *CESO III*, the dispositive portion of which is hereunder quoted:

"WHEREFORE, premises considered, the Homestead Application No. 045306-221 of Primitivo Bahande is hereby ORDERED CANCELLED and whatever amount paid thereon is hereby forfeited in favor of the government. Nelson Setias is hereby directed to file the appropriate Public Land Application over the subject lot (lot 2144, Pls 96) within ninety (90) days upon finality of this Order."

Per Certification dated October 6, 2021 of then Chief, Records Management Division Jane G. Bautista, *CPA*, *DPA*, no Motion for Reconsideration or Notice of Appeal was filed by the aggrieved party from the Decision dated January 30, 2020 issued by the then Undersecretary for Legal and Policy, Planning and International Affairs, Atty. Jonas R. Leones, *CESO I*, by authority of the Secretary.

As such, you are hereby directed to implement the same subject to the provisions of DAO No. 2016-31 and submit compliance report within three (3) days from receipt hereof. In case there has already been compliance with said Decision, furnish this Office with the proper documents for record purposes.
