Respectfully forwarded is the memorandum of CENRO Quezon, Palawan dated March 7, 2023 relative to the above subject.


Per memorandum, the apprehension was conducted last January 8, 2023 at around 10:30 P.M. at Malanot Bay, Barangay Alfonso XIII, Quezon, Palawan which led to the apprehension of one (1) unit motorized banca loaded with 55 pieces of lumbers of undocumented Taluto species with a total volume of 721.50 board feet. Two (2) individuals were also arrested namely Ariel M. Lapana (owner of the boat/boat operator) and Aysan T. Bacar (helper) for violation of Section 77, of PD 705 as amended.

The apprehended undocumented lumbers have an estimated fair market value of Php25,252.50 while the one (1) unit motorized banca with 12HP Golden Horse Engine has an estimated value of Php47,000.00. The apprehended Motorized Banca and undocumented lumbers were brought to the compound of DENR CENRO Quezon, Palawan for safe keeping purposes. The said apprehended items are under the custody of PNP-Maritime Quezon, Palawan.

Notices of hearing dated January 17, 2023, January 24, 2023, January 31, 2023, February 13, 2023 and February 20, 2023 were sent to all concerned parties in relation to DAO 1997-32. The scheduled hearing dated January 24, 2023 was attended by all concerned parties except Mr. Hermihildo Unsan who failed to appear on the said hearing. Since Mr. Unsan failed to appear despite the several notices, his absence to appear shall be deemed a waiver of his rights to be heard and that is probably guilty for violation of Section 77 of PD 705 as amended.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended motorized banca and undocumented lumbers.

SUBJECT : **SUMMARY OF MINUTES OF ADMINISTRATIVE HEARING ON THE APPREHENSION AND SEIZURE OF ONE (1) UNIT MOTORIZED BANCA LOADED WITH 55 PIECES UNDOCUMENTED TALUTO LUMBERS HAVING A TOTAL VOLUME OF 721.50 BOARD FEET AT MALANUT BAY, BRGY ALFONSO XIII, QUEZON, PALAWAN**



Submitted herewith the summary of minutes of the Administrative Confiscation Proceedings together with pertinent documents anent the above-cited subject treated under DAO 97-32. The hearing was conducted on January 24, 2023 at DENR-CENRO Quezon, Palawan.

Please be informed that prior to the conduct of hearing, a notice of hearing was given to the respondents informing them of their privilege to exercise their right to hire a legal counsel of their own choice pursuant to the provisions of the New Constitution. However, despite the considerable period of time since the notice of hearing was served, this office did not receive any notice or motion from the respondents to re-schedule the hearing due to non-hiring of lawyer.

Further informed that during the scheduled date of hearing, the respondents asserted to proceed the hearing even without the assistance of their own legal counsel.

I. FACTS OF THE CASE:

WHAT: Apprehension and seizure of 55 pieces of undocumented Taluto lumbers having a total volume of 721.50 board feet.

WHEN: On or about 10:30 PM of January 08, 2023

WHERE: Malanut Bay, Brgy. Alfonso XIII, Quezon, Palawan

WHO: Mr. Ariel M. Rapana and Mr. Aysan T. Bacar, both residents of Brgy. Suwangan, Quezon, Palawan.

HOW: On the evening of January 8, 2023, the PNP-MG led by James B. Bue together with personnel of DENR CENRO Quezon and Bantay Quezon conducted an anti-illegal logging operation that led to successful apprehension of Mr. Ariel M. Rapana and Mr. Aysan T. Bacar who are

caught in the actual possession and transport using unmarked motorized banca the undocumented Taluto lumbers having a total volume of 721.50 board feet in Malanut Bay, Brgy Alfonso XIII, Quezon, Palawan.

Due to lack of permit presented by the respondents, the apprehending team declared apprehension. The apprehended items were deposited at PNP-MG compound, Alfonso XIII, Quezon, Palawan

II. PRESENTATION OF PARTIES CONCERNED (*Apprehending Officers and Respondents*):

1. During the hearing, the apprehending officers were not present but they were able to submit their “Malayang Sinumpaang Salaysay”. Based on the malayang sinumpaang salaysay of PMSg James B. Bue, on or about 1:30 PM of January 8, 2023, the PNP-2nd SOU-MG has received an information from a reliable informant about the transport of undocumented lumbers via motor-banca. In response, on or about 7:00 PM on that day, they immediately dispatched a team composed of personnel of PNP-MG, DENR – CENRO Quezon and Bantay Quezon to respond the said information using their patrol boat.

On or about 10:30 of the evening, in the vicinity of Malanut Bay, a suspicious motor banca due to slow pace and its load seems heavy was observed. The team immediately approached the subject motor banca and instructed the operator to stop and subsequently identified their team as members of PNP-MG, DENR and Banatay Quezon. The team immediately noticed the several lumbers on the motor-banca. In the course of verification/investigation, the respondents failed to present any legal documents for the possession and transport of lumbers.

Due to lack of permit presented, the team declared arrest and apprehension and they informed the respondents (Mr. Ariel M. Rapana and Mr. Aysan T. Bacar) of their violation of Section 77 of PD 705 and subsequently informed their rights under the Miranda Doctrine.

The arrested persons were brought to the PNP-2nd SOU-MG station for further investigation and documentation while the apprehended motor-banca loaded with undocumented lumbers were deposited at PNP-2nd SOU-MG.

2. In that hearing, Forest Technician I Jesse O. Cascara of CENRO Quezon concurs to the statement of PMSg James B. Bue and manifested that the apprehended Taluto lumbers is 55 pieces having a total volume of 721.50 board feet.
3. In the same hearing, Mr. Aysan Bacar explained that on the evening of January 8, 2023 he and Mr. Ariel M. Rapana is set to fish in the sea when a certain Hermihildo Unsan approached them and requested them to deliver lumbers in the river of BLISS. Expecting that the lumbers have permit as being told by Mr. Unsan, in the amount of Php 7.00 per board feet they agreed to deliver the lumbers using the motor banca of Ariel Rapana.
4. Likewise, in the same hearing Mr. Ariel Rapana concurs to the statement of Mr. Aysan Bacar and narrated that since the time of their arrest and apprehension, Mr. Unsan has not appeared to them.

5. Lastly, since the name of Hermihildo Unsan was mentioned by the respondents as the owner of the lumbers, Mr. Unsan was invited to be given a chance explain himself. Despite the several notices (dated January, 24, 2023, January 31, 2023, February 13, 2023 and February 20, 2023) however, Mr. Unsan did not show up.

III. APPLICABLE LAWS AND POLICIES:

1. *Section 77 of PD 705 as amended or Revised Forestry Code of the Philippines “Cutting, Gathering and/or collecting Timber or other Forest Products Without License- any person who shall cut, gather, collect, remove timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code; Provided, that in the case of partnerships, associations, or corporations, the officers who ordered the cutting, gathering, collection or possession shall be liable, and if such officers are aliens, they shall, in addition to the penalty, be deported without further proceedings on the part of the Commission on Immigration and Deportation.*
2. Department Administrative Order No. 97-32 dated 1997 Rules for the Administrative Adjudication of Illegal Forest Products and the Machinery, Equipment, Tools and Conveyances used in the commission of crimes.

IV. FINDINGS/EVALUATION

1. The possession of 55 pieces of Taluto lumbers having a total volume of 721.50 board feet is not covered by appropriate DENR documents/permit, hence a patent violation of Section 77 of PD 705 as further amended;
2. In view of the above findings and facts presented, it was found that there were sufficient and convincing evidences to support the finding of probable cause to charge **Mr. Ariel M. Rapana and Mr. Aysan T. Bacar** for violation of Section 77 of PD 705 as further amended by E.O. 277 and R.A. 7161.
3. Since **Mr. Hermihildo Unsan** failed to appear despite the several notices, his absence to appear shall be deemed a waiver of his right to be heard and that he is probably guilty for violation of Section 77 of PD 705 as further amended.

V. RECOMMENDATION

1. In view of the above findings and evaluation, it is recommended that the one (1) unit unmarked motorized banca together with 55 pieces of Taluto` lumbers having a total volume of 721.50 board feet be confiscated in favor of the government in addition to the filling of case against the above –mentioned offenders for violation of Section 77 of PD 705 as further amended by E.O. 277.

Ayon sa Sinumpaang Salaysay ni **PLT PMSg James Bue**, binanggit niya na noong ika – 8 buwam ng Enero 2023 ganap na 1:30 ng hapon nakatanggap ang kanilang PNCOIC na si **PEMS Richarge P Rodriguez** ng impormasyon mula sa kanilang pinakakatiwalaang impormante patungkol sa patuloy na ilegal at talamak na pagpuputol ng mga kahoy-gubat at pag babyahen ng mga ito sa pamamagitan ng isang Bangka na di motor, sa bulubunduking kagubatan na sakop ng Quezon, Palawan , na walang kaukulang dokumento o papeles mula sa kinauukulan o anumang ahensya. Dahil dito, ay agad bumuo ng grupo ang kanilang PNCOIC kasama ang tauhan ng DENR at Bantay Quezon upang matugunan ang nasabing sumborg. Ganap na 7:00 ng gabi Enero 8, 2023 sila umalis lulan ng kanilang sasakyen pandagat humigit kumulang 8:30 ng gabi ay narating nila ang parte ng baybayeng dagat na sakop ng Malanut Bay, Bgy. Alfonso XIII, Quezon, Palawan at doon ay nagpalutang lutang mua sila sakay ng sasakyang pangdagat at nag mamasid sa paligid na maaring daanan nito. Habang sila ay nag mamasid dakong 10:15 ng gabi ay may napansin silang Bangka na tila hirap na hirap sa pagtakbo at agad naman silang nagdesisyon na puntahan ang nasabing Bangka. Habang sila ay papalapit ay natanaw nila ang kargang kahoy. Agad nila itong pinahinto, at agad din naman silang huminto. Agad silang nagpakilala na kawani ng PNP-Maritime Quezon kasama ang taohan ng DENR CENRO, Quezon. Ang mga nakasakay ay walang naipakitang permit sa pag byahe ng karga nilang kahoy. Ganap na ika-10:30 ng gabi Enero 8, 2023, Agad silang nag deklara ng pag-aaresto sa paglabag sa batas ng Section 77 of PD 705 at kasunod nito ay ang pag papaliwanag ni PSSg Willard M Coyoca ang Kanilang karapatan alinsunod sa saligang batas o (MIRANDA DOCTRINE) sa lenggwahen o salita na kanilang naiintindihan sa wikang tagalog, at agad silang kumuha ng mga litrato na maaring gamitin mga ebedinsiya sa pagsampa ng kaukulang reklamo/kaso laban sa inaresto. Nag disisyon na silang dalhin ang inaresto sa kanilang himpilan na naka base sa Sitio Bliss, Bgy. Alfonso XIII, Quezon, Palawan.
- H.O.** : Sa ating pagpapatuloy, binabanggit po dito sa report ng PNP Maritime-Quezon na kayo po Ginonng Aysan Bacar na resident ng Bgy. Suwangan, Quezon, Palawan ay nasabat ng PNP-Maritime Quezon sa aktong pagbibyahe ng kahoy na walang kaukulang dokumento/permit. Maari po ba kayong tumayo itaas ang iyong kanang kamao magpakilala at mangangakong mag-sasabi ng pawang katotohanan lamang?
- A.Bacar** : Ako po si Aysan Bacar, 28 years old, may asawa at may 5 anak, nakatira sa Bgy. Suwangan, Quezon, Palawan. nangangakong magsasabi ng pawang katotohanan lamang.
- H.O.** : Ano po ang kaugnayan niyo sa pangayaring iyon?
- A.Bacar** : Noong panahon na po na iyon sir, maglalaot po kami tapos ay pumunta sa amin ang sabi na mag pahakot daw ng kahoy, sabi namin illegal man iyan kuya, sabi wala iyan kumpleto ito may papel ito. Sabi ko siguradohin mo kuya kasi mahirap ito baka mahuli kami. Sabi niya po ok na iyan lahat pag bagsak niyo kukunin nanamin.

- H.O.** : Maraming salamat po, ngayon ang susunod ko namang tatanongin si Mr. Rapana, Maari kabang tumayo itaas ang iyong kanang kamay, sabihin ang iyong pagkakilangan at mangangakong magsasabi ng pawang katotohanan lamang?
- A.Rapana** : Ako po si Ariel Rapana, 28 years old, may asawa at anak, nakatira sa Bgy. Suwangan, Quezon, Palawan nangangakong magsasabi ng pawang katotohanan lamang.
- H.O.** : Ikaw ba ang may-ari ng banca?
- A.Rapana** : Yes po sir, bagong gawa lang po talaga yan sir.
