
Per results, the Team ascertained that there was on-going construction of the Causeway Project despite the issuance of the Notice of Violation and Letter to Suspend by the DENR-EMB MIMAROPA Regional Office on February 10, 2023.

Moreover, the Team highly recommends that the DENR Regional Executive Director or/ DENR EMB MIMAROPA Regional Director shall issue "Status Quo Order" to DPWH-Romblon District Engineering Office for the continuous violation of PD 1586 while implementing Causeway Project in Calatrava, Romblon.

In compliance to PENRO Special Order No. 23-42 dated April 12, 2023 directing the undersigned Joint Investigation Team to conduct validation on the alleged illegal reclamation in Calatrava, Romblon, hereunder is the report with comments and recommendations, to wit:

#### I. INTRODUCTION/BACKGROUND

The investigation and/or on-site validation stemmed from the complaint of Ms. Mary Ann Montesa regarding the alleged illegal reclamation in Calatrava, Romblon {E-2023-105358} per Memorandum dated March 14, 2023 of the Undersecretary, Field Operations for Luzon & Visayas and Environment (DENR CO-OSEC 2023-001474) and Memorandum Order dated March 30, 2023 signed by the Assistant Regional Director Maximo C. Landrito. The said memorandum referred to and received by DENR PENRO Romblon on April 3, 2023, 3:15 in the afternoon.

The Joint Investigation Team was instructed by this Office to coordinate with the DPWH-District Engineering Office, Municipal LGU of Calatrava, Romblon and Sunwest Construction and Development Corp. to determine the present status of the project and to conduct on-site validation or ocular inspection.

The Team personally met District Engineer Elena M. Castilan of DPWH-Romblon District Engineering Office in Odiongan, Romblon, Municipal Mayor Marieta F. Babera of Calatrava, Romblon and the project in-charge/Foreman Barton R. Laurenciano of Sunwest Construction and Development Corporation.

During the coordination with the DPWH-DEO Castilan and Municipal Mayor Babera, the Team inquired about the update on the above-mentioned project as well as compliance of the implementing agency in particular the DPWH-DEO on the duly issued Notice of Violation and Letter to Suspend by the DENR-EMB MIMAROPA Regional Office on

February 10, 2023. Finally, during the conduct of on-site validation, the Team requested the project in-charge/Foreman Barton R. Laurenciano of Sunwest Construction and Development Corporation in Calatrava, Romblon to provide the Team with updates in terms of their accomplishment.

#### II. FACTUAL FINDINGS

- A.) ON THE ISSUES RELATIVE TO THE ALLEGED RECLAMATION AND THE DPWH-DISTRICT ENGINEERING OFFICE (DEO) COMPLIANCE ON THE NOTICE OF VIOLATION AND LETTER TO SUSPEND ISSUED BY DENR-EMB MIMAROPA REGIONAL OFFICE DATED FEBRUARY 10, 2023
- 1. The Team personally met District Engineer Castilan of DPWH-District Engineering Office (DEO) around 8:40 A.M. of April 14, 2023. Prior to this meeting, the OIC, PENR Officer Arnoldo A. Blaza, Jr. sent a Letter Request to the DPWH-DEO on April 13, 2023. Attached is the Letter Request.
- 2. On the said meeting, District Engineer Castilan commented on the said Letter Request that her Office at present cannot provide any updates as to the status of the project and compliance on the Notice of Violation and Letter to Suspend by the DENR-EMB MIMAROPA Regional Office dated February 10, 2023.
- 3. District Engineer Castilan categorically mentioned that these concerns were already at the disposition of the proper Court and the Philippine Reclamation Authority (PRA). Consequently, the District Engineer waived their right to send any authorized representative to join the Team in the conduct of on-site validation or/ocular inspection.
- 4. After this, the Team proceeded to Calatrava, Romblon and coordinated with Mayor Babera of Calatrava, Romblon around 9:40 A.M. to gather any updates on the causeway project.
- 5. Mayor Babera disclosed to the Team that her Office together with the DPWH and Sunwest Construction and Development Corp. received formal complaint from the Regional Trial Court relative to the on-going implementation of the Causeway Project in Calatrava, Romblon.
- 6. Mayor Babera also said that the Philippine Reclamation Authority (PRA) in Manila has confirmation to send technical personnel for the conduct of inspection on the said causeway project in this municipality.

#### III. ACTUAL/OCULAR INSPECTIONS

After short meeting with Mayor Babera, the Team with the Municipal Engineer Ulysses P. Ancheta of Calatrava, Romblon proceeded to the Causeway Project located at Barangay Poblacion.

Upon arrival at the project site, we met the project in-charge/Foreman Barton R. Laurenciano of Sunwest Construction and Development Corporation who personally accommodated the Team during the conduct of on-site validation.

Per information gathered from the Project In-Charge/ Foreman Laurenciano, he said that the causeway project is about 40 to 50% in terms of accomplishment. He added that the following activities already accomplished were sheet piling, pile cap rubble concrete, structural concrete and embankment.

Furthermore, the investigation conducted by the Team reveals that there was an ongoing construction of the Causeway Project despite the issuance of Notice of Violation and Letter to Suspend by the DENR-EMB MIMAROPA Regional Office last February 10, 2023.

Thus, out of the 4,600 square meters (115m x 40m) total area of the Causeway Project, about 40% of the embankment has already completed using filling materials such as armor rocks and earth soil.

#### IV. FINDINGS/ANALYSIS AND DISCUSSIONS

Based on the results of meeting and on-site validation or/ocular inspection conducted by the Team, it was found that the DPWH-District Engineering Office as represented by its District Engineer Elena M. Castilan has "NO COMPLIANCE" to the issued Notice of Violation (NOV) and Letter to Suspend by the DENR-EMB MIMAROPA Regional Office since February 10, 2023 to date.

The continuous implementation of the Causeway Project in Calatrava, Romblon by DPWH-DEO and its contractor despite the issuance of NOV and Letter to Suspend by the DENR EMB Regional Office, has clearly demonstrated its blatant disregard of the law and the lawful order.

Currently, the continuous implementation of Causeway Project with around 40% completed embankment without any corresponding clearances and permits issued by the appropriate agency like Philippine Reclamation Authority (PRA), DENR-EMB such as ECC violates Presidential Decree 1586 or the "Environmental Impact Statement Law" and other

applicable department orders like DENR Administrative Order No. 2018-14 or the "Guidelines on the Issuance of Area Clearance for Reclamation Projects and Proclamation/Special Patents over Reclaimed Lands."

#### V. CONCLUSIONS/ COMMENTS AND RECOMMENDATIONS

IN VIEW OF THE FOREGOING, the Joint Investigation Team in consideration with the results of the on-site validation or/ ocular inspection highly recommends that the DENR Regional Executive Director or/ DENR EMB MIMAROPA Regional Director shall issue "Status Quo Order" to DPWH-Romblon District Engineering Office for the continuous violation of PD 1586 while implementing Causeway Project in Calatrava, Romblon.



Likewise, the Team shall conduct on-site validation of the alleged reclamation in Calatrava, Romblon.


Further, the team shall be supervised by the undersigned and the Chief of Technical Services Division, Malvin R. Rocero, during the conduct of the said activity.
