In relation to the complementation of NIPAS through the designation and establishment of other conservation areas provided in Section 2 of the Republic Act No. 7586 (*National Integrated Protected Areas System Act of 1992*), as amended by RA No. 11038 (*Expanded National Integrated Protected Areas System Act of 2018*), the BMB is initiating the creation of a Technical Working Group through a DENR Special Order for the development of a policy on the identification and recognition of Other Effective Area-Based Conservation Measures (OECMs). The proposed policy intends to recognize various initiatives and modalities of resource management by government agencies, private sectors and indigenous people which contributes to the conservation of biodiversity. The development of such policy also supports the country's commitment to Target 3 of the Kunming-Montreal Global Biodiversity Framework (KM-GBF) which aim for the conservation and management of areas of particular importance for biodiversity and ecosystems functions and services.

Relative to this, may we request for your agency's permanent and alternate representatives to be included in the aforementioned DENR Special Order.
